HISTORY OF THE FEDERATION OF

FLORIDA FAIRS

PREFACE

The Federation, at its 1989 meeting determined it was time for us to seek out our "roots" as an organization, and many elements are missing.

What you are about to review is information which we have been able to document from records, correspondence and meeting minutes as well as from the records of the Federation, which from time to time, we have been unable to locate.

We hope that our fairs, chartered under chapter 616, after reviewing this history, can give us additional input into the Federation, the History of Florida Fairs, of their Fairs, and Fairs which may have come and gone.

HISTORY

In December of 1950, at the urging of J.C. Huskisson, Assistant Manager of the Florida State Fair, Tampa and John Henry Logan, Manager of the Pinellas County Fair, then in Largo, a letter was circulated to all county fairs in Florida.

The letter was authored by Lloyd Rhoden, Secretary Treasurer and Manager, North Florida Fair, Tallahassee and Leon County Extension Agent.

The text invited fair managers to attend a meeting in the Terrazzo room of the Floridan Hotel in Tampa on February 1, 1951, stating "The purpose of this meeting is to discuss among ourselves the advantages and advisability of organizing a State Association of Fairs and Shows the latter alluding to Livestock Shows. Thus, we can document the "Founding Fathers" of our Federation were Lloyd Rhoden, J.C. Huskisson and John Henry Logan.

Nineteen representatives of ten fairs were present along with a representative from the State Extension Service and a "Fair Designer" from Raleigh, North Carolina.

Fairs represented that are still active in Florida were the Florida State Fair, Pinellas County Fair, North Florida Fair, Central Florida Exposition, Pasco County Fair, and the Charlotte County Fair, although this event has no relation to the new Charlotte County Fair which made its debut in January of 1990.

Representatives were also present from the Tobacco Festival and Fair, Quincy (Gadsden County) and the State Livestock and Crops Pavilion in Jackson County.

Lloyd Rhoden was appointed Temporary Chairman of the State Association of Fairs and Expositions and the next meeting was set for March 29 of the same year at Silver Springs.

By that time, the organization had a new name, "Florida Association of Fairs, Livestock Shows and Expositions" and representatives of ten events and associations were in attendance.

Represented were the Florida State Fair, State Extension Service, Florida Marketing Bureau, Sumter All Fla. Breeders Show, Southeastern Festival, Inc., Central Florida Exposition, Citrus County Fair, North Florida Fair, Charlotte County and the Strawberry Festival of Plant City.

At this meeting communications were reviewed from Pensacola, Quincy, Marianna and Eustis pledging support for the fledgling group, and a third organizational meeting was set for May 14, 1951 at which time by-laws would be adopted and officers and directors elected. This meeting was held in Orlando at the Angebilt Hotel.

The meeting was held as scheduled and the first slate of Officers and Directors was elected. They were:

John Henry Logan, Clearwater; 1st. District V.P.

Gordon Ellis, Hilliard; 2nd. District V.P.

George E. Dryden, Marianna; 3rd. District V.P. W.E. Goerne, Ft. Lauderdale; 4th. District V.P. W.E. Ellis, Ocala 5th. District V.P. Directors at large; Harry Jack, (city unknown), J.C. Huskisson, Tampa Lloyd Rhoden, Tallahassee.

Speakers at that meeting included Rollo E. Singleton, Secretary of the Missouri Association of Fairs and Agricultural Exhibitions to discuss organization and purpose; H.G. Clayton, Director, Cooperative Extension Service, University of Florida, who gave his concept of the purposes and objectives of such an organization and Karl Lehman, Manager of the Lake County Fair and Sportsman's Exhibition who reviewed problems involved in holding fairs, shows and expositions.

Activities adjourned with the scheduling of the "Annual Meeting", Monday December 10 at Winter Haven.

Thirty persons attended this meeting including what could well be defined as our first "Associate Members", Mutual Advertising Agency of Miami Beach, Mahaffey Bros. Tent and Awning Co., Memphis, Tennessee and Royal Crown Shows of Tarpon Springs.

Auditing, nominating, program and resolutions committees were formed.

Reports were heard from previously formed committees including Legislative, Carnival and By-Laws committees and an afternoon session consisted of a "1951 Version" of today's round table discussions.

Dues at this time for members and associates (merely grouped with members) was \$25.00 per year.

Honorary Memberships were recommended for representatives of the University system, and Agriculture related state agencies, the Attorney General and State Comptroller.

In the early years, the title "Short Course" was given to the annual meeting and in the 1952-53 period, the organization had a total of 23 fairs. Some of them no longer are in existence, i.e.;

Gadsden Co. Fair & Tobacco Festival, Quincy, S.E. Florida Youth Show, Belle Glade and Jefferson County Fair, Monticello. A predecessor of the Charlotte County Fair also belonged as did the Nassau County Fair which is now the Northeast Florida Fair in Callahan.

At some point prior to December of 1952 the name of our organization became "Florida Federation of Fairs, Livestock Shows and Expositions", with the word "Federation" replacing "Association" in our title.

At the 1952 meeting, records indicate a motion was made that the Federation pursue the legislature, seeking legislation defining a fair.

Documentation of the organization and its activities from this period until 1975 could not be found, however, we have been able to research a reasonably accurate listing of Presidents, but a listing nonetheless that may be open to revision.

During this period, the Federation also addressed involvement in a great many Livestock Shows, Breed Shows, and other exhibitions of an agricultural nature, but not necessarily fairs as we know them today.

In 1975, the Federation had 42 member fairs, 8 member Livestock Shows and 34 associate members and met each April in Gainesville.

The programs of the meeting in that time frame are not unlike the programs which comprise the annual meetings we have at this point in time.

Of the 42 member fairs, Levy County, Seminole County, Hillsborough County Jr. Agricultural Fairs and Sumter All Florida Breeders Show at Wildwood no longer exist.

Among the member Livestock Shows, only two remain, the Southeastern Livestock Show at Ocala and the Suwannee River Livestock Show at Fanning Springs.

In 1977, the Legislature created the Bureau of Public Fairs and Expositions with the stated intent to protect the legitimate county fairs of the State of Florida. The bureau became effective on July 1 addressing many of the functions it addresses today

such as safety inspection, and Chapter 616 as it was in form at that time.

Articles of Incorporation for the Florida Federation of Fairs and Livestock Shows were filed in 1977 under the guidance of President Darwin Fuchs.

The schedule of Florida Fairs and Livestock Shows belonging to the Federation in 1977-78 included 42 member fairs and livestock shows.

There were 33 Officers, Directors (Past Presidents), Honorary Life Directors and Honorary Directors and three Junior Directors. We had 40 Associate Members.

From that period to the present day there were occasional changes in by-laws but the overall structure of the Florida Federation of Fairs and Livestock Shows is pretty much intact today as it was then.

In 1989 we had 45 member fairs and 140 Associate Members. With the burgeoning growth of Associates we also implemented a Trade Show in conjunction with the annual Short Course in the mid 1980's.

There are many important events which have not found their way onto these pages of the history of our organization for lack of documentation and we sincerely hope member fairs will help us to fill in the voids in the future.

HISTORY OF FLORIDA FAIRS AND LIVESTOCK SHOWS

The city of Jacksonville enjoys the position as the first city in the Sunshine State to hold a fair. In an effort to stimulate the local economy, the event got under way in 1876. Over 1,000 visitors attended Florida's first "State" fair that year. We know this event today as the Greater Jacksonville Agricultural Fair.

Florida's oldest "County" fair, the Dade County Fair was born in the City of Miami in 1897. Henry Morrison Flagler's Florida East Coast Railroad paid all expenses during the fair's first years of existence. This was the forerunner of what we now call the Dade County Youth Fair and Exposition which was chartered in 1952. The Dade County Youth Fair and Exposition is the largest youth fair in the world.

The Florida State Fair in Tampa is an outgrowth of the South Florida Fair Association which was founded in 1904. In 1975 the State of Florida officially designated this annual event as the Florida State Fair. Over 858,000 people came through the gates in 1990 making this the second largest crowd of all time for the Fair. Attendees travel from around the U.S. and some 39 foreign countries.

"FAIR FACTS"

Here are some fascinating "Fair Facts" about Florida Fairs and Livestock Shows:

- * The Lake County Fairgrounds were leased to the U.S. Army Signal Corps in World War II.
- * The Florida Strawberry Festival & Hillsborough County Fair, though officially founded in 1930, was preceded by a "Strawberry Day" as early as 1914 in Plant City.
- * In World War II, the Volusia County Fairgrounds were turned into an industrial site to aid the war effort.
- * The North Florida Fair (formerly the Leon County Fair) began in 1941~ though early archive materials refer to Leon County Fairs as early as 1914.
- * The Florida Citrus Showcase & Festival and Polk County Fair received a visit from Ex-President Calvin Coolidge in 1930. The former President had ended his term in office the year prior and came to the festival while visiting friends in Mt. Dora.
- * The St. Lucie County Fair, founded in 1966, is an off shoot to a party held to honor World War I heroes. It is held at the same time of year.
- * The Hamilton County Fair started as a one day youth livestock show. It has since expanded to a full week and was incorporated in 1986. No longer a member.
- * The Southeastern Youth Fair has the oldest continuous Steer Show in Florida. Marion County.
- * The newest Fair in Florida is the Charlotte County Fair in Port Charlotte founded in January 1990.

- * The Suwannee County Fair had it's debut in 1913 the theme "Good Roads Days". There were few roads for farmers to move their crops and other goods. The fair was designed to aid farmers in displaying their crops.
- * The Brevard County Fair in it's first year of existence (1984), drew some 210,000 patrons through the fair gates.

- * Herschel Parrish was the first son of a Past President of the Federation to also serve as President.
- * First Lady Barbara Bush attended the Central Florida Fair in Orlando in 1992.
- * The Auditorium as the Citrus County Fair was converted into a jail because of overcrowding, complete with cells and barbed wire fencing. It was three years before it was reverted to its original use.
- * The South Florida Fair and the Miami-Dade County Fair were used for a post disaster operations base in 1992 and again in 2005. Several Fairs throughout the state were used in the same way, some were used to shelter horses and other animals. Several Fairs have also had disastrous effects of Hurricanes. Hurricane Opal destroyed five buildings at the Greater Okaloosa County Fair. In 1992 the Dade Country Fairgrounds were destroyed by Hurricane Andrew.
- * The Volusia County Fair was affected by a major tornado (an F3) in February 2007, losing several buildings.
- * Tom Umiker has been both an Associate Director (1999) and a Director (2009).
- * Rick Vymlatil has been manager of three Fairs. St. Lucie County Fair, Florida State Fair and South Florida Fair.
- * In the hospitality room at a Zone meeting in Sarasota, guests were required to perform a talent before they were allowed to leave the room.
 - * Fairs that have been re-activated since the last history was written are Brevard County, Hillsborough County, Levy County, and Sumter County. 2020: Only Hillsborough and Sumter remain.
- * In 2008 several Florida Federation of Fairs members were "snowed in" in Las Vegas, delaying their return to Florida.
- * The Lake County Fair has had four generations on staff. 1. Robert "Bob" Norris, father, 2. Charles Norris, son, 3. C.E. "Happy" Norris, grandson, 4. Leah Norris, great granddaughter.
- * The Pensacola Interstate Fair has had three generations on staff. 1. John E. Frenkel, Sr., (who was instrumental in getting the organization started in the sixties when it was known as "A Short Course" and was held at the University of Florida. At that time it was not large enough and they did not have officers but he was a key person in getting it organized.) father, 2. John E. Frenkel, Jr., son, 3.

Lisa Hinton Named 2015 Woman of the Year in Agriculture

TALLAHASSEE, Fla. – Commissioner of Agriculture Adam H. Putnam announced today that Lisa Hinton, a fifth generation Floridian, has been named the 2015 Woman of the Year in Agriculture. Lisa Hinton has dedicated herself to the advancement of Florida agriculture, agriculture education and youth programs. The award, now in its 31st year, recognizes women who have made outstanding contributions to Florida agriculture.



"Lisa Hinton is a true advocate for Florida agriculture and the programs she has implemented and the individuals she has inspired will have a lasting impact on Florida agriculture for generations to come," said Commissioner Adam H. Putnam. "I am proud to recognize her as the 2015 Woman of the Year in Agriculture, and I want to thank her for her years of dedicated service and contributions to agriculture and to all of Florida."

Hinton grew up on a seed harvesting and cow-calf operation where she spent most of her summers working and developed an appreciation and respect for agriculture. When the National FFA Organization voted to allow female membership in 1970, a young Hinton jumped at the opportunity to join. She became the first female to be elected a State FFA officer in Florida. Hinton then went to the University of Florida where she graduated with a B.S. in Agricultural Education.

Hinton had an immeasurable impact on Florida's youth programs while serving as the Director of Agribusiness for the Florida State Fair. Hinton placed a high priority on livestock education and her philosophy of "we're raising kids not animals" led to the development of the Champion Youth Program at the Florida State Fair. The program has gained national recognition as a valuable teaching tool for the future contributors to the agriculture industry. In addition to the Champion Youth Program, Hinton also played a role in developing and implementing other important programs, such as the Youth Steer Futurity that showcases Florida cattle, Ag-Venture and the Youth Livestock Show Ethics Certifications.

After her retirement from the Florida State Fair, Hinton then promoted agricultural education on a state and national level by serving as the Executive Director of the Florida Federation of Fairs. In this role, she is able to impact the direction of 52 agricultural fairs in the state of Florida as well as over 200 associate members.

As a result of her dedication to Florida agriculture, education and youth programs, Hinton was inducted into the Florida 4-H Hall of Fame in 2002 and the Florida Federation of Fairs Hall of Fame in 2009.

The Woman of the Year in Agriculture award is sponsored by the Florida Department of Agriculture and Consumer Services and the Florida State Fair Authority and presented to the recipient Monday, February 8th at the 2016 Florida State Fair in Tampa.

SALES TAX EXEMPTION HISTORY

For years, the Florida Department of Revenue ("DOR") had a standing order to collect sales tax from all ride operators and concession operators who contracted for space at Florida fairs. Most, if not all, local DOR agents collected the tax due on concession space. However, tax from ride revenue paid to fairs by rider operators was selectively enforced by DOR agents. Thus leaving the fair industry and ride operators to guess whether they should collect and remit sales tax. At one point, Conklin Shows was advised that it owed revenue earned at the Miami-Dade County Fair & Exposition retro-actively. Needless to say, the amount due was substantial. The law firm of Foster & Fuchs was retained by the Federation to work with Conklin Show's attorney to try and resolve the issue. John Foster and E. Darwin Fuchs, chairman of the legislative committee and the Federation's President Don Frenkel, went to Tallahassee and met with the Department of Revenue representatives in an attempt to gain clarification on how the sales and use tax laws would be enforced and interpreted. considerable and lengthy negotiations, it was determined that the only thing that could resolve the issue was to pass legislation exempting fair associations from the sales and use tax.

Thereafter, the Federation's Board of Directors approved the following: (a) Hire a lobbyist; (b) Raise the required funds Federation members, including ride operators and concessionaires, to pass the proposed legislation through the legislature.

In 1995, tax exempt legislation was approved by both the House and Senate. However, the exemption was vetoed by Governor Lawton Chiles. The following year, at the next legislative session, the mission was accomplished and the sales tax exemption was passed clarifying the law.

In all, Florida Fairs, ride operators and concessionaires contributed approximately \$150,000 to save the industry from the years of costly litigation over sales tax that would ultimately have resulted in the demise of a number of smaller fairs. While much of the money went for lobbyist, legal fees and campaign contributions, there was a substantial sum left that has provided a nice war chest to continue battling legislative and regulatory efforts to protect the Fair industry in Florida.

FEDERATION IN JEOPARDY

From the Federation's beginning it was a well known fact that certain members from a certain sector of the state were controlling the organization. A few members decided who would serve on the Board of Directors, and controlled all operational aspects of the Federation's business.

In 1978 when the nominating committee made it's recommendation for election of directors, and then asked for any recommendations from the floor a representative of the newly chartered Florida Council of Fairs requested, and was granted, permission to speak. He outlined the Council's members' grievances with the way the Federation was being run and controlled by a select few people and was not representative of all Florida Fairs. He then proposed the Council's slate of directors. A major debate ensued and lasted for at least three hours before a Board of Directors was finally elected.

At the conclusion of the business meeting, newly elected president E. Darwin Fuchs called for a joint meeting of the executive committees of both the Federation and Council members. After much discussion and debate, it was agreed that the Association needed to have total state representation. With that understood, Fuchs proposed the following:

- 1. The state be broken into zones, with a director being elected from each zone.
- 2. With the understanding the President would appoint a nominating committee from each zone. Each committee would then make their recommendation to serve on the board at the annual meeting.

With that understanding, it was agreed the Council's charter would be dissolved.

Directors continued to be elected by this method until 2005 and are now elected as follows, assuring state-wide representation.

At large members: 6

Small Fairs: 2 (attendance less that 50,000) Medium Fairs: 2 (attendance 50,000—400,000 Large Fairs: 2 (attendance greater than 400,000 The Past President and two Associate Directors

MEMORANDUM OF UNDERSTANDING Between

Florida Federation of Fairs And University of Florida - IF AS - Extension

The Florida Federation of Fairs believes that the University of Florida - IFAS - Extension program has a vital role in the development and implementation of agricultural and youth programs relating to Fairs in Florida. As a commitment to that belief, the Florida Federation of Fairs encourages Fairs to:

Include local Extension staff on the Fair Board in an ex-officio capacity (where applicable) so that they have a voice in the decision making process.

Support age appropriate 4-H youth development standards in the design and implementation of fair rules and regulations, including proper use of the 4-H Name and Emblem.

Support active educational involvement of Extension staff (in coordinating demonstrations, manning booths, and assistance in running events) by providing credentials for access to the Fair and other conveniences when possible (i.e. parking, etc.),

Develop relationships between IFAS Extension, 4-H, and Fair Committees (e.g. Livestock, General projects, etc.) to enhance the quality of the exhibit experience for youth, volunteers, and adults.

Provide year-round support of the Extension program by working cooperatively with Extension in providing facilities, etc. for Extension events at reduced or free rental rates.

The University of Florida - IFAS - Extension believes that Florida Fairs are effective venues for providing educational programs related to agriculture, family life and youth development. As a commitment to that belief Extension encourages its faculty, staff and stakeholders to:

Utilize the facilities of the state and local fairs to present educational programs and demonstrations.

Serve on fair boards and advisory committees in an ex-officio manner to foster cooperation and understanding between Fair Boards and Extension.

Work cooperatively with Fair Boards and their committees in the development of parameters for youth program exhibits and demonstrations within the policies and practices of the Florida 4-H program and USDA 4-H Name and Emblem requirements.

Promote attendance to fairs to recognize youth and adult achievements, and to increase public awareness of the importance of agriculture to the state's economy and the well-being of the citizens of the state.

Develop close working relationships with staff of state and local fairs as means to enhance communication and avoid conflicts of scheduling or program rules.

We, Florida Fairs and Extension, believe that the common objectives between our organizations (a. to educate the public on the importance of agriculture, and b. to recognize the quality work of 4-H members) are best served by our mutual agreement to work cooperatively, efficiently and effectively. This effort serves both organizations well and enhances the benefit to the public.

The History Continues.....

In the 20 years since the original history was written, much has changed and much has remained the same.

As stated previously, "there are many important events which have not found their way onto these pages of the history of our organization for lack of documentation." There are several missing years, years where no minutes can be found, or any other records from that earlier period.

In the 1980s auctions were held at the President's Party to fund scholarships for the Fair Management program at Georgia State. The auctions are still held but the scholarships have changed.

The trade show has steadily increased and is only limited by the space at the host hotel each year. The Trade Show started in 1987 with a budget of \$2,000 to cover pipe & drape and security. A table and chair was provided for \$50.00, electricity was extra. The lowest number of booths was 36 in 1997 and the highest was 92 in 2016, in 2022 there were 105 booths.

In the early 1950s the date of the Annual Meeting (known as Annual Short Course) was in December, in the mid 50s it moved to the middle of May, in the 70s it moved to the middle to end of April and in 2008 the Thursday after Mother's Day was established. The Site Selection Committee (Chairman, President, 1st Vice President, Executive Secretary) select the place for the Annual Meeting for the next five years (with approval of the Board of Directors). The President and Executive Director select the meals. Meeting locations have been selected through 2026.

Through the years over many individuals have served on the Board of Directors. As stated earlier, there are missing years, therefore many missing names. All of the current member Fairs were contacted to try and fill in the blanks.

The Federation has been fortunate in having had only six Executive Directors during the past several years, the 7th one was hired in 2019. Dan West, former manager of the Manatee County Fair in Palmetto.

Traditionally the duties of the officers (besides those stated in the bylaws) are: Secretary/Treasurer: Showcase Committee, 2nd Vice President: Summer Workshop Committee, 1st. Vice President, Annual Meeting Planning. President & Executive Director in charge of overall oversight of all committees and Federation activities and events.

Showcases are an important part of the annual meeting. Participants must be a member in good standing of the Florida Federation of Fairs and listed in the current Directory and have not showcased in the past three years. Only three acts may be submitted by an agent. **Rules have changed**.

Over the years we have had hundreds of showcases. Some who have gotten notoriety have been Casey Lunn Hasak of Naples who was the teen winner on *Star Search* in 1991. Terry Fator won *American's Got Talent* in 2007. Taylor Ware was a finalist on *America's Got Talent* and went on to appear on many national TV shows. There are others who have become successful.

<u>In 1990</u> President George Frazer met in Gainesville with the Department of Agriculture and was one of six members of a "Fair Council" to discuss Chapter 616. Others were Farm Bureau, FFA, 4H/ State Cooperative Extension Office.

It was voted to pay the expenses of the Executive Secretary and the Federation President to attend the IAFE meeting in Las Vegas or where held.

IAFE Zone 2 meeting held in Naples.

<u>In 1991</u> Officers wore ribbons to the annual meeting for the first time, a brochure was developed and distributed. Notebooks were prepared for all committee chairs with a job description, this was done "to maintain continuity from year to year and to document Federation activities for the Fair History Project."

Legislation Appreciation Day was held, this was an annual affair held in Tallahassee, the Federation maintained a booth there.

<u>In 1992</u> the Federation bought their first computer and laser printer.

John Foster was retained to address the Chapter 616 issue.

It was voted to have two delegates from each Fair instead of one.

IAFE Zones 1 & 2 met in West Palm Beach March 31-April 3.

<u>In 1993</u> a plaque was presented to John Foster and Darwin Fuchs for their work with Legislative issues.

The Federation was represented in the recently formed Florida Amusement Ride Inspection Advisory Committee meeting in Tampa. Federation First Vice President Ron Beckey was named Chairman of the organization's Legislative and Rules Committee.

<u>In 1994</u> banquet tickets and assigned seating were used for the first time. Smoking was banned from all areas of the Annual Meeting

Reithoffer Shows was the first advertiser in the newsletter, "sponsoring the newsletter" for \$50.00 per issue.

In 1995 Reithoffer again sponsored the newsletter.

LeRoy Van Dyke was the auctioneer at the President's party auction.

<u>In 1996</u> IAFE Spring Manager's Conference was held in Orlando May 3 -6, at the Sheraton Plaza at the Florida Mall, hosted by Central Florida Fair.

<u>In 1998</u> an Economic Impact Study was done with Buck Christian working with Dr. Mulkey at the University of Florida and several Fairs.

With a cost of \$25,000.00. The report was widely distributed to the benefit of Fairs.

Federation pins were purchased.

Hosted the Hospitality Suite at the Zone 2 meeting in Sarasota.

<u>In 1999</u> the President's Party and the Hall of Fame reception were combined.

The Director's Breakfast was changed to honor Past Presidents.

<u>In 2000</u> Bob Crawford, Commissioner of Agriculture gave the welcome speech.

<u>In 2001</u> to celebrate the 50th Anniversary of the Federation a cookbook was published. Executive Secretary Mozelle Williams with the help of many members, in particular Roberta Cassidy, Terri Gast, Mary Beaver and Debbie Dutton compiled and published the over 200 page book.

The Agriculture Committee was added and the Merit Awards program was initiated. The committee also initiated purchasing a mechanical cow, the Dairy Farmers, Inc. donated half of the purchase and the Florida State Fair the other half.

Purchased four Farmer For A Day Units for \$6,000.00.

The first organized meeting of the Associates was held.

Stickers were purchased to give to Associates to put on concessions "Member of Florida Federation of Fairs."

The law firm Foster & Fuchs was put on a retainer.

Voted to call the "convention" an Annual Meeting, not convention.

The first golf tournament was held led by Giles Ellis of the Florida State Fair. Later named The Giles Elis Memorial Golf Tournament.

<u>In 2002</u> A Mission Statement was developed under the leadership of Jim Overton.

The first Merit Awards were given, the program was funded with \$10,000.00, mainly from the Golf Tournament.

Commissioner of Agriculture **Charles Bronson** gave the Keynote Address.

First Honorary Members chosen to be members of the Board of Directors.

Handbook for new Directors developed.

Hall of Fame Committee to consist of past recipients with the presenter being the current recipient.

Purchased a trailer to move the cow and the South Florida Fair donated the signage for the trailer.

<u>In 2003</u> waive registration fee for Honorary Directors.

President to have first refusal to host the Summer Workshop.

In 2004 a committee was established to draft a Memorandum of

Understanding between the Federation and the Cooperative Extension Services.

Dr. Larry Arrington of the University of Florida was made an Honorary Director.

The Associate of the Year Award was established.

<u>In 2005</u> By-laws changed to elect directors by the size of the Fairs and not by zones.

To be eligible to be elected as a director must be a Fair Manager or equivalent, Assistant Manager or equivalent, for not less that 5 years or must be on the governing board of a member fair association for no less than 10 years. Also must be a voting delegate.

Fair dates were added to the annual directory.

The first showcase to be held in a hotel lounge.

Door prize money and partial Hospitality Suite expenses put in Annual Meeting budget, to eliminate hats and such.

Silent Auction added to President's party auction.

<u>In 2006</u> instead of using generic photographs on the Directory Cover a contest was developed to select photographs submitted by member Fairs. Photographs used are considered winners, without issuing a winning order.

The first scholarship (\$1,000 sponsored by Staats) was awarded to Danielle Padgett of Sarasota.

<u>In 2007</u> The President's Party was held at the famous Florida Theatre on Forsyth Street in Jacksonville courtesy of Theatre President J. Erik Hart.

Scholarships were awarded (one \$1,000 sponsored by Staats and one \$1,000 by the Federation) to: Leah Harvell of Lake Placid and Nocona Rooks of Inverness.

<u>In 2008</u> - The Thursday after Mother's Day was established as the start of the annual meeting.

A person can not be inducted into the Hall of Fame until one year from serving as President.

Sound needs to be bid by member firms.

Scholarships were awarded (one \$1,000 sponsored by Staats and one \$1,000 by the Federation) to: Kelsy Munyan of Ft. Pierce and Lindsay Rucks of Okeechobee.

Doris Graska was the first woman from Florida to win the Hass Wilkerson Heritage Award for volunteers. The award include \$1,000 to the recipient and \$500 to the Citrus County Fair.

<u>In 2009</u> By-Laws changed to have Executive Director accept membership applications as long as they are qualified for membership.

Re-instate travel expenses for President, beginning 2009-10.

Hired lobbyist to ensure that our interests and benefits are safeguarded.

Fairs who had received the Blue Ribbon for the previous 5 years would not be evaluated for another three years.

YPI (Young Professionals Initiative) Established by IAFE for age 40 and under.

By-laws changed to allow the Immediate Past President to serve out their term even if their Fair affiliation has been terminated.

Scholarships were awarded (one \$1,000 sponsored by North American Midway Entertainment and one \$1,000 by the Federation) to: Eileen Cowdery, Winter Springs, Matthew Simmons, Callahan.

The first \$1,000 Scholarship for tuition for a Florida resident to the IAFE Institute of Fair Management was awarded to Lesa Burke of Volusia County.

The South Florida Fair hosted the IAFE Zone 2 meeting.

<u>In 2010</u> waive registration fee for IAFE President.

In cooperation with the Florida Department of Agriculture a video was made and widely distributed titled **"Beyond The Midway."**

The "Faircracker" newsletter became available on the Federation website and in print.

<u>In 2011</u> Online convention registration was offered for the first time. FYI established for age 40 and under. Leah Norris was the first chairman. This was similar to IAFE's YPI. This was later merged into YPI.

Historical Display Contest was established to showcase a Fair's History. The winner was Pasco County, in 2012 it was won by Citrus County and 2013 by Florida State Fair. The contest was discontinued as it had served its purposed to encourage Fairs to have a history exhibit.

Florida Dairy Farmers sponsored the milkable cow display.

First annual Fair Dream Tour was established by Happy Norris. The trip was in August visiting the Iowa State Fair, Indiana State Fair and the Illinois State Fair.

The first joint convention with Zone II was established.

<u>In 2012</u> the second Fair Trip was to The Big E, Fryeburg Fair, and Topsfield Fair.

In 2013 What A Great Idea Contest was established.

The Fair Trip was to East Texas State Fair, and State Fair of Texas.

Lisa Hinton, Executive Director received the IAFE Executive of the Year Award.

<u>In 2014</u> Miranda Muir was elected YPI representative for Zone II.

The Fair Trip was the Calgary Stampede in Canada.

<u>In 2015</u> the Fair Trip was to State Fair of VA fairgrounds, Maryland State Fair and Allentown, PA Fair.

A Strategic Planning Committee was established.

<u>In 2016</u> the Fair Partner Shoot-out was established in partnership with NICA and OABA, in February raising over \$10,000.

A fire in the trade show area canceled Tom Umiker's President's Party.

The Fair Trip was to the Minnesota State Fair.

YPI raised funds and supplies for a St. Augustine Youth charity.

<u>In 2017</u> Florida State Fair hosted a Florida Fair Appreciation Reception.

Participated in Farm Bureau Legislative Days in Tallahassee.

Hired CAS Government Services to lobby for us in Tallahassee.

Megan Price, Miss South Florida Fair became Miss Florida.

The Beyond The Midway video made in 2010 was reworked and distributed as a CD.

Agricultural signs were created using "Ole Red" displaying QR codes.

The Summer Trip was to the Erie County Fair.

The "Great Ideas" Contest was established.

First Fall Fair Trip visiting Florida Fairs, Volusia, Jacksonville, North Florida Fair.

YPI established a fund raiser to be held on Wednesday night after the Golf Tournament. Mix & Mingle Bowling was held and a donation was made to Harbor House of Central Florida.

Facebook page established. Recognized new members.

<u>In 2018</u> Summer Fair Trip was to California State Fair in Sacramento.

Miss South Florida Fair Taylor Tyson, was crowned Miss Florida.

A first time attendee workshop was held at the convention.

A Candidate Forum for those running for Commissioner of Agriculture.

YPI raised funds and goods with another Mix & Mingle for Literacy volunteers of Collier County.

Hurricane Michael caused damage throughout the State. Fairs were instrumental in recovery.

Fall Fair Trip was to Georgia National Fair in Perry, Ga.

IAFE met in San Antonio, Texas. Leaving Las Vegas after decades. Rick Vymlatil was elected Chair and all of the Florida Delegates wore matching blue shirts and volunteered at all of the events for the day.

<u>In 2019</u> Bill Olson, Greater Jacksonville Agricultural Fair and YPI member, at age 40, was the youngest person elected President of the Florida Federation of Fairs.

Dan West, former manager of the Manatee County Fair was hired to replace retiring Executive Director Lisa Hinton.

YPI raised \$2,000.00 for the Lee Conlee House in Putnam County.

<u>In 2020</u> The 5th Annual Fair Partner Shootout was another success.

The 2020 Spring Faircracker went completely digital and was on the website March 1st.

Due to a worldwide pandemic Covid 19, many Fairs were not allowed to open. It started with Miami-Dade Youth Fair. Others who did not have a Fair were: Sarasota, Okeechobee, Collier (ran partly), Putnam, Citrus, Flagler, Clay, Santa Rosa, Hernando, and Lake.

The 2020 Florida Federation of Fairs Convention, to be held at World Golf Village was cancelled. Election of officers was held via Zoom video meeting May 28, 2020.

The 2021 Convention was held at the Naples Grand Resort. Coincidentally this was in the hometown of the Incoming President Rhonda Ward from Collier Fair. The Golf Tournament was not held because of the lack of an affordable course. Instead a Giles Ellis Memorial Event was the Fun Shoot & Giles Ellis Memorial Event.

The theme for the President's Party was football

Open mic was established in the hospitality room. For the first time ever we were not allowed to bring our own refreshments.

The summer fair trip was to Wilson County Fair, Tennessee State Fair, Williamson County Fair and Georgia Mountain Fair.

<u>In 2022</u> the convention was again held at the Naples Grande. Zones 1 & 2 joined the convention. This was the 110th year that Dennis Lee sponsored the Hospitality room. The hotel moved it from downstairs to upstairs ballroom and the price of a mixed drink was \$12, and beer or soft drink \$6.00. There was not a lunch on Saturday. There were more showcases than previously. was over sold. The theme was Mardi Gras. Several new awards were established. The Fair trip ws to Washington State Fair.

<u>In 2023</u> the convention was held in Orlando with Zone 2 joining. The largest Trade Show so far. The Past Presidents' Council was established giving the group one vote on the Board of Directors. Wilton Simpson, Commissioner of Agriculture was the Keynote Speaker.

HISTORY OF THE GILES ELLIS MEMORIAL GOLF TOURNAMENT/EVENT

As a means to fund the Merit Awards Program a Golf Tournament was started on April 25, 2001. It was chaired by Giles Ellis of the Florida State Fair and held at MacDill Air Force Base in Tampa. Besides funding the program it became a major source of income for the Federation. Raising more than \$100,000 since its inception.



The tournament was held in 2001, 2002, 2003, 2004, and 2005 in Tampa and Chaired by Giles Ellis.

In 2008 the Annual Golf Tournament was named after Giles Ellis, CFO of the Florida State Fair, who passed away in 2007.

PREMIUM CHECKS

Premium checks issued by a Fair and not cashed become unclaimed property and must be paid to the state? Some Fairs have already had to remit the amount of outstanding checks to the state.

To avoid this liability the following wording should be included on the checks and on the applications for entries.

Language for checks for premium monies:

This check is void if not negotiated within 90 days from the date hereof and all sums held on payee's behalf by payor shall constitute an irrevocable gift of said amount by payee to payor.

Language for applications for entries:

All checks for premium monies awarded in connection with the Fair shall be negotiated by the recipient/payee within 90 days from the date of the check, time

being of the essence. If the recipient/payee fails to timely negotiate said check, all monies due recipient/payee shall belong to the Fair and the recipient/payee shall be deemed to have made an unconditional and irrevocable gift of said monies to the Fair.

GENERAL PROVISIONS

616.17 Minimum exhibits.--

managing public lands.

- (1) No public fair or exposition conducted by a fair association may be approved by the department for a tax exemption certificate unless the fair or exposition displays the following minimum exhibits, but this requirement may not be construed as a limitation on the number of exhibits which the fair or exposition may have:
- (a) Three exhibits from 4-H Clubs or Future Farmers of America chapters which are officially approved by those clubs or chapters.
- (b) Three exhibits of community, individual, or county farm displays.
- (c) Three exhibits of field crops in at least three different crops.
- (d) Three exhibits of horticultural products.

- (e) Three culinary exhibits such as canned fruits, canned vegetables, canned pickles or juices, jams, jellies, cakes, bread, candies, or eggs.
- (f) Three exhibits of household arts such as homemade spreads, towels, luncheon sets, rugs, clothing, or baby apparel.
- (g) Three exhibits of fruit or vegetable crops in at least three different crops.
- (h) Three exhibits of arts, crafts, photography, or antiques or of scout handiwork.
- (i) Three exhibits from home demonstration, home economics, educational, religious, or civic groups.
- (j) Three exhibits of livestock such as dairy cows, beef cattle, hogs, sheep, poultry, horses, or mules.
- (2) The provisions of subsection (1) do not apply to specialized livestock shows or fruit or vegetable festivals, the minimum exhibits of which shall be as follows:
- (a) Each specialized livestock show shall consist of at least 50 head of animals or 300 head of poultry.
- (b) Each specialized fruit, vegetable, or crop festival or exposition shall consist of at least 50 entries in the specialty, which shall occupy at least 1,000 square feet of display area.
- (3) The department may provide a waiver to the minimum exhibit requirements of this section to any fair association that submits an application for the waiver to the department, at least 60 days prior to the annual public fair or exposition in need of the waiver, and shows good cause why the requirements of this section cannot be met.

"Additional Powers of Fairs"

by Foster & Fuchs

In Chapter 616, which governs public fairs and expositions, there is a

section which lists the powers of a fair association. It is interesting to note the Florida Legislature has empowered a fair association to do more than just hold a fair. Specifically, Section 616.08 of the Florida Statutes provides:

Every fair association shall have the power to hold, conduct, and operate public fairs and expositions annually and for such purpose to buy, lease, acquire, and occupy lands, erect buildings and improvements of all kinds thereon, and develop those lands, buildings, and improvements; to sell, mortgage, lease, or convey any such property or any part thereof, in its discretion, from time to time for the purpose of public fairs or expositions; to charge and receive compensation for admission to those fairs and expositions, for the sale or renting of space for exhibitions, and for other privileges; to conduct and hold public meetings; to supervise and conduct lectures and all kinds of demonstration work in connection with or for the improvement of agriculture, horticulture, stock raising and poultry raising, and all kinds of farming and matters connected therewith; to hold exhibits of agricultural and horticultural products and livestock, chickens, and other domestic animals; to give certificates or diplomas of excellence; to promote the progress of the geographical area it represents and serves and stimulate public interest in the advantages and development of that area by providing facilities for agricultural and industrial exhibitions, public gatherings, cultural activities, and other functions which the association determines will enhance the educational, physical, economic, and cultural interests of the public; and generally to do, perform, and carry out all matters, acts, and business usual or proper in connection with public fairs and expositions.

CONFLICT OF INTEREST POLICY

Article I—Purpose

The purpose of the conflict of interest policy is to protect this tax-exempt organization's (Organization) interest when it is contemplating entering into a transaction or arrangement that might benefit the private interest of an officer or director of the Organization, or might result in a possible excess benefit transaction. This policy is intended to supplement but no replace any applicable state and federal laws governing conflict of interest applicable to nonprofit and charitable organizations.

Article II—Definitions

1. **Interested Person** - Any director, principal officer, or member of a committee with governing board delegated powers, who has a direct or indirect financial interest, as defined below, is an interested person.

- 2. **Financial Interest** A person has a financial interest if the person has, directly or indirectly, through business, investment, or family:
- a. An ownership or investment interest in any entity with which the Organization has a transaction or arrangement, or
- b. A compensation arrangement with the Organization or with any entity or individual with which the Organization has a transaction or arrangement, or
- c. A potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which the Organization is negotiating a transaction or arrangement.
- Compensation includes direct and indirect remuneration, as well as gifts or favors that are not insubstantial.

A financial interest is not necessarily a conflict of interest. Under Article III, Section 2, a person who has a financial interest may have a conflict of interest only if the appropriate governing board or committee decides that a conflict of interest exists.

Article III-Procedures

- 1. **Duty to Disclose.** In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the directors and members of committees with governing board delegated powers considering the proposed transaction or arrangement.
- 2. Determining Whether a Conflict of Interest Exists. After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.

3. Procedures for Addressing the Conflict of Interest.

- a. An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of and the voted on, the transaction or arrangement involving the possible conflict of interest.
- b. The chairperson of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.
- c. After exercising due diligence, the governing board or committee shall determine whether the Organization can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.
- d. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Organization's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement.

4. Violations of the Conflicts of Interest Policy.

b. If, after hearing the member's response and after making further investigation as warranted by the circumstances, the governing board or committee determines the member failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

Article IV—Records of Proceedings

The minutes of the governing board and all committees with board delegated powers shall contain:

- a. The names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the governing board's or committee's decision as to whether a conflict of interest in fact existed.
- b. The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement, and a record of any votes taken in connection with the proceedings.

Article V—Compensation

- a. A voting member of the governing board who receives compensation, directly or indirectly, from the Organization for services is precluded from voting on matters pertaining to that member's compensation.
- b. A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Organization for services is precluded from voting on matters pertaining to that member's compensation.

No voting member of the governing board or any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Organization, either individually or collectively, is prohibited from providing information to any committee regarding compensation.

Article VI—Annual Statements

Each director, principal officer and member of a committee with governing board delegated powers shall annually sign a statement which affirms such person:

- Has received a copy of the conflicts of interest policy, Has read and understands the policy, h.
- Has agreed to comply with the policy, and
- c.
- Understands the Organization is charitable and in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.

Article VII- Periodic Reviews

To ensure the Organization operates in a manner consistent with charitable purposes and does not engage in activities that could jeopardize its tax-exempt status, periodic reviews shall be conducted. The periodic reviews shall, at a minimum, include the following subjects:

- Whether compensation arrangements and benefits are reasonable, based on competent survey information, and the result of arm's length bargaining.
- Whether partnerships, joint ventures, and arrangements with management organizations conform to the Organization's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes and do not result in inurement, impermissible private benefit, or in an excess benefit transaction.

Article VIII -Use of Outside Experts

When conducting the periodic reviews as provided for in Article VII, the Organization may, but need not, use outside advisors. If outside experts are used, their use shall not relieve the governing board of its responsibility for ensuring periodic reviews are conducted.
