Further, we certify that the student has not used mechanical devices such as opaque or overhead projectors or used computer enhanced pictures. We agree that the FBCF will not be held responsible for any copyright infringements and will release and indemnify them from any claims.

We hereby acknowledge that we give permission to the FBCF and whomever it may authorize the absolute right and permission to copyright, publish and/or use photographic portraits, pictures, motion pictures and/or video reproductions of the student and/or his/her artwork, in which the student and/or the work may be included in whole or part, or composite or distorted in character or form, in conjunction with his/her own or a fictitious name or reproductions thereof, in color or otherwise, made through any media at a studio, on the grounds or any location of the FBCF or elsewhere, for art, advertising, editorial, educational trade or any other lawful purpose whatsoever as deemed necessary by the FBCF. We hereby acknowledge that we give permission for this use without the receipt of any financial consideration or compensation with regards to the reproduction of the student's artwork. We agree to waive any right that the student may have to inspect and/or approve the finished product that may be used in connection therewith, or the use to which it may be applied. We understand that voluntary consent to waiving of any rights and/or privileges which we might have in this matter is prerequisite to entering and competing in any contest whatsoever held in connection with and sanctioned by the FBCF and that this properly executed release form is a part of the student's valid application to be a contestant in any such event.
