2021 CALF SCRAMBLE GENERAL RULES, REGULATIONS AND RELEASE

For and in consideration of Southwestern Exposition and Livestock Show (“SELS”) considering the Contestant (“Contestant”) for participation, and/or allowing Contestant to participate, in the Calf Scramble and related activities held during the annual Fort Worth Stock Show & Rodeo (collectively, the “Calf Scramble”), I, for myself and on behalf of Contestant, my spouse, and each of our heirs, personal representatives, next of kin, successors and assigns (collectively, “Releasors”), hereby agree to the terms and conditions of this Entry Application and Release (“Entry Application”).

I have read and understand the Calf Scramble General Rules, Regulations and Release and have carefully and fully explained them to Contestant. I understand that Contestant’s eligibility to participate in the Calf Scramble is subject to SELS’ verification and decision on the day of Contestant’s participation in the Calf Scramble and that all decisions of SELS are final and binding. I agree on my behalf and on behalf of Contestant to the Calf Scramble rules and to abide by all decisions of SELS, and I will cause Contestant to abide by all such rules and decisions.

Acknowledgment & Assumption of Risk: I understand and acknowledge that participation in the Calf Scramble requires good health and fitness. I agree that it is my sole responsibility to determine whether Contestant is sufficiently fit and healthy for participation in the Calf Scramble. I further understand that activities like the Calf Scramble are dangerous activities and that a person’s participation in any capacity in such activities will expose the person to a **SUBSTANTIAL AND SERIOUS RISK OF PERSONAL INJURY, PROPERTY DAMAGE, AND/OR DEATH**. I understand and expressly acknowledge that there are significant hazards, dangers, and risks associated with Contestant’s participation in the Calf Scramble and Contestant’s presence at the Calf Scramble Site (“Risks”), including (without limitation): protective gear and other equipment failure; exposure to viruses or diseases and other dangers arising from close contact with animals; arena conditions; property damage; and/or personal injury, disability or death. I acknowledge and agree there may be Risks not known to me or reasonably foreseeable at this time. I understand and I have considered the Risks involved and the fact that I may not be aware of all of the Risks involved, and I voluntarily and freely choose to assume these Risks on behalf of myself, Contestant and all other Releasors. I agree I am responsible for Contestant’s safety and wellbeing at all times and under all circumstances while at the Calf Scramble site and the other grounds, premises, and arenas related to the annual Fort Worth Stock Show & Rodeo (“Calf Scramble Site”). I understand and acknowledge that Risks may be caused, in whole or in part, by the acts or omissions of Contestant or others participating or volunteering in the Calf Scramble or present at the Calf Scramble Site or by Released Parties (as defined below). **On behalf of the Releasors, I hereby expressly assume responsibility for all Risks and liability for any damages, liabilities, losses or expenses which may be incurred as a result of Contestant’s participation in the Calf Scramble and presence and conduct at the Calf Scramble and Calf Scramble Site.**

CONTESTANT/PARENT UNDERSTANDS AND ACKNOWLEDGES THAT ACTIVITIES LIKE THE SHOW ARE DANGEROUS ACTIVITIES AND THAT CONTESTANT’S PARTICIPATION IN ANY CAPACITY IN SUCH ACTIVITIES WILL EXPOSE CONTESTANT TO A SUBSTANTIAL AND SERIOUS RISK OF PERSONAL INJURY, PROPERTY DAMAGE, AND/OR DEATH. CONTESTANT/PARENT UNDERSTANDS AND EXPRESSLY ACKNOWLEDGES THAT THERE ARE SIGNIFICANT HAZARDS, DANGERS, AND RISKS ASSOCIATED WITH CONTESTANT’S PARTICIPATION IN THE SHOW AND CONTESTANT’S/PARENT’S PRESENCE ON THE SHOW GROUNDS (“RISKS”), INCLUDING: PROTECTIVE GEAR AND OTHER EQUIPMENT FAILURE; MEDICAL TREATMENT (OR LACK THEREOF); THE ACTS OR OMISSIONS OF CONTESTANT/PARENT, RELEASED PARTIES (AS DEFINED BELOW), OR OTHERS PARTICIPATING OR VOLUNTEERING IN THE SHOW OR PRESENT AT THE SHOW GROUNDS; EXPOSURE TO COVID-19, VIRUSES OR DISEASES AND OTHER DANGERS ARISING FROM CLOSE CONTACT WITH HUMANS AND ANIMALS; ERRATIC ANIMAL BEHAVIOR; SHOW GROUNDS CONDITIONS; PROPERTY DAMAGE; AND/OR PERSONAL INJURY, DISABILITY, SICKNESS, OR DEATH. CONTESTANT/PARENT ACKNOWLEDGES AND AGREES THERE MAY BE RISKS NOT KNOWN TO CONTESTANT/PARENT OR REASONABLY FORESEEABLE AT THIS TIME. CONTESTANT/PARENT UNDERSTANDS AND HAS CONSIDERED THE RISKS INVOLVED AND THE FACT THAT CONTESTANT/PARENT MAY NOT BE AWARE OF ALL OF THE RISKS INVOLVED, AND CONTESTANT/PARENT VOLUNTARILY AND FREELY CHOOSES TO ASSUME ALL KNOWN AND UNKNOWN RISKS ON BEHALF OF CONTESTANT AND ALL OTHER RELEASORS. CONTESTANT/PARENT AGREES CONTESTANT/PARENT IS RESPONSIBLE FOR CONTESTANT’S SAFETY AND WELLBEING AT ALL TIMES AND UNDER ALL CIRCUMSTANCES WHILE AT, IN, OR ON THE SHOW GROUNDS.

Further, Contestant/Parent acknowledges that participation in the Show and being present on the Show Grounds may expose Contestant/Parent to crowds, other individuals, or animals, which may place Contestant/Parent at risk for being exposed to or contracting the novel coronavirus (“COVID-19”), which has been declared a worldwide pandemic by the World Health Organization, or any viruses, illnesses, or diseases spread by humans or animals. In particular, Contestant/Parent acknowledges that COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing. Contestant/Parent therefore agrees that: (i) Contestant/Parent will not travel internationally or travel to or from an area in the United States that has been highly-impacted by COVID-19 within 14 days of his/her access to the Show Grounds or during the Show; (ii) if Contestant/Parent experiences symptoms recognized by the Centers for Disease Control and Prevention as symptoms of COVID-19 or any other contagious disease or virus within 14 days of his/her access to the Show Grounds or during the Show, Contestant/Parent will not enter the Show Grounds; (iii) if Contestant/Parent is diagnosed with, or is exposed to a person with a confirmed or suspected case of COVID-19 or any other contagious disease or virus, Contestant/Parent will not enter the Show Grounds unless Contestant/Parent has subsequently tested negative for the contagious disease or virus and is cleared by a medical doctor for entering the Show Grounds. By signing this Release, Contestant/Parent acknowledges the contagious nature of COVID-19 and voluntarily assumes the risk that Contestant/Parent may be exposed to or infected by COVID-19 or any other contagious disease or virus by entering the Show Grounds and that such exposure or infection may result in personal injury, illness, permanent disability, and death or loss of prizes or income.

BEING FULLY AWARE OF THE FOREGOING, CONTESTANT/PARENT, ON BEHALF OF ALL RELEASORS, HEREBY FULLY ASSUMES SOLE RESPONSIBILITY AND LIABILITY FOR SUCH HAZARDS AND RISKS (BOTH KNOWN AND UNKNOWN) AND FOR ANY DAMAGES, LIABILITIES, LOSSES, OR EXPENSES THAT MAY BE INCURRED AS A RESULT OF CONTESTANT’S PARTICIPATION IN THE SHOW, CONTESTANT’S/PARENT’S EXPOSURE TO OR CONTRACTION OF COVID-19 OR ANY OTHER CONTAGIOUS VIRUS OR DISEASE, CONTESTANT’S/PARENT’S PRESENCE ON THE SHOW GROUNDS, AND RELEASED PARTIES’, CONTESTANT’S/PARENT’S, AND ANYONE ELSE’S ACTS OR OMISSIONS. CONTESTANT/PARENT AGREES THAT CONTESTANT ENTERS AND PARTICIPATES IN THE SHOW AT CONTESTANT’S/PARENT’S OWN RISK.

Use of Likeness: In further consideration of SELS permitting Contestant to enter and/or to participate in the Calf Scramble, the receipt and sufficiency of which is hereby acknowledged, I, on behalf of myself and the other Releasors, hereby grant the Released Parties permission to photograph, video, record, and interview Contestant and the nonexclusive, irrevocable, perpetual, sublicensable (through multiple tiers), transferable, and worldwide right and license to display, distribute, perform, exhibit, transmit, broadcast, reproduce, publish, digitize, edit, adapt, synchronize, create derivative works from, exploit, stream, license, and otherwise use Contestant’s name, nickname, image, likeness, appearance, voice, biographical information, signature, performance, and any other identifying personal

characteristics of Contestant (collectively, “**Contestant’s Likeness**”) and all content and materials created by or on behalf of the Released Parties that incorporate or otherwise include, in whole or in part, Contestant’s Likeness (collectively, the “**Materials**”) for any purpose, including without limitation, educational, entertainment, business, and promotional purposes, in perpetuity in any medium or format whatsoever now existing or hereafter created, including but not limited to, in, on, or through print media, film, television, internet and online media, and all forms of broadcast and streaming technologies, without further consent from or compensation to Contestant, me or anyone else, including any Releasors. Credit or other acknowledgment of Contestant, if any, shall be determined by the Released Parties in their sole discretion. I, on behalf of myself and the other Releasors, (i) agree that the Released Parties make no representation that Contestant’s Likeness will or will not be used in any way, (ii) waive any right to inspect or approve the Materials or any use of the Materials, (iii) agree that the Released Parties shall have full exclusive ownership (including all copyrights and other intellectual property rights) of any Materials, (iv) represent and warrant that Contestant is not a member of any union or guild or memberships that would prevent me from granting these rights or Contestant from participating in the Calf Scramble, and (v) agree not to challenge or otherwise interfere with the Released Parties’ rights in and to the Materials or their use of Contestant’s Likeness

Waiver of Jury Trial: I, ON BEHALF OF MYSELF AND ALL OTHER RELEASORS, AND SELS EACH AGREE TO WAIVE ANY RIGHT WE MAY HAVE TO A TRIAL BY JURY AND TO RESOLVE ANY AND ALL DISPUTES ARISING BETWEEN US BY TRIAL BEFORE A COURT OF COMPETENT JURISDICTION IN TARRANT COUNTY, TEXAS SITTING WITHOUT A JURY, INCLUDING ANY DISPUTES UNDER THIS ENTRY APPLICATION OR THE OFFICIAL RULES OR RELATING TO THE FORT WORTH STOCK SHOW & RODEO OR THE CALF SCRAMBLE OR THE CALF SCRAMBLE SITE.

Other Terms: Upon SELS’s request, I agree to sign and deliver to SELS any additional documents presented by SELS for purposes of confirming the licenses, agreements, consents, and releases granted in this Entry Application. I represent that I completely understand that this is a complete and final release, waiver and indemnity agreement. I represent and warrant that I am the parent/legal guardian of Contestant and I have the full power, authority, capacity and right, without limitation, to execute, deliver, and perform this Entry Application. I acknowledge and agree that the Released Parties (i) are third-party beneficiaries of this Entry Application, (ii) are each entitled to the rights and benefits given to them hereunder, and (iii) may enforce the provisions of this Entry Application as if they were parties to same. Except as expressly provided in this provision, there are no other third-party beneficiaries to this Agreement. I understand that this Entry Application shall be binding on me and the other Releasors, any dispute regarding the subject of this Entry Application and this Entry Application itself will be governed by the laws of Texas, and that the exclusive jurisdiction and venue for any dispute regarding the subject of this Entry Application and this Entry Application itself shall lie in the state courts of Tarrant County, Texas. I acknowledge that this Entry Application will be construed and interpreted as broadly as possible under Texas law, AND I WAIVE ANY AND ALL GENERAL RELEASE LIMITATIONS PROVIDED BY APPLICABLE LAW OR ANY RIGHTS GRANTED TO ME THEREUNDER. If any part of this Entry Application is determined to be invalid or unenforceable, it does not affect the validity of the remainder of this Entry Application. This Entry Application and SELS’s rules and regulations constitute the entire agreement between SELS and Releasors and supersede any previous or contemporaneous discussions or agreements between us in respect of these matters.

I HAVE CAREFULLY READ THIS ENTRY APPLICATION AND I FULLY UNDERSTAND ITS TERMS AND AGREE TO BE FULLY BOUND BY SUCH TERMS IN BOTH MY INDIVIDUAL CAPACITY AND IN MY CAPACITY AS PARENT OR LEGAL GUARDIAN OF CONTESTANT. I FULLY UNDERSTAND THAT THIS ENTRY APPLICATION PROVIDES RELEASED PARTIES WITH MY ABSOLUTE AND UNCONDITIONAL CONSENT, WAIVER, AND RELEASE OF LIABILITY AND ALLOWS RELEASED PARTIES TO PUBLICIZE AND COMMERCIALY EXPLOIT CONTESTANT’S LIKENESS AS SET OUT ABOVE. BY SIGNING, I ACKNOWLEDGE THAT I UNDERSTAND ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE RELEASED PARTIES. I FURTHER UNDERSTAND THAT I AM FULLY BINDING ALL RELEASORS TO THE TERMS OF THIS AGREEMENT. I HAVE VOLUNTARILY AND WITHOUT INDUCEMENT OF ANY NATURE EXECUTED AND DELIVERED THIS ENTRY APPLICATION.

INCOMPLETE ENTRY APPLICATION AND RELEASES WILL NOT BE ACCEPTED. All information requested on the Entry Application and Release must be complete. There must be two adult witnesses to the signing of the Entry Application and Release by the Parents and the Contestant. BOTH PARENTS must sign the Entry Application and Release. However, if the Parents are divorced, or if one is deceased, one signature is sufficient, BUT THE NOTATION OF “DIVORCED” or “DECEASED” MUST BE IN THE SPACE PROVIDED, or the Entry Application and Release will be returned.

NOTE: Signatures of Parents, Contestant and Witnesses MUST BE THEIR OWN. This Entry Application and Release will not be accepted unless the signatures of Parents and Contestant are witnessed by TWO ADULT WITNESSES.

SELECTION OF CONTESTANTS

1. The 2021 Calf Scramble will be held in 22 of the Rodeo performances. There will be twenty (20) participants and seven (7) alternates scheduled for each performance. The participants will be guaranteed a position in the Scramble. The alternates will be used to fill any vacancies.
2. Participants should be carefully selected using the guidelines listed under Paragraph 3.
 - a. The Calf Scramble is made available to both girls and boys who reside in the State of Texas and are members of 4-H or FFA.
 - b. Scramble participants must be born 9/01/03 – 1/01/07 and not beyond their junior year of high school.
 - c. Each 4-H Club’s or FFA Chapter’s entries must be received at one time as a group.
 - d. **ENTRIES WILL BE ACCEPTED ON A FIRST-COME, FIRST-SERVE BASIS.** Students will be notified through their AST or CEA about their status. After all positions have been filled, remaining applications will be kept on file and AST or CEA will be notified should a position become available.
 - e. Each County Extension Agent or Agricultural Science Teacher may enter a maximum of six students. The following chart should be followed with regard to the number of participants in relation to the number of alternates. Designation must be made on the entry application indicating whether the applicant is a participant or an alternate.

- f. If for any reason a participant or alternate is forced to withdraw from participating in the Calf Scramble, it is the responsibility of the AST or CEA to notify the Calf Scramble Office immediately. Failure to notify the Calf Scramble Office may disqualify other participants from that Chapter or County.
3. The following questions should be taken into consideration by ASTs or CEAs when selecting participants:
 - a. The Scramble Purchase Certificate awarded to the winner is for the purchase of a registered beef or dairy heifer, and will be mailed to the winner’s supervisor. Most participants have had to add more money in order to obtain a suitable animal for showing. Would the participant’s parents be financially able to add extra funds if it is necessary?
 - b. Does the participant have suitable facilities for caring for and developing the animal of their choice?
 - c. Does the participant have a real desire to own and show a registered animal?
 - d. Is the participant the type who will devote the required attention to the animal in an effort to bring a good animal to the 2022 Show that he or she, their sponsor, their supervisor and the Southwestern Exposition and Livestock Show will be proud to exhibit?
 - e. Are the participants’ grades satisfactory enough to allow them to participate in the Scramble, as well as to spend the time away from school (principal permitting) to bring the animal to the 2022 Show and stay with her for the days necessary to show and care for her?
 - f. Will the participant be conscientious in submitting regular monthly reports to the Calf Scramble Office and to the sponsor?

ARENA RULES

1. Participants and calves will be placed in the arena as directed by the arena director.
2. The Calf Scramble will be refereed by an appointed group of referees.
3. Participants will take into the arena a rope halter which will be supplied by the Southwestern Exposition and Livestock Show. The halter cannot be used as a lariat. Halters must be placed on the head of the animal in the usual way. (It is suggested that the supervisors of all participants instruct the participants in the proper use of a rope halter, and how to place it on the head of a calf before coming to the Show to participate in the Scramble.)
4. At no time will a participant be permitted to tie the rope to his body or belt.
5. Each participant will attempt to catch and halter one of the calves released in the arena. The participant catching a calf is required to halter it and lead it across the finish line.
6. If a participant catches a calf, no other participant will be allowed to touch the calf unless it breaks free.
7. If a participant catches the calf by the tail, they will be given a reasonable amount of time to work around to its head; otherwise, the referee will instruct them to release the calf.
8. If two or more participants simultaneously catch the same calf, the calf will be released.
9. If a participant loses a calf with his halter on, it then becomes a “free calf”. The participant is permitted to recapture the calf by the halter or rope, but any other participant who catches this calf will have to catch it in the usual manner, then remove the halter and put their own halter on the calf.
10. A participant who catches and properly halters a calf and leads it across the finish line will be declared a winner when so indicated by the referees.
11. Undue roughness will not be tolerated by the referees. Poor sportsmanship automatically disqualifies any participant.
12. Contestants must wear blue denim jeans and a Calf Scramble jersey. (Jersey to be provided by the Southwestern Exposition and Livestock Show.)
13. Shoes with any type of metal cleats will not be allowed.

INTERSCHOLASTIC RULING

The Interscholastic League State Executive Committee in cooperation with the State Board of Vocational Education has formulated the following model for the Calf Scramble Rules which permits the event, but still protects the participant’s amateur standing. This is done, as will be noted in the Rules, by placing the whole matter under the supervision of the Agricultural Science Department of the School and Texas AgriLife Extension Service and prohibiting the participants from receiving anything of cashable value for winning the athletic part of the program.

1. A participant shall not receive rewards of any kind for participating in a Calf Scramble.
2. Special awards may be given for these animals when they are exhibited in competition with other animals, and all awards and other money derived from the sale of the animal will belong to the participants as a reward for their labor, feed, veterinary, insurance and other costs, after the year’s project has been completed and the animal shown at the Southwestern Exposition and Livestock Show.
3. Title to an animal received in a Scramble shall not pass to the participant catching the calf until the participant has demonstrated under competent supervision their interest in caring for the animal and their ability to follow competent instructions in feeding, grooming and showing said animal. The animal must be returned for exhibit at the next Show, unless circumstances approved by the Livestock Show Management, sponsor and supervisor, make this impractical. Example: The animal may turn out to be unsuitable for the project due to deformity, disease or other unforeseen reasons.

4. Animals received in a Scramble will not be allowed to be sold, traded or disposed of until the participant receives title to the animal. Under no circumstances will a “For Sale” sign be displayed while an animal is being exhibited at the Southwestern Exposition and Livestock Show.
5. Payments will only be made to the seller of the animal. No payments will be issued directly to a winner or member of the winner’s family. Students, parents, or supervisors will not be issued payments for reimbursements.

RULES FOR PURCHASING HEIFERS WON IN THE CALF SCRAMBLE

1. A participant catching a calf in the Calf Scramble and otherwise being declared a winner will receive a purchase certificate valued at \$500 with which they may use to purchase a registered beef or dairy heifer of their choice. The eligible breeds will be listed on the backside of the purchase certificate. This certificate, along with complete instructions, will be mailed to the winner’s AST or CEA approximately two weeks after the conclusion of the Show.
2. Winners must purchase their animal from a bona fide herd outside of their immediate family (i.e. winners may not purchase an animal from themselves or a family member).
 - a. The heifer **MUST BE PURCHASED BY THE WINNER NOT LATER THAN JUNE 1, 2021**. Registration certificates must be transferred and/or recorded in the purchaser’s name on or before November 1, 2021.
 - b. **BEEF HEIFERS:** The calf must be recorded or registered in the association records of one of the following breeds: ABERDEEN-ANGUS (Black), BEEFMASTER (must be registered with B.B.U.), BRAFORD, BRAHMAN, BRANGUS (must be registered with IBBA), BRAUNVIEH, CHIANINA, CHAROLAIS, GELBVIEH, HEREFORD, LIMOUSIN, LONGHORN, MAINE-ANJOU, POLLED HEREFORD, RED ANGUS, SANTA GERTRUDIS, SHORTHORN, SIMBRAH, SIMMENTAL. Beef Heifers must have been born on or after January 1, 2020.
 - c. **DAIRY BREEDS:** The calf must be purebred and registered in the association records of one of the following breeds: AYRSHIRE, BROWN SWISS, GUERNSEY, HOLSTEIN, JERSEY or MILKING SHORTHORN. Dairy heifers must have been born on or after December 1, 2019.
 - d. There will be no separate classes for Scramble heifers. Dairy heifers will be shown in the Junior Dairy Show. Depending upon breed purchased, beef heifers will be shown in the Junior Beef Heifer or Open Beef Cattle Shows. Beef and Dairy Heifers must meet eligibility requirements for their respective classes at the Southwestern Exposition and Livestock Show.
3. No payments will be issued as reimbursement to a winner’s relative or supervisor. Payments will only be issued to the seller of the animal.
4. The purchase certificate should be given to the seller of the animal. The seller is responsible for transferring the registration certificate to the Scramble winner’s name. The transferred registration papers and Scramble purchase certificate must be submitted by the seller to the Southwestern Exposition and Livestock Show, Attn: Calf Scramble, P.O. Box 150, Fort Worth, TX 76101-0150, at one time, before payment will be issued.
5. Any certificate not redeemed by September 1, 2021, will automatically become null and void. In the event that breed association requirements restrict the registration of an animal before this deadline, the purchase certificate and an affidavit stating that the animal has been purchased from the seller must be sent to the Calf Scramble office to be kept on file until the registration papers are received.
6. The payment will not exceed the amount of the certificate. If an animal is purchased for less than the amount of the certificate, a check will be issued from the Stock Show to the seller for the actual cost of the animal.
7. The original registration certificate will remain in the files of the Southwestern Exposition and Livestock Show until the recipient has entered this heifer in the 2022 Southwestern Exposition and Livestock Show.
8. The obligations of the Calf Scramble Program must be met and this must be verified by the Scramble winner’s supervisor. If not, the winner will be required to return the \$500 to the Southwestern Exposition and Livestock Show.

REPORTING AND EXHIBITION

1. Once a month, beginning with the month of June, the winner is required to submit a monthly report about their project. Winners must devise their own method of record keeping and make their monthly reports in the form of a letter. These reports, as well as any photographs, folders, etc., should be sent to the student’s sponsor. The Calf Scramble office should receive a photocopy of the reports and other material the sponsor receives. The January 2022 report should be a final essay on the entire project titled “My Scramble Project”.
2. Depending upon breed purchased, winners must exhibit their animal in the Junior Division or Open Division of the 2022 Southwestern Exposition and Livestock Show. Scramble exhibitors must indicate boldly on the entry card that their entry is a SCRAMBLE HEIFER. Braford and Longhorn will show in their respective open show.
3. Original registration certificate will be mailed out upon receipt of 2022 Junior Livestock Show entry.
4. Depending upon breed purchased, winners must care for their animal in accordance with the rules of the Junior Show or open Show Divisions.

COMBINING CERTIFICATES

Winners will be allowed to combine their Fort Worth Calf Scramble purchase certificates with certificates won at other livestock shows. The Calf Scramble Office must be notified prior to selection of the heifer.

CALF SCRAMBLE SCHOLARSHIPS

A minimum of thirty scholarships with a total of \$21,500 will be awarded to Calf Scramble exhibitors participating in the 2020 Calf Scramble. The scholarship recipients will be selected by a committee based on the Scramble exhibitor’s overall performance, including monthly reports, essay and placing at the 2022 Show.

Due to the outstanding efforts of the Calf Scramble Committee, minimum scholarship commitments have been exceeded for several years. The following guide outlines last year’s scholarship totals:

RODEO TICKETS

It is not necessary for the students, parents or supervisors to purchase rodeo tickets to view the Calf Scramble. A one-day grounds pass will be provided for the student. The pass will allow admittance to the Stock Show Grounds. It is not necessary for the students, parents or supervisors to purchase rodeo tickets to view the Calf Scramble. The Calf Scramble Committee will escort the group to the designated areas inside Dickies Arena prior to the Calf Scramble.

For those who wish to attend the entire rodeo performance, rodeo tickets may be purchased by calling (817) 877-2420. Tickets are available on a first-come, first-served basis and no complimentary seating will be provided. After the Post Scramble Meeting, the Calf Scramble Committee will escort the students to the viewing area. Those students will not have a seat, unless they purchased a ticket; but this will allow the students whose families that purchased tickets, to meet them at the conclusion of the rodeo.
