2023 HORSE SHOW – GENERAL ENTRY INFORMATION

PLEASE NOTE ENTRY CLOSING DEADLINE:

ALL HORSE SHOW ENTRIES MUST BE POSTMARKED OR SUBMITTED ONLINE AT FWSSR.COM BY MIDNIGHT NOVEMBER 15, 2022.

LATE ENTRIES MUST BE POSTMARKED OR SUBMITTED ONLINE AT FWSSR.COM BY DECEMBER 30 AND SUBMITTED WITH APPROPRIATE LATE FEE.

- 1. Payment for entry fees and additional passes <u>must</u> be submitted with entries. **Any entries received without payment will be returned.**
- 2. Please type or print legibly all information required on Entry Applications and Agent/Summary Sheets.
- 3. All entries must include appropriate signatures.
- 4. Copy of horse registration papers and exhibitor/owner membership card must accompany entry.

ALL ENTRIES MUST BE SUBMITTED WITH AN AGENT/SUMMARY SHEET. ONE AGENT/SUMMARY SHEET IS REQUIRED FOR EACH GROUP OF ENTRIES.

AGENT: All correspondence - including confirmation of entries, passes and premiums will be mailed to the agent.

Premium checks will be made payable to the owner – mailed to agent's address. (Owner can serve as Agent). Following the completion of the Show, agents will be contacted to obtain a Form W-9 for each owner in which the owner's premium check is \$600 or more. The premium check will not be released until a valid, signed Form W-9 is returned to Southwestern Exposition and Livestock Show.

OWNER: Owner of the animal will be as it appears on the registration papers or lease agreement at the time the entry application is submitted.

<u>CONFIRMATION OF ENTRIES</u>: Once an entry is received and processed, the agent will receive a confirmation of the entry along with the appropriate passes. Please open immediately. If the confirmation of entries does not agree with your understanding of the entries, please notify our office immediately. <u>Class changes or additions will not be permitted after NOON the day preceding the class involved. Class changes or additions accepted by mail or in person in the Stock Show Main Office located in the Amon G. Carter Jr. Exhibits Hall building or submitted online at fwssr.com.</u>

<u>TACK STALLS</u>: Tack stalls should be ordered on Horse Show Agent/Summary Sheet and paid for with entries. If sharing tack stalls, **DO NOT** pay for tack stall with two separate checks.

STALL REQUESTS: Any requests to be stalled with someone who is not acting as your agent should be indicated on your agent summary sheet with the exact name of the owner/agent you wish to be stalled with. The most effective way to insure that a group will be stalled together is for someone to act as agent. Otherwise every effort will be made to accommodate stalling requests but there is no guarantee.

<u>MEMBERSHIP CARDS</u>: Current individual membership cards must accompany entry and be shown at stall office before entry numbers will be issued. Please refer to each breed in the Premium List for membership card requirements.

TRAILERS: NO RV HOOKUPS OR OVER NIGHT PARKING WILL BE AVAILABLE FOR HORSE SHOW EXHIBITORS.

No Overnight Camping on the Stock Show grounds. Any trailer, vehicle or vehicle/trailer combinations left overnight will be towed at owner's expense. Parking space will be provided for all trailers. Exhibitors with vehicles pulling trailers will be directed to an appropriate parking location by Stock Show staff and will remain on Stock Show grounds at staff's discretion. However, no trailer, vehicle or vehicle/trailer combination will be allowed to remain on Stock Show grounds overnight. Trailers cannot be unhooked from vehicles and left on Stock Show grounds (must be moved to appropriate trailer parking location as directed by Stock Show staff).
