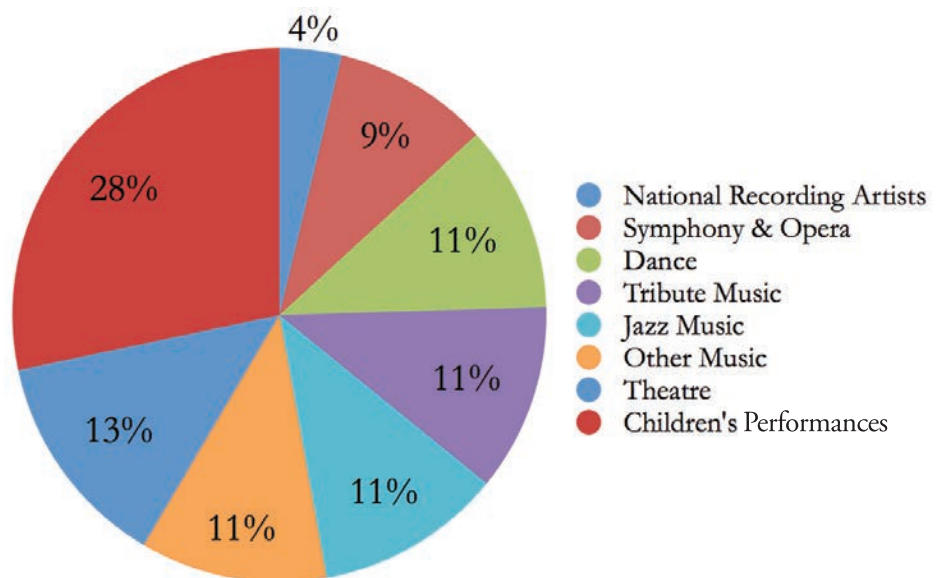




Variety is the **SPICE** *of* **LIFE**

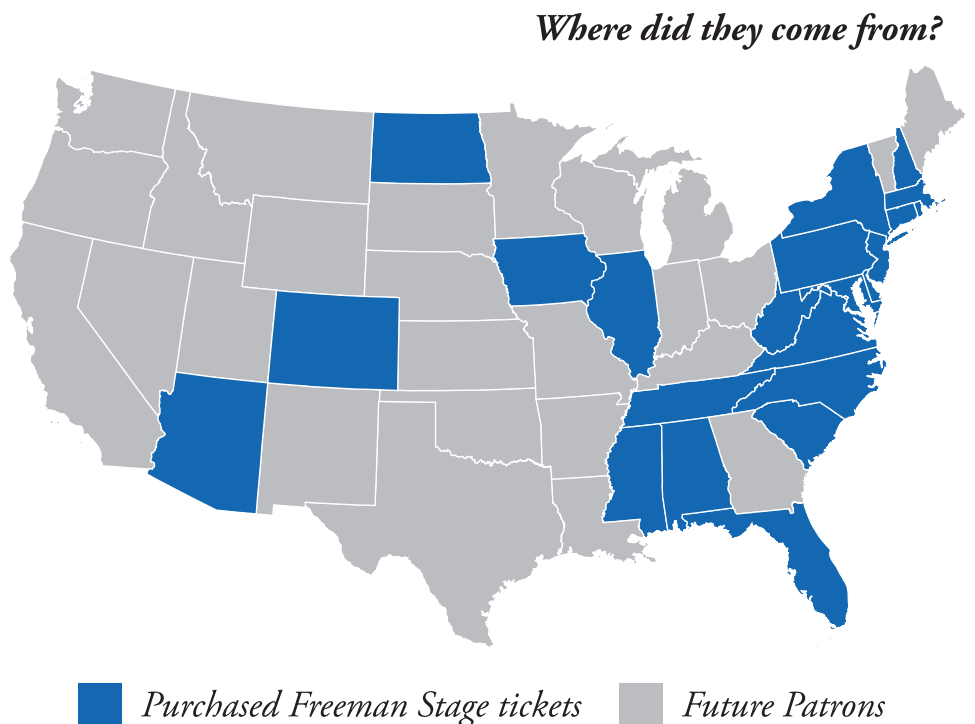
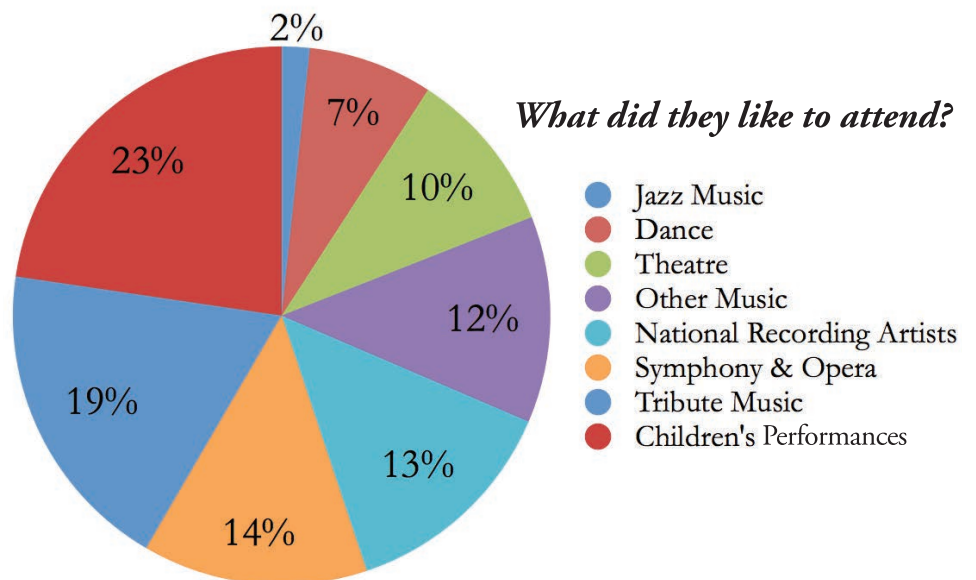

Though we cover some of our operating costs through ticket sales, concession sales, donations, and sponsorships, we still are faced with a substantial financial void to fill each season. Through the generosity of the Carl M. Freeman Foundation, we have received over \$3 million dollars in grants since our founding in 2007, including grants totaling \$780,000 during 2011. However, we must expand our broad-based community support to sustain our programs and thrive on a long term basis. As a way to offset these costs, we hold a series of special fundraising events throughout the summer. Not only do these events help us with our bottom line...they also ensure that our generous guests have some fun along the way!

New for 2011, the White Party - a theme for the appreciation of the summer season, where the decorations, food, and attire are typically white in color - was a huge success. In September, we held the annual Joshua M. Freeman Foundation Golf Tournament - a day that was one of Josh's favorite days of the year - and we followed it with the exciting Arts by the Sea party.

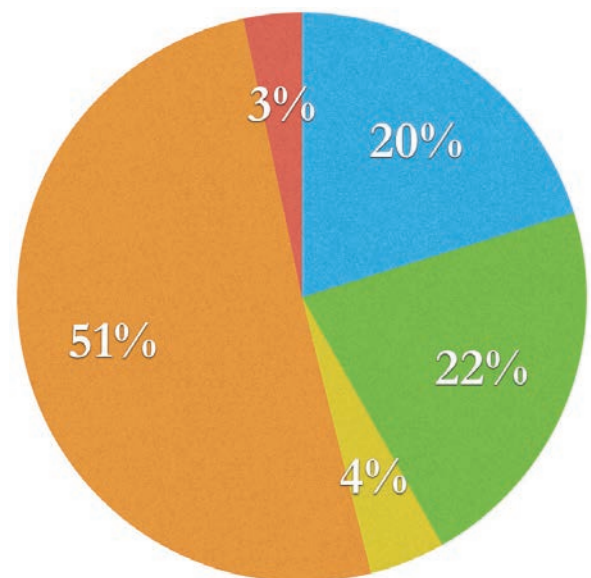

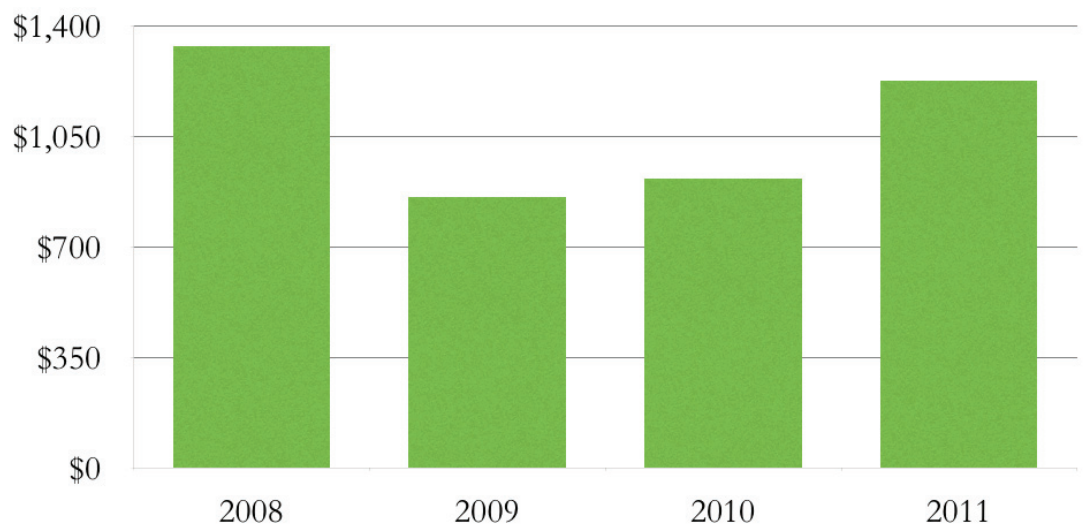

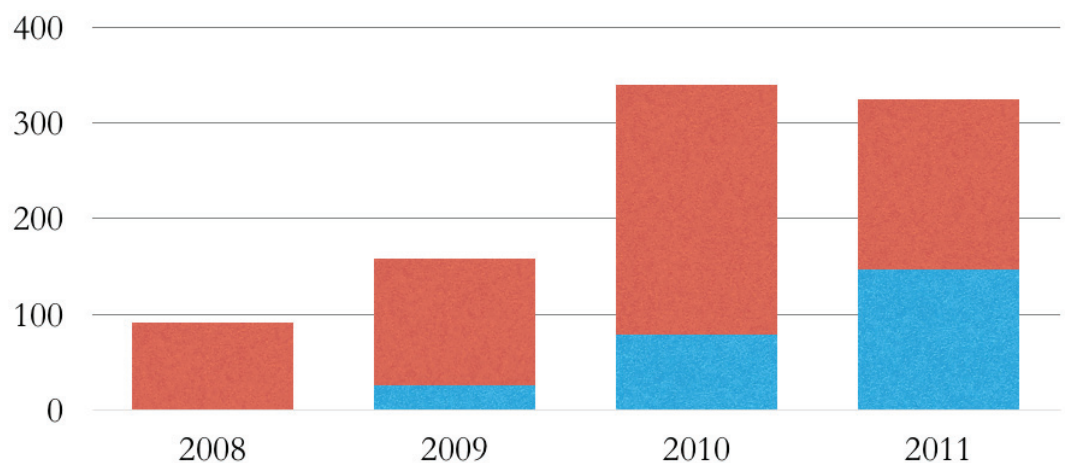
Estimated
