We recognize that there is a joyful need in our community for enriching, educational, and impactful arts experiences. In 2014, we again offered a diverse season of performances at The Freeman Stage at Bayside and at additional venues in the area. These events included tribute bands, dance troupes, national recording artists, local theatre productions, global musical artists, an arts & jazz festival, a special performance for Operation SEAs the Day, and painting workshops. As well, there were a number of informative pre- and post-performance Q&A sessions that encouraged patrons to interact with artists in a new way. In all, there were 584 performers who dazzled our guests in 2014, but the memories created were immeasurable.

10 NATIONAL RECORDING ARTISTS



For the last few summers, The Freeman Stage at Bayside is occasionally transformed into something that resembles Madison Square Garden. Tour buses pull into town, rows of seats are placed on the lawn, and concert t-shirts are pulled from attics. When National Recording Artists perform at The Freeman Stage at Bayside, it's a completely different experience for our audience. In 2014, we presented 10 National Recording Artists—Bruce Hornsby, Aaron Neville, Big Bad VooDoo Daddy, Wynton Marsalis and the Lincoln Center Jazz Orchestra, Barenaked Ladies, Dave Mason's Traffic Jam, The Beach Boys with John Stamos, Firefall, Jennifer Nettles, and David Nail. Each artist brought their own distinctive style, personality, talents, and audience to our small Sussex County stage. We are proud and honored to be able to present such talent to our community, and hope to continue the tradition for years into the future. The Freeman Stage at Bayside isn't a local secret anymore...it's become a destination.

2014 was a record breaking year in several ways, with attendance being one of them. Over 50,000 patrons enjoyed our performances, and they traveled from near and far to do so! Attendees from 30 states purchased tickets for shows in 2014. We saw couples enjoy date nights under the stars. Families, small and large, came together to create everlasting memories. Local organizations brought out their members for a night of fun. We take pride in the fact that The Freeman Stage at Bayside continues to be a welcoming place for our patrons to enjoy.

2014 in review

14,306 OUTREACH IMPACTS



The most important goal of our organization is to provide inspired arts education for all. In 2014, we were lucky enough to have over 14,000 chances to do so with our outreach guests. Students from over 20 area schools were able to either be guests at The Freeman Stage at Bayside for a performance, or we brought the arts to their schools or other area locations such as Delaware Technical Community College. Whether it was participating in a mural project, or joining the Washington National Opera on stage, we created experiences that had impact.

3,718 VOLUNTEER HOURS

With a full time staff of only 6 employees in 2014, the Joshua M. Freeman Foundation relies on the time and talents of our dedicated volunteers to help us get the job done! Their tasks can range from ushering patrons to their seats at The Freeman Stage at Bayside, to washing out paint brushes for students at an outreach mural project. Our volunteer corps is over 100 members strong, and 15% of them have been with us for over 5 years. Their 3,718 hours of service in 2014 has a value of over \$75,000, but their service to our organization is truly priceless.

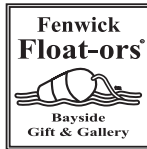
Each of these events is essential for raising funds, and awareness, for our young nonprofit organization.

LOOKING FORWARD

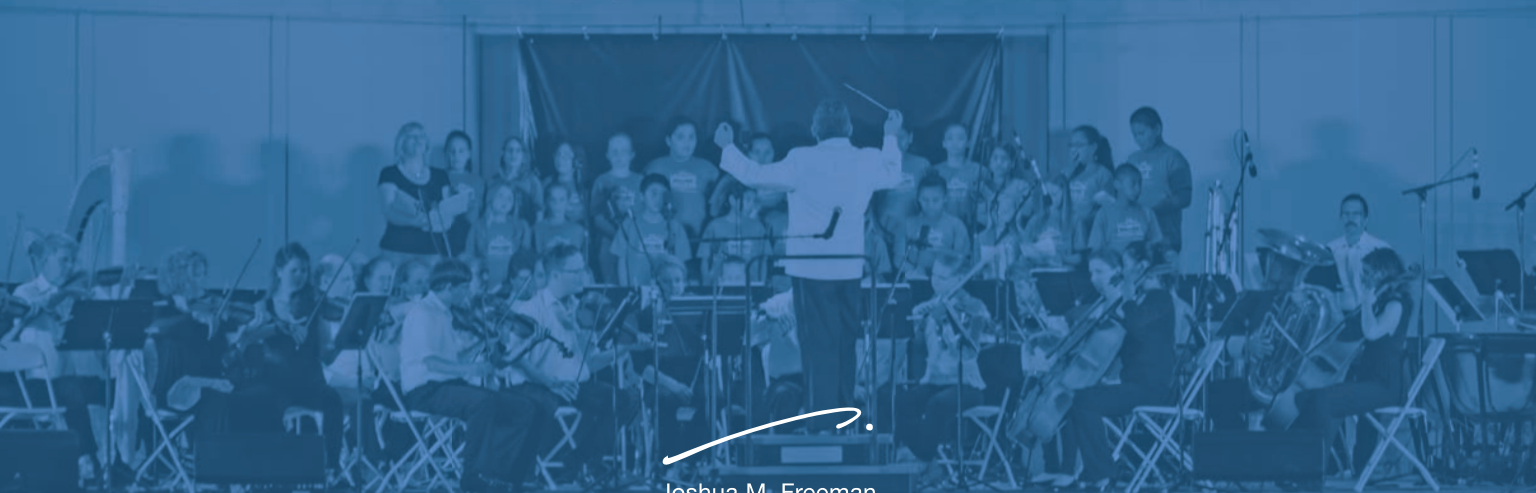
