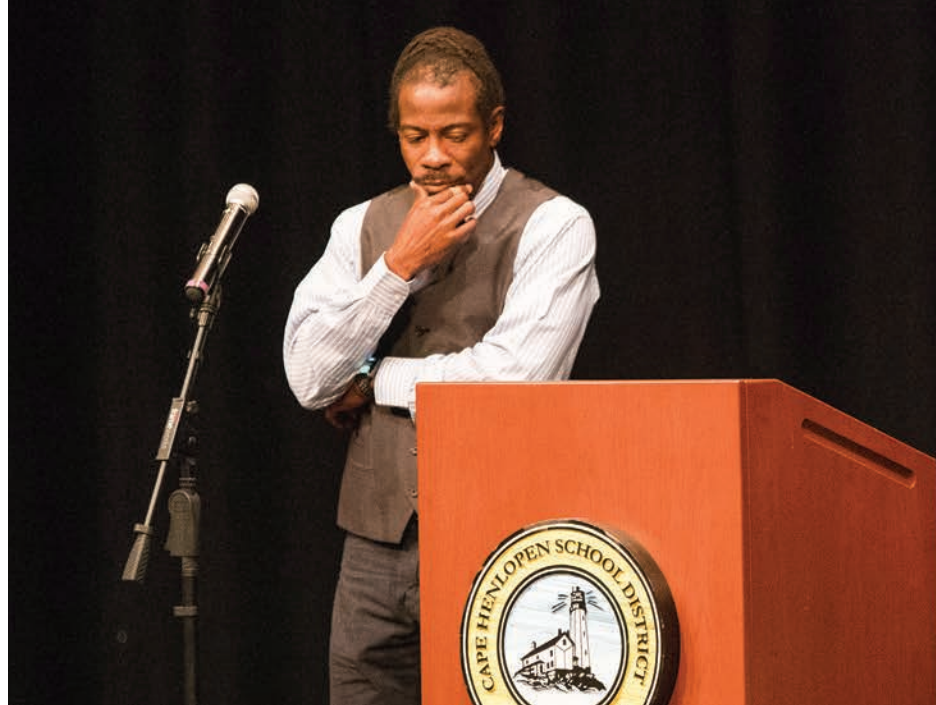

In 2017, 20,521 students from Maryland and Delaware participated in a variety of arts experiences through our Arts in Education program. This year, we completed our legacy mural project and have reached our goal of having a mural in all 12 middle schools in Sussex County and expanded our high school poetry program, which we introduced in 2016, to include a writing workshop. Through 72 programs, students from elementary to high school were able to have a variety of arts experiences they might not have had otherwise. As we continue to create opportunities to elevate the human spirit and enrich lives, we look forward to continued growth to our Arts in Education program.

Our Volunteer Program continues to be a bright spot within our organization as it not only attracts more participants, but also is a huge reason we're able to further our mission at The Freeman Stage and in schools. In 2017, our volunteer corps grew again to over 240 dedicated individuals who contributed nearly 13,000 hours of service. In 2017 alone, their donated time had a value of \$288,585 (based upon the Independent Sector rate of Delaware)! Though the duties of a volunteer may not always be glamorous, we are truly thankful for their commitment and hard work.

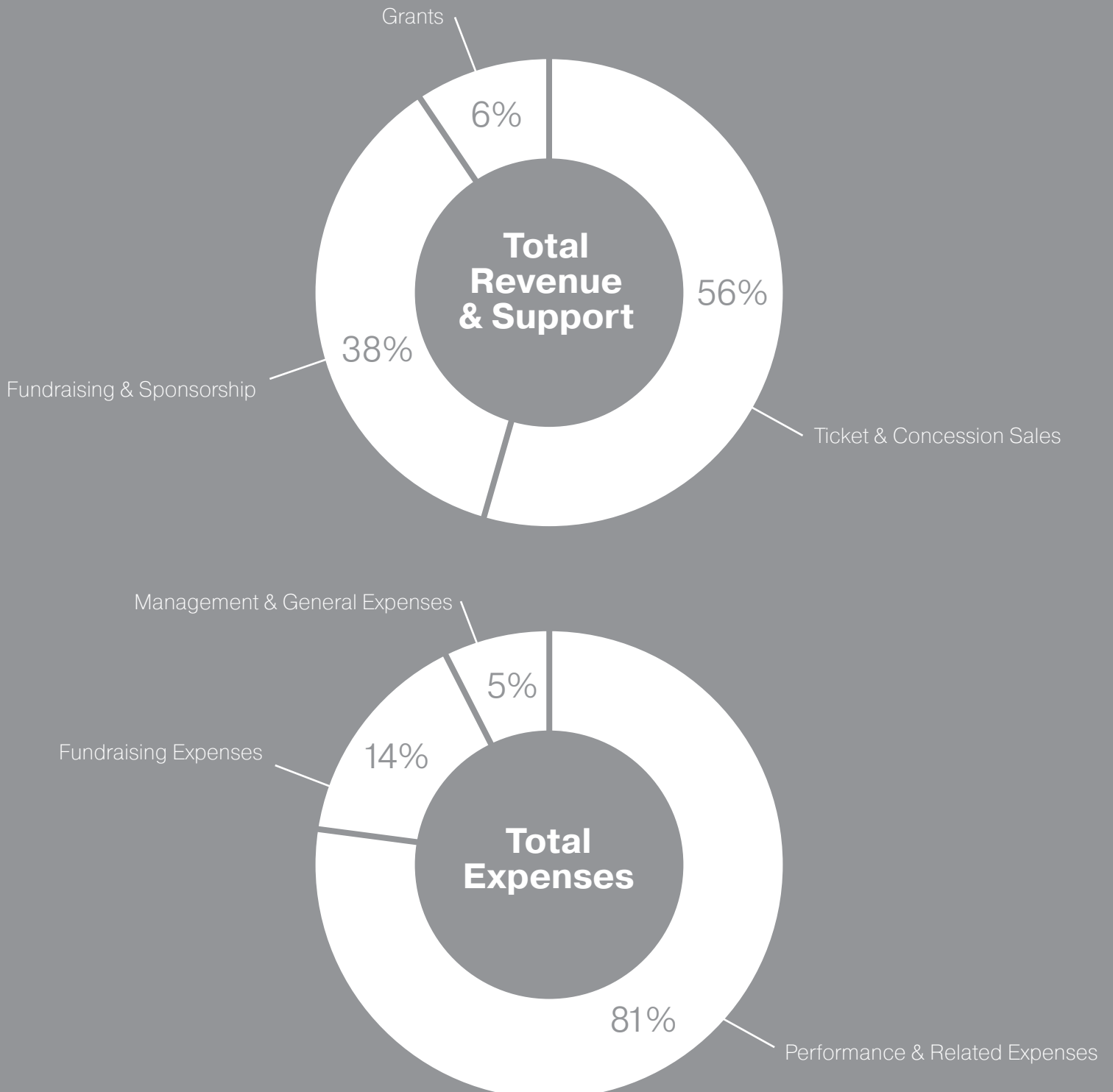
