

## **DOUBLE MUGGING RELEASE FORM**

RELEASOR agrees to indemnify the RELEASEES and each of them from loss, liability, damage or cost they may incur due to the presence of RELEASOR in or upon the areas where the DOUBLE MUGGING activities will take place, whether caused by negligence of the RELEASEES or otherwise.

RELEASOR hereby assumes full responsibility for the risk of bodily injury, death, or property damage due to the negligence of the RELEASEES or otherwise while in or upon the areas where the REDNECK RELAY activities will take place and while participating in the DOUBLE MUGGING activities.

RELEASOR expressly agrees that this release, waiver, and indemnity agreement is inclusive to be as broad as inclusive as permitted by the laws of the State of Wyoming and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. RELEASOR expressly understands that the DOUBLE MUGGING involves an inherent risk of injury to oneself and to others. RELEASEES are not liable for the injuries to those who participating in the DOUBLE MUGGING activities, or that are caused by watching the DOUBLE MUGGING activities.
