# Figure 8 Races Waiver

IN CONSIDERATOIN of being permitted to enter for any purpose the RESTRICTED AREA (Herein defined as the area to which admission to the general public is prohibited), the undersigned, for themselves, and personal representatives, heirs, and next of kin:

1. HEREBY RELEASES, WAIVES LIABILITY, DISCHARGES AND CONVENANTS, NOT TO SUE, Fremont County, Fremont County Fair, Fremont County Fair Board, Fremont County Fair Staff, Town of Riverton, their officers and members, officials, car owners, drivers, participants, persons in the Restricted Area, promoters, sponsors, advertisers, owners and lessors of premises used to conduct the event, and each of the undersigned releases said RELEASES from all liability to the undersigned, their personal representatives, assigns, heirs and next of kin for all loss of damage, and any claim or demands therefore, on account of injury to the person of property or death of the undersigned, whether caused by the negligence of Releases or otherwise while the undersigned as in or upon the Restricted Area; and
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releases and each of them from any loss, liability, damage or cost they may incur due to the presence of undersigned in or upon the Restricted Area and whether caused by the negligence of the Releases of otherwise; and
3. HEREBY ASSUMES FULL RESPONSIBLITY FOR AND RISK of bodily injury, death and property damage due to negligence of Releases of otherwise while in or upon the Restricted Area; and
4. Each of the undersigned expressly agrees that the foregoing Release Waiver of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the state in which the event is conducted and that if any portion there is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
5. EACH OF THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF ALL LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no real representation, statements of inducement part from the foregoing written agreement have been made.
