The following are a few reminders:

All results are final at the end of the show. Any concerns must be expressed during the show. Only official time sheets will be used. NO videos, pictures, etc. will be considered. Stats and times must be reviewed during the show and concerns expressed at that time.

***Contestants not wearing mesh safety socks will be disqualified in all chopping events.

***Sixteen years and up can enter the Men's events. Sixteen – eighteen years must have parents or legal guardian permission signature on the A-B Waiver and Release Liability Form.

- ***Super Master's contestants must be 68 years old at the time of the event.
- ***Log for Log Roll Contest will be 135 BFx16 ft. log.
- ***Blocks will be given out near the track.
- ***Trees will be assigned by random draw in this order: Super Masters, Masters and Women.

***Partners that are selected by the qualified contestants for the Log Roll and Crosscut Saw event must also be a qualified contestant.

***Jack and Jill partner does not have to be qualified but can only compete as a partner.

***WE ARE BRINGING BACK THE TEA BOIL AS AN EVENT BY A RANDOM DRAW. PLEASE INDICATE ON THE REGISTRATION FORM IF YOU WOULD LIKE TO BE CONSIDERED.

Please submit the completed registration form, \$35 entry fee made payable to Fryeburg Fair, **W9 FORM AND INSURANCE WAIVER** that are enclosed to the address listed below on or before <u>August 31, 2023</u>.

We recommend that you submit your application early to be sure you are considered as a contestant. The number of contestants is limited to 100. The order of acceptance will be determined by the postmark date of your envelope. The participant confirmation letter and passes will be sent out September 1, 2023.
