RV Reservations & Policies for the Georgia National Fairgrounds & Agricenter

*** SECURITY CAMERAS ARE IN USE***

- 1. Reservations can be made 24/7 at www.GNFA.com
- 2. RV sites will be assigned by reservation date and the current conditions of the grounds.
- 3. GENERATORS IN RV PARK & TENT CAMPING ARE PROHIBITED.
- One additional vehicle is allowed at RV site. Guests or additional vehicles must park in designated areas. DROP
 TRAILERS ARE NOT ALLOWED IN RV SITES.
- 5. "Full hookups" include water/electricity. Some sites include sewage. A dump station is located east of the Covered Horse Arena.
- 6. IF YOU HAVE SEWER AT THE SITE, THE "HONEY WAGON" WILL NOT PUMP YOU.
- 7. ALL RV'S MUST BE PARKED BUTT TO THE BOX.
- 8. **LEASH LAW ENFORCED:** Pets allowed (**NO PETS DURING THE GEORGIA NATIONAL FAIR**) and must be on a maximum 6' leash. Pets must be always under the control of the owner. Bathing pets in restrooms & showers are prohibited. No Pets in Livestock areas while livestock is present.
- 9. A VALID DRIVERS LICENSE is required to operate motorized vehicles of any kind i.e., cars, trucks, 4 wheelers, golf carts, motorcycles, electric bicycles, etc. Absolutely no motor vehicles in barns, ADA scooter exception. Reckless use of motor vehicles will result in suspension from the grounds. (NO VEHICLES INCLUDING BICYCLES DURING THE GEORGIA NATIONAL FAIR. This is a zero-tolerance policy. If caught breaking this, you will be asked to leave the property.
- 10. Obey all posted signs & 15 MPH speed limit.
- 11. Hover boards, Segway type transportation, roller blades, roller skates, skateboards, scooters, and similar mechanical equipment ARE PROHIBITED. This is a zero-tolerance policy. If caught breaking this, you will be asked to leave the property.
- 12. Ground fires are prohibited. Campfires are okay in a self-contained off the ground pit. Any outdoor grilling must be done on a self-contained grill.
- 13. An adult **MUST** supervise children riding bicycles. Bicycles are prohibited in barns & surrounding loading zones.
- 14. Consumption or use of alcoholic beverages or intoxicants is unlawful in any public use areas without proper permits.
- 15. Vehicles parked in the fire lanes, loading zones, RV sites, and handicapped sites or outside designated parking areas will be towed at owner's expense.
- 16. All refund requests must be received prior to the last day of departure. There is a one-night non-refundable fee on all cancellations.
- 17. GNFA reserves the right to refuse occupancy.
- 18. Check out is noon on the last day of the scheduled stay unless otherwise stated.
- 19. NO livestock in RV sites. Horses should not be tied out in RV areas for an extended period. Temporary horse pens of any kind are prohibited.
