2024 ELIGIBILITY RULES

Eligibility will be handled directly between the GCF&R, Ag Instructors, Galveston County Extension Agents and the Schools. Forms will not be released to 4-H Leaders, Youth Exhibitors/Participants or Parents.

Eligibility for ALL shows/events/contests which require eligibility status will be handled in the following manner:

- 1. An eligibility list of all youth exhibitors/participants will be provided by the GCF&R to the respective Ag Instructor or the Galveston County Extension Agent. All public, private and home schools will be contacted for Eligibility status
- 2. The Ag instructor will send the <u>FFA Eligibility List</u> to the school officials for the exhibitors/participants from their Chapter. The Ag instructor will then send the completed list directly to the GCF&R. This list will be kept on file in the Fair Office.
- 3. The Galveston County Extension Agent will send the <u>4-H Eligibility List</u> to the School Officials for all of the 4-H exhibitors/participants. The Galveston County Extension Agent will then send the completed list directly to the GCF&R. This list will be kept on file in the Fair Office.
- 4. The GCF&R will send eligibility for participation in Senior Citizens Day, Special Kids Day & Schools Day. The school officials will send the completed list directly to the GCF&R. This list will be kept on file in the Fair Office.
- 5. All <u>ineligible</u> exhibitors/participants will be immediately notified by the Ag Instructor, the Galveston County Extension Agent or the GCF&R.
- 6. Discrepancies with eligibility status must be resolved between the exhibitor, the exhibitor's parent(s)/guardian(s), and the designated school officials as soon as possible.
- 7. Any change resulting from a discrepancy in eligibility status must be documented in writing and relayed only by the designated school officials to the GCF&R *PRIOR TO CHECK-IN (LIVESTOCK, YOUTH PROJECT SHOW & AG MECHANICS) OR ELIGIBILITY DEADLINE (EVENTS/CONTESTS)*.
- 8. ANY FAILURE TO COMPLY WITH ANY APPLICABLE GCF&R RULES MAY RESULT IN DISQUALIFICATION FROM PARTICIPATION IN THE GALVESTON COUNTY FAIR & RODEO, INC. FOR THE YEAR IN WHICH THE VIOLATION OCCURS AND THE EXHBITOR WILL FORFEIT ALL AWARDS AND/OR PROCEEDS. THE EXHIBITOR WILL ALSO BE DISQUALIFIED FROM PARTICIPATING IN THE 2025 FAIR.
- 9. These rules apply to all applicable shows/events/contests which require eligibility status. An absence from school will be requested by GCF&R for those youth who are assisting with Senior Citizen's Day, Special Kid's Day, and/or Schools Day. All other requested absences in regards to participation under FFA must be addressed to the exhibitor's respective Ag Instructor and in regards to participation under 4-H must be addressed to the Galveston County Extension Agent.

Fair officials reserve the right to change the rules, dates, times and places due to unforeseen circumstances.
