Rules:

1. Ages 3 to 7 - Contestant must not weigh more than 60 lbs.
2. Long sleeves required
3. Must wear pants
4. Closed toed shoes
5. Helmet and vest **MUST BE WORN** (we can provide helmet and vest)
6. If the Mutton Bustin' Chairperson determines that a child is emotionally and/or physically unable to safely ride and there is a legitimate concern of serious injury to the child and/or sheep, then the said Chairperson reserves the right to disallow the ride. **The decision of the Chairperson is final.**
7. Only the contestant gets in free. **Parents and all other spectators will have to pay the gate admission.**
8. **NO REFUNDS** for any reason.
9. Only one parent/guardian is allowed in the arena area with their child. *WARNING: There is an inherent risk of injury or death when farm animal activities are held. The Parent/Guardian voluntarily assumes all risks related to this event and the Galveston County Fair & Rodeo shall not be held liable for the health and safety of the parent/guardian.* The parent/guardian must sign a waiver when checking in their child for this event or child will not be able to participate and no refunds will be issued.

I AM AWARE THAT MY CHILD IS VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER AND RISKS INVOLVED AND I AGREE TO ASSUME ANY AND ALL RISKS OF BODILY INJURY, HARM, DEATH OR PROPERTY DAMAGE, WHETHER THOSE RISKS ARE KNOWN OR UNKNOWN.

I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any of the matters covered by the foregoing release.
