- 1. Ages 3 to 7 Contestant must not weigh more than 60 lbs.
- 2. Long sleeves required
- 3. Must wear pants
- 4. Closed toed shoes
- 5. Helmet and vest **MUST BE WORN** (we can provide helmet and vest)
- 6. If the Mutton Bustin' Chairperson determines that a child is emotionally and/or physically unable to safely ride and there is a legitimate concern of serious injury to the child and/or sheep, then the said Chairperson reserves the right to disallow the ride. **The decision of the Chairperson is final.**
- 7. Only the contestant gets in free. Parents and all other spectators will have to pay the gate admission.
- 8. **NO REFUNDS** for any reason.
- 9. Only one parent/guardian is allowed in the arena area with their child. WARNING: There is an inherent risk of injury or death when farm animal activities are held. The Parent/Guardian voluntarily assumes all risks related to this event and the Galveston County Fair & Rodeo shall not be held liable for the health and safety of the parent/guardian. The parent/guardian must sign a waiver when checking in their child for this event or child will not be able to participate and no refunds will be issued.
