- 1. Tiny Mister and Tiny Miss contestants must be ages 3 5 as of the date of the contest. Lil' Mister and Lil' Miss contestants must be ages 6 years 2nd grade as of the date of the contest.
- 2. An Indemnity Form must be submitted with the entry form. Failure to do so will result in the disqualification of the contestant.
- 3. A link to a questionnaire will be sent to the parent. A recent photograph of the contestant must be emailed before Monday, April 1, 2024. The questionnaire information and photograph will be published in the program for this show.
- 4. Tiny and Lil' contestants may ride in the Parade which will be held on Saturday, April 6, 2024. Contestants will assemble at 9:00 a.m. at the VFW Post 5400 Parking Lot, Hwy 6 in Santa Fe and the parade will start at 10:00 a.m. All contestants will ride on one float. Western Wear will be the attire for the parade. The theme of the parade will be "Springtime on the Ranch". We will need volunteers to pull the float and decorate.
- 5. The contestant's parent(s) or guardian(s) agree with the Galveston County Fair & Rodeo, Inc. that the contest is for the purpose of extending an opportunity for the contestants to participate in a good experience and fun event. Each contestant is expected to act properly and to present a good image.
