# Health Requirements

## General Requirements

- No livestock will be allowed entry onto the show grounds without the proper health records and tests required.
- A veterinarian, Georgia Department of Agriculture personnel or other qualified person may be present to examine all livestock prior to exhibition.
- An official Certificate of Veterinary Inspection must show proof of the requirements for the appropriate species.
- ***No livestock will be allowed entry onto the show grounds with visible warts or visible ringworm lesions.***
- ***Livestock may be inspected at the show facility for infectious and contagious diseases and those suspected of having disease will be removed from the show facility. If suspected animals are not removed from or return to the show facility, all of the exhibitor's entries will be disqualified.***

## Certificate of Veterinary Inspection Requirements

All animals being exhibited in any type of livestock show (local, county, area, district, or state) must have an official certificate of veterinary inspection (health certificate). The certificate of veterinary inspection must be issued within 30 days of the exhibition with the following exceptions:

**Certificate of Veterinary Inspection exceptions will be the following:**

1. For Georgia cattle, swine, goats and exotic animals exhibiting in Georgia 4-H and FFA shows, the certificate of veterinary inspection and required tests shall be valid for 4 months (unless specified otherwise by show management).
2. For Georgia sheep exhibiting in Georgia 4-H and FFA shows, a certificate of veterinary inspection must be issued by a veterinarian and must be updated and signed every 30 days during the show season (up to 4 months) by a veterinarian, county extension agent or vocational agriculture teacher. The examiner must sign and record the following statement on the certificate: "to the best of my knowledge, the animals being exhibited are free from any clinical signs consistent with those of foot rot, scabies, contagious ecthyma (sore mouth), cutaneous fungal lesions, scrapie or any other infectious or contagious disease."
3. Georgia equine participating in Georgia Equine Shows will not require a certificate of veterinary inspection. (See complete Equine Requirements)

***\*\*Certificate of veterinary inspection is required on all market hogs at the Georgia National Fair as there will be breeding hogs on the premises. No livestock will be allowed entry onto the show grounds without the proper health records and test required. \*\****

# Farm Animal Livestock Requirements

## I. CATTLE

### A. Brucellosis

1. Georgia cattle have no brucellosis test requirements.
2. Out-of-state cattle must satisfy Georgia import requirements for Brucellosis. (Regulations are contingent on state of origin: call (404) 656-3667 for current regulations).

### B. Tuberculosis

1. DAIRY CATTLE - All dairy cattle six (6) months of age and older must have a negative TB test within sixty (60) days of shipment - REGARDLESS OF THE STATUS OF THE STATE OF ORIGIN (This does not apply to Georgia Cattle).
2. BEEF CATTLE - Beef cattle originating from a TB free state do not require a TB test. Beef cattle from the following states will require a negative TB test if six (6) months of age or older within sixty (60) days of shipment: California, Michigan, New Mexico, and Minnesota.

## II. SWINE

### A. Georgia swine:

1. All breeding swine 4 months of age and over must have a negative Brucellosis and a negative Pseudorabies test within 30 days of exhibition except:
  - a) Swine originating from a validated Brucellosis free herd and a qualified Pseudorabies free herd. Validation and qualification numbers and date of last test conducted must be recorded on the certificate of veterinary inspection.
2. Market swine:
  - a) Gilts must have a negative brucellosis and a negative pseudorabies test within 30 days of exhibition unless originating from a validated brucellosis free herd and a qualified pseudorabies free herd. Validation and qualification numbers and date of the last herd test must be recorded on the certificate of veterinary inspection.
  - b) Barrows must have a negative pseudorabies test within 30 days of exhibition unless originating from a qualified pseudorabies free herd. Qualification number and date of the last herd test must be recorded on the certificate of veterinary inspection.
  - c) Slaughter swine may be exempt from the certificate of veterinary inspection and the test requirements if they qualify under the "Certificate of Veterinary Inspection Exceptions" section described above.

- B. Out-of-state swine must enter on a certificate of veterinary inspection issued within 30 days of entry with the entry permit number and individual identification recorded. Test requirements for breeding swine and market swine are the same as "Georgia swine" requirements above.

**NOTE:** Swine purchased and/or removed from the farm of a validated/qualified herd loses validated/qualified status at the time of transfer and will require the appropriate tests prior to exhibition.

- C. Any exhibition of out-of-state swine must have an entry permit number from the Dept. of Agriculture. (Call (404) 656-3667 Monday through Friday 8:00 am - 4:30 pm).

## III. SHEEP

- A. Georgia and out-of-state sheep must enter on a certificate of veterinary inspection issued within 30 days of the exhibition. All sheep, except wethers, must be identified with USDA approved individual animal identification to the flock of origin. Those sheep born after 1/1/02 must be identified to the flock of birth and flock of origin if different. This information must be recorded on the certificate of veterinary inspection. The following statement must be recorded on the certificate of veterinary inspection for all sheep including wethers: "To the best of my knowledge, the animals being exhibited are free from any clinical signs consistent with those of footrot, scabies, contagious ecthyma (soremouth), cutaneous fungal lesions, scrapie or any other infectious or contagious disease."
- B. For Georgia 4-H and FFA sheep, see CERTIFICATE OF VETERINARY INSPECTION REQUIREMENTS above.
- C. *Sheep may be inspected at the show facility for infections and contagious diseases and those suspected of having disease will be removed from the show facility.*

## IV. GOATS

- A. Georgia and out-of-state goats must enter on a certificate of veterinary inspection issued within 30 days of the exhibition. All goats, except wethers, must be identified with USDA approved individual animal identification to the flock of origin. Those goats born after 1/1/02 must be identified to the flock of birth and flock of origin if different. This information must be recorded on the certificate of veterinary inspection. The following statement must be recorded on the certificate of veterinary inspection for all goats including wethers: "To the best of my knowledge, the animals being exhibited are free from any clinical signs consistent with those of foot rot, scabies, contagious ecthyma (soremouth), cutaneous fungal lesions, scrapie or any other infectious or contagious disease."

- B. For Georgia 4-H and FFA goats, see CERTIFICATE OF VETERINARY INSPECTION REQUIREMENTS above.
- C. Goats may be inspected at the show facility for infectious and contagious diseases and those suspected of having disease will be removed from the show facility.

## **V. EXOTIC ANIMALS**

- A. All exotic animals and all non-traditional livestock entering Georgia must be accompanied by an official Certificate of Veterinary Inspection identifying each animal with unique permanent individual identification.
- B. All llamas, alpacas and camels entering Georgia must be identified by a USDA approved metal ear tag, unique and individual tattoo, notarized photograph, or an electronic identification device (microchip). If electronic identification is used, the consignee is responsible for providing the appropriate reading device for verification. Castrated males are exempt from the individual identification requirements.

# General Rules and Regulations

**NOTICE:** All exhibitors are cautioned to read carefully the following rules and regulations, as they will be strictly enforced. The Georgia National Fair (GNF) will be held on the Georgia National Fairgrounds & Agricenter in Perry, October 5-15, 2023, unless postponed, or extended by the Georgia Agricultural Exposition Authority (GAEA), all of which they hereby claim and reserve the right to do from any cause whatsoever which they may deem necessary for the general good of all concerned.

## Administration of Rules and Regulations

The GNF reserves to the GAEA the final and absolute right to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions, and differences in regard there to, or otherwise arising out of or connected with or incident to the show, and the right to amend or add to these rules as its judgment may determine. An exhibitor who violates any of the following rules will forfeit all privileges and premiums and be subject to such penalty as the GAEA may order.

## Statement of Liability

1. All livestock exhibits will be under the direction of the GAEA, but the GAEA will in no case be responsible for any loss or damage that may occur. Each exhibitor will be solely responsible for any consequential or other loss, injury or damage done to, or occasioned by, or arising from, any animal or article exhibited by him/her and for its description as given in the catalog, and shall indemnify the GAEA against all legal or other proceedings in regard thereto, as well as damage or injury to any other person or property, caused by the exhibitor, or any of the animals exhibited by him/her, or arising out of, or in any way connected with such exhibition of any of the animals so exhibited.
2. The management reserves the right to remove from the grounds any exhibit, animal or fowl that may be falsely entered or may be deemed unsuitable or objectionable, without assigning a reason therefore, and if necessary, to return any money already paid for space or stalls, which shall exonerate them from any claim whatsoever on the part of the exhibitor or purchaser.

## Testing and Responsibility

3. **DRUGS & DIURETICS:** Administration of any drug of any kind or description internally or externally is prohibited, except for treating a recognized disease or injury as prescribed by a licensed veterinarian. For the purpose of these rules, the term "drug" shall mean: the sale, possession or use of any substance which is controlled by license under federal, state or local laws or regulations and any substance commonly used by the medical or veterinary professions which affect the circulatory, respiratory, or central nervous systems of an animal. The use of any *diuretic, tranquilizers or anti-inflammatory drugs* for any purpose whatsoever on any animal in the show is prohibited. Show management reserves the right to take blood, tissue, milk and/or urine samples for analysis. Any animal entered is subject to testing. The administration of any drug of any kind or description internally or externally for the treatment of a disease or injury must be done in accordance with regulations established by the United States Food and Drug Administration.
4. **EXHIBITOR RESPONSIBILITY:** The exhibitor shall be the absolute insurer of and shall be responsible for the condition of an animal exhibited at the Georgia National Fair Livestock competitions, regardless of the acts of a third party. Extent of knowledge on the part of the exhibitor with regards to the drugs or substance found in an animal is not relevant to any issue, and it shall not be a defense that person or persons unknown introduced the prescribed substance into the animal prior to, or at arrival, or after arrival on the Georgia National Fairgrounds property.
  - a. Any animal exhibited in any 4H/FFA Junior show being treated with a prescription or over-the-counter medication (the use of any diuretic, tranquilizers or anti-inflammatory drugs for any purpose whatsoever on any animal in the show is prohibited) that has not completed its recommended withdrawal time must be accompanied by an original, complete veterinary prescription. This prescription must be provided to management upon request at any time during the show and will be required at the time of residue testing if that animal is selected. The prescribed medication(s) must be approved for the use on the treated animal.
  - b. Should testing and inspection procedures used by the GNF reveal evidence of the presence of a foreign substance or any drug not medically necessary or not approved for such use by the Food and Drug Administration or United States Department of Agriculture, the exhibitor, a member of the exhibitor's immediate family or any other person shown to have had care, custody or attendance of the animal in any way, at the discretion of the Georgia Agricultural Exposition Authority, may be subjected to the penalties provided for in these rules.

5. **PENALTIES:** An exhibitor determined to have violated these rules or whose animal has been found to contain evidence of drugs as described in these rules may be subject to the following penalties at the discretion of the Georgia Agricultural Exposition Authority;
- a. Forfeiture of prize money;
  - b. Forfeiture of sale money;
  - c. Forfeiture of tiles, trophies, and awards
  - d. *Banned from future livestock competition at the Georgia National Fair and the Georgia National Junior Livestock Show.*
    - i. *The exhibitor will be banned from competing at future livestock competitions for all species at the Georgia National Junior Livestock Show and the Georgia National Fair for twelve (12) months or one complete show year (whichever is greater) from rule infraction. After the twelve (12) months or one complete show year (whichever is greater) suspension has been completed, the exhibitor will then be placed on probation for twenty-four (24) months or two show years (whichever is greater).*
    - ii. *During this probation period, management reserves the right to residue test any/all entries of the individual on probation that are entered at the Georgia National Junior Livestock Show and/or the Georgia National Fair. The exhibitor is responsible for full payment of costs incurred for any positive samples. Residue tests will be sent to a laboratory of show management's choice.*
    - iii. *If, at any time following the first ban, any **Junior 4H/FFA animal** shown by that exhibitor tests positive for any unapproved drugs, prohibited drugs, or drugs that are not under the prescription of a licensed veterinarian, the exhibitor will be banned from the Georgia National Junior Livestock Show and the Georgia National Fair for the exhibitor's junior show career.*
  - e. Subject to investigation by federal, state and local authorities for criminal prosecution.
  - f. *Violation of these rules may result in disqualification from other 4-H and/or FFA activities.*

*Refusal to submit animals for testing or to cooperate in completion of minimum testing requirements will result in disqualification and subject the exhibitor to the same penalties provided for exhibitors whose animals test positive for drugs.*

### **Eligibility for Entry**

6. Competition is open to the world unless otherwise stated in the special rules governing a particular department.
7. **CERTIFICATE OF REGISTRATION:** All animals in the breeding classes must be recorded in recognized books of record for their respective breeds. Exhibitors must produce certificates of registry at the request of the superintendent in charge.
8. **OWNERSHIP:** Exhibitors entering an animal in any name other than the name of the bona fide owner or owners or showing an animal in a class for which it is not eligible, may, at the discretion of the management, be barred from further showing, and any or all premiums previously awarded may be forfeited. Entries that have been erroneously entered will be transferred to their proper classes prior to judging. Animals owned in partnership may be entered in proper classes in one owner's name but must appear under this ownership in all classes entered.
9. **HEALTH REQUIREMENTS:** Health Certificates meeting requirements set forth under Health Regulations printed in the Premium List are required on all animals. Diseased animals are barred entry (at all times) into the Fairgrounds area. Superintendents are instructed and authorized to refuse unloading privileges to animals showing any signs or characteristics of disease. Inspectors will check health papers upon arrival.
10. **BREEDER AFFIDAVIT:** Barren animals will not be eligible for breeding classes; an affidavit that the animal is a breeder must be furnished on request.
11. If an exhibitor has been disqualified from competition in a major show or has had a premium withheld or withdrawn on the grounds of rule violation, misrepresentation, fraud, or deception, he/she will not be allowed to compete at the Georgia National Fair. In cooperation with the member shows of the North American Livestock Show and Rodeo Managers Association and the Rule Infraction Database, the Georgia National Fair reserves the right to refuse entry to any exhibitor.
12. To be eligible for entry, exhibitors and their livestock must meet and adhere to the requirements of Special Rules listed under the appropriate department or departments (in subsequent pages of this premium list).

### **Entries**

13. **ENTRIES AND ENTRY DEADLINE:** All livestock entries will be **ONLINE ONLY**. Entry deadline remains September 1st. All entries will be paid for through the online process, using a credit/debit card. There is a processing fee of \$1.50 per exhibitor. The Livestock show information can be found at [www.georgianationalfair.com](http://www.georgianationalfair.com) - Livestock - Livestock Competitions. *Please Note: Livestock Office hours are Monday through Friday, 7:00 am to 4:00 pm, and the office is closed*

*on Saturday & Sunday. If the entry deadline of September 1<sup>st</sup> falls on the weekend or a Holiday, there will be no one in the office to assist you. The deadline will not be extended.*

14. **ACCEPTANCE:** In all cases, the management reserves the right to reject, accept or accept conditionally, an application for entry, and does not guarantee space in the exhibition buildings.
15. **SIGNATURES:** By completing the online entry the exhibitor and parent/guardian acknowledges that he/she understands and will abide by the liability requirements and rules and regulations of the Georgia National Fair.
16. **SOCIAL SECURITY NUMBER REQUIRED:** Social Security number is required for premium checks.
17. **ENTRY FEES:**
  - a. Beef & Dairy Cattle..... \$20.00
  - b. Sheep, Swine, & Goats..... \$15.00
    - i. Entry fee includes the original bedding which will be in the stalls upon arrival of livestock.
18. **CANCELLATIONS OR CHANGES:** Must be made no later than *September 10.*
19. **REFUNDS:** There will be no refunds.
20. **SUBSTITUTE SHOWMEN:** Animal must be shown by owner. Substitute showman will be allowed if an exhibitor has more than one animal in a class. The substitute showman must be a 4-H or FFA member and must be approved by the show superintendent. If an exhibitor is unable to show his/her animal due to a disability, a substitute showman will be allowed to show for that exhibitor. The exhibitor with the disability must be present at the show-ring when the substitute showman and animal enter the ring. The substitute in all cases must be a 4-H or FFA member and the substitute must be approved by the show superintendent at the time of animal check-in. No adults other than officials of the show will be allowed in the show-ring. *(No substitute showman will be allowed to show in showmanship).*
21. **SUBSTITUTIONS (Open Shows ONLY):** Substitutions of animals will be allowed within the same breed and class and for the same exhibitor. In addition, one open substitution (out of class) will be allowed per exhibitor. Substitutions can be made only in the name of the original exhibitor. Exhibitors in breed shows without defined classes can substitute only an animal of the same sex with a birth date within 90 days of the entry being substituted. Exhibitors in these shows will also be allowed one open substitution (not the same sex and DOB not within 90 days).
22. **GROUP CLASSES:** All entries for group classes must be shown in their respective single classes. Animals to comprise a competitive group need not be named in application for entry, but exhibitors must indicate in which group class they expect to compete.
23. **JUNIOR & OPEN SHOW EXHIBITORS:** All animals shown in the Junior Show are eligible to show in the Open Show if applicable classes are available. If the Junior Exhibitor elects to show in the Open Show, he/she must abide by all the Open Show rules, including entry deadline, and must apply and pay entry fees for both shows. *Exception: Heifers showing in the Comm. Dairy Heifer Show are not eligible to be shown in the Purebred Show of the Georgia National Fair during the same year.*
24. **SHOW NUMBER:** Each entry in the Fair will be assigned a show number. This number will identify animals in the show and will correspond with the Official Livestock Catalog number and must be displayed properly when the entries are being judged.

### **Passes and Parking**

#### **25. JUNIOR EXHIBITORS**



- a. **Complimentary Livestock Admission Wristbands:** All participating exhibitors will receive three (3) wristbands and one (1) complimentary vehicle pass per family will also be provided. (Example: If a household has 2 participating exhibitors, you will receive a total of 6 wristbands and 2 vehicle passes, etc.). Additional passes must be purchased.
- b. **4-H and FFA chapters** with junior entries will receive complimentary Livestock Admission Bracelets and complimentary vehicle passes for Agents or Advisors.
- c. **All Livestock Admission Bracelets** must be put on when picked up and kept on until your stay with us is final, if for any reason these bracelets get lost or must be cut off, the exhibitor will be responsible for purchasing a replacement. All complimentary bracelets must be picked up at Livestock Credentials Office at the Livestock Gate to the Fairgrounds upon arrival.
- d. Additional bracelets/passes (quantities limited) may be purchased at the Livestock Credentials office. **Prices:** Armbands (2-day) - \$25, (4-day) - \$50, (season) - \$95, 1-day pass - \$15, Senior \$10, Vehicle pass - \$15
- e. **Every vehicle and every person must have a bracelet/pass to enter the gate. There will be no Vehicle or Trailer parking inside the gates. All vehicles with vehicle passes will be parked in a designated area outside the Livestock Gate of the Fair.** Vehicle passes are good only for parking vehicles in designated areas, not for entrance of driver or passengers. Parking spaces are limited, and a vehicle pass does not guarantee space.
- f. Livestock trailers may be dropped in designated areas without a vehicle pass. Any vehicle other than trailers must have a vehicle pass to enter and to park in designated areas.



g. All vehicles must be out of the barn areas by 8:00 am each morning.

26. **OPEN SHOW EXHIBITORS**

a. **Complimentary Livestock Admission Bracelets** are issued depending on the number of entries:

Number of Entries	Passes
1.....	1
2 - 3.....	2
4 - 5.....	3
6 or more.....	4

b. One complimentary vehicle pass will be issued per exhibitor.

c. **Open and Junior Show Exhibitors:** Exhibitors showing in both junior and open shows, when those shows are held within the same time period, will receive complimentary passes for the junior show only, not for both shows. When the junior and open shows are not held within the same time period, the exhibitor will receive passes for both shows.

27. No parking is permitted on the asphalt next to the barns.

28. **NONCOMPLIANCE:** Exhibitors not cooperating with security personnel or officials of the Show in all matters of policy, including parking, will have their entries canceled and will be ordered to remove their exhibit(s) from the grounds immediately.

29. **AGENTS/ADVISORS (4H & FFA): Must confirm their junior exhibitor's entries in order to receive their pass packets.**

30. If you are an exhibitor and you are reading these rules, please email "***I have read the rules***" to [livestock@gnfa.com](mailto:livestock@gnfa.com) by entry deadline to receive a GNFA hat. Please include your name, what you are showing and the date. Do not share this rule with anyone.

31. **IMPORTANT NOTICE TO EXHIBITORS:** On heavy attendance days the Georgia State Patrol will designate all gates on the Fairgrounds as exits only from approximately 9 pm until 11 pm. It is strongly suggested that you plan your entrance and exit times wisely with this information in mind.

### **Judges and Judging Procedure**

32. Policies of selecting judges and of determining judging systems rest solely with the management.

33. Judges will be familiar with all rules, regulations, and procedures of the Georgia National Fair.

34. The decision of the judges shall be final in all cases and no appeal will be considered except in cases of written protest. In cases where fraud, misrepresentation, error, or collusion is discovered after awards have been given, the Georgia National Fair management or such referee may be appointed may make a decision regarding final placement. Such cases may be appealed in writing to the Livestock Committee, from whose decision there will be no appeal.

35. If any exhibitor or his/her representative interferes in any way with the judges or shows disrespect to them, or to the Show, the management may withhold from such exhibitor any premium monies that may have been awarded, or take any other steps deemed desirable.

36. Judging will not be delayed for animals entering the arena late. Any exhibit not presented promptly at the scheduled time is barred from competition in the class. Protests that the judges overlooked exhibits will not be considered.

37. No one will be allowed to act as judge in the ring or class in which he/she exhibits or in which he/she may hold an interest.

38. Judges must not award a prize to an unworthy exhibit. It is the intent of the Georgia Agricultural Exposition Authority that no premium or distinction of any kind be given to any animal that is not deserving. In cases where only one animal is being exhibited in a class, the judge shall make his/her award in accordance with the merits of the animal being exhibited which may be either first, second, third, etc. Only first prize-winning animals are eligible to compete for championship honors.

### **Protests**

39. Protest against an award and/or eligibility must be made in writing to the Agricultural/Youth Livestock Director of the Georgia National Fairgrounds and accompanied by an affidavit and a deposit of \$50.00 within twenty (24) hours following the designation of such award. Any animal being protested must have been entered into the appropriate show and qualified to show before the protest will be accepted. In case the protest shall not be sustained, the deposit will be forfeited to the Georgia National Fair. The Livestock Superintendent will notify the exhibitor of the protested animal or article of such protest, and both parties shall then have ten (10) days in which to bring testimony in the case to be submitted to the Livestock Committee. The protested award will be held in abeyance until final action of the Georgia Agricultural Exposition Authority.

40. No other protest will be considered by the Livestock Committee.

## Care of Animals, Stalls and Pens

41. **ANIMAL WELL-BEING:** Management reserves the right to remove any exhibitor from the grounds who is deemed to be mistreating any animal.
42. **CONTROL:** All animals exhibited at the Georgia National Fair must be halter broke or broke appropriate for the species.
43. **BEDDING:** The official bedding of the Georgia National Fair is wood shavings or pellets. All beef entries in the Junior and Open shows will be required to use wood shavings or pellets in the barn. The first bedding is provided, and additional chips can be purchased on site. Absolutely **NO** exceptions to this rule. Violators will forfeit all premiums won. Junior and Open Dairy and Llama exhibitors will be allowed to use straw on top of the existing wood shavings. Wood shavings must not be removed from stalls.
44. **BEDDING SALES:** Shavings and pellets will be available on the Fairgrounds at reasonable prices. Straw will be allowed in the outside tie-outs only, except where otherwise specified. Hours and location for purchase of bedding will be posted.
45. **TIE-OUTS:** Cattle may be tied out after 8:00 pm each evening in areas designated by management. Outside tie space is available on a “first come, first served” basis. Cattle are only allowed in tie-out areas. Exhibitors are permitted to use any type of bedding they so desire (natural products only) in the designated tie-out area. No equipment of any kind allowed, fans, generators, tents, etc. Pens may be set in the tie out area, but no electric fence is allowed in the tie out area. Panels are allowed to be set up as pens in tie outs for cattle. Maximum pen space is 12’x12’. Exhibitors are responsible for ensuring the pens/animals are secured. The GNF Show Management will monitor and remove panels if rules are not followed. Vehicles permitted for delivery of bedding and feed only. Vehicles must not be left unattended and are not allowed to park in the tie-out area.
46. All vehicles must be out of barn areas by 8:00 am each morning.
47. **SIGNS:** Livestock exhibitors are permitted to display a sign or banner over their exhibit advertising their own herd or farm. This sign or banner shall be of a reasonable size so as not to obstruct the view of other exhibitor’s signs or exhibits of livestock. Signs must not exceed 22 x 28 inches and may be used to advertise individual animals within an individual exhibit. The management reserves the right to have objectionable signs removed.
48. Posting of signs is not allowed outside the barns or in any area inside the barns other than in the exhibitor’s assigned spaces.
49. All owners and those in charge of property or livestock shall care for, guard, protect and preserve the same. The Georgia National Fair will not be responsible for any loss or damage.
50. **NO DOGS:** Are allowed on the Georgia National Fairgrounds during the Fair except service dogs and dogs participating in demonstrations and/or competitions.
51. All articles and animals for the exhibition must be in their places, with all rubbish and waste cleared away by 9:00 am each morning.
52. **ARRIVAL TIME:** All animals must be in the barn by the time and date specified in this book under individual shows.
53. **DEPARTURE TIME:** All animals must be out of the barn by 9:00 pm on the date of their release as specified in this book under individual shows. They may spend that night in the tie-outs but must be off the grounds by noon the following day.
54. **EARLY DEPARTURE:** Any animal on exhibition may not be removed from the grounds prior to its release time without a special order given by the Livestock Department. Any violation of this rule will cause forfeiture of all premiums earned by the exhibitor.
55. ANY EQUIPMENT BROUGHT IN TO BE USED IN YOUR STALL OR SPACE MUST COMPLY WITH AND BE USED IN COMPLIANCE WITH ALL FEDERAL, STATE, AND MUNICIPAL OCCUPATIONAL SAFETY AND HEALTH REGULATIONS.
56. **NO BUTT FANS ALLOWED:** No fans allowed in alleyways. All fans must be attached to tie panel in stalling area and cannot be attached by extension to hang beyond 42 inches from tie panel.
57. No demonstrators, trophies, decorations, portals, fountains, signs, banners (except as allowed in rule # 47), advertising matter or exhibits of any kind or character will be allowed in the aisles or public passageways or attached to the Show buildings’ walls, posts, or doors.
58. **TRIMMING CHUTES:** NO chutes allowed in the center aisle of cattle barn. Chutes & equipment outside of barn must be kept orderly. **No chutes on the Court of Honor (South side of Multi-Purpose Building).**
59. **BREED SHOWS:** Where breed shows are offered, breeds that do not meet the minimum requirements for that show for two consecutive years will no longer be offered a breed show. See individual show rules.



## Photographs

60. Exhibitors of Grand Champion and Reserve Grand Champion winners must make themselves and their animals available for the taking of official photographs and must remain at the Show until animals are released; those photographs are to become the property of the Georgia National Fair with copies made available on site for purchase by the exhibitors.
- a. *Failure to comply may result in premium monies being withheld.*

- b. Only the photographers displaying the badge of “Official Photographer” are authorized to take photos for resale on the Fairgrounds.

### **Premiums & Awards**

61. Premium checks will be mailed by the Georgia National Fair (except where otherwise stated) as soon as possible after the conclusion of the show.
62. *All premium checks issued by the Georgia National Fair are good for up to 90 days from the issue date on the check. Checks not cashed by that time will not be reissued. In the event that a premium check is lost in the mail, request must be made before this 90-day period has lapsed to have the premium check reissued.*

### **Notice to Exhibitors**

63. Exhibitors may spend the night inside the barns only to tend to lactating animals and must do so within their assigned stalling area or purchase additional stalling space, if available. No other camping is allowed in or around the barn areas.
64. In order to create a good public image and add to the attractiveness of the livestock area, all beds, cots, bedding, etc., should be stored out of sight by 8 am each morning.
65. No cooking is allowed inside or around the outside of the barns to comply with local fire codes. *Coolers are allowed.*
66. No Unauthorized ATVs, Golf Carts, Motorcycles or Bicycles allowed on the grounds. **The following are prohibited on the property known as the Georgia National Fairgrounds & Agricenter:**
- a. **Skateboards, Scooters, Roller Skates, Hover Boards, Roller Blades, and other similar mechanical equipment.**

# Georgia National Fair

## Junior Herdsman Award

The county/chapter exhibits will be judged each day of the Fair by judges who will be selected by Georgia National Fair management. The judges will be working independently of each other in evaluating the exhibits. There will be separate awards for beef, goat, swine, sheep, and commercial dairy heifers. County 4-H and FFA Chapters may combine their exhibits and be judged as one. Otherwise, they will be judged separately. **Each unit wishing to compete must sign up at the barn office upon arrival. Sign up deadline is at the close of check-in/weigh-in. No one will be allowed to sign up after the deadline.**

Criteria for selecting Herdsmen Award winners:

- 1. Appearance & Cleanliness** ..... 50% of points
  - A. Aisles must be kept clean. Feed and water pails should be neat, clean, and removed from stalls/pens when not in use.
  - B. Identification, such as stall cards, must be displayed.
  - C. Manure must be removed from stalls/pens and placed in appropriate containers (not in trash cans).
  - D. Additional decorations and county/chapter banner will count towards Herdsmen Award.
  - E. \* The use of neck ropes, matching ropes, mats under the front of cattle, and well-kept beds will count toward the Herdsmen Award. (\*for cattle only)
  - F. All county/chapter exhibitors dressed alike as a group will count toward the award.
  - G. Appearance of animals should be clean and well-groomed at all times.
- 2. Educational Value for General Public** ..... 25% of points
  - A. Any educational information concerning the species or breed being shown will count towards Herdsmen Award.
  - B. *No free-standing displays of any kind will be allowed. All educational information should be posted above pens or tie spaces.*
- 3. Conduct** ..... 25% of points
  - A. Someone from each county/chapter should be always present to man the county/ chapter exhibit area.
  - B. Cattle must be in the barn during the day when not being groomed or shown.
  - C. Courtesy to other exhibitors, spectators, and show officials will count toward the award. Roughhousing, foul language, and loud noises will count against display.

Each county/chapter is the ambassador for their community. Your actions are being judged from the time you come to the Agricenter until you return home. The county/chapter scoring the highest in each species over the duration of their stay at the Fairgrounds will be named the Superior Herdsmen and will receive an appropriate award.

2. **HEALTH CERTIFICATES:** Health Certificates meeting requirements set forth under Health Regulations printed in this Premium List and current Georgia Department of Agriculture regulations are required on all animals.
3. **ELIGIBILITY:** Exhibitors are eligible from the State of Georgia only. Classes open only to 4-H and FFA members 4<sup>th</sup> grade through 12<sup>th</sup> grade in school (and at least nine years old by entry deadline). No exhibitor who has graduated from high school is eligible to show in regular classes or in showmanship.
4. **SOCIAL SECURITY NUMBERS:** Will be required for premium checks.
5. **ENTRY DEADLINE:** All livestock entries will be **ONLINE ONLY**. Entry deadline remains September 1<sup>st</sup>. 6. No breed changes will be allowed after the entry deadline.
7. **REFUNDS:** There will be no refunds.
8. **SIGNATURES:** The online entry process has a place where you must agree to the rules, marking the check box will serve as required signature. There is an Advisors form that all 4H/FFA advisors are required to send in for their counties/clubs.
9. **NUMBER OF ENTRIES:** No more than four (4) market animals, steer &/or market heifer combined can be entered by any one exhibitor.
10. **OWNERSHIP:** Market Animals must have been owned by the exhibitor since September 1<sup>st</sup>, 2023. A description of the calf, including breed, birth date and tattoo number, must be listed. This is a feeder steer calf show and it is suggested that all calves be born on or after August 1<sup>st</sup>, 2022. The Show Committee reserves the right to mouth all steers for age. The exhibitor must maintain continuous full ownership, possession and provide daily care for the steer(s) from September 1<sup>st</sup>, 2023, to show time.
11. **IDENTIFICATION:** *Tattoo is required on all Jr. Beef Cattle. The tattoo number in the animal's ear must match the tattoo number on the entry form when the animal is weighed in or checked in. (Ear tag numbers are not accepted for tattoo number on entry form.)*
12. The GNF steer show will be structured so that divisions will be separated into breeds which will further be divided into classes based on weight. The Divisions will be composed of:
  - a. **Breed Divisions:** Any breed with a minimum of seven steers after check-in and classification will be considered a breed division. If a breed division does not make for 2 consecutive years, they will show in Crossbred.
  - b. **Crossbred Division:** This division will consist of calves of varying percentages of British and Continental breeds.



- c. Any breed division (including Brahman derivative) with less than seven steers will show in the Crossbred division.
- d. **Steer Classifications Guidelines:** Registration papers will not be considered in the classification process of entries.

13. **WEIGH-IN:** All steers will be weighed by show officials on Thursday, Oct. 5, between 5:00 pm and 7:00 pm. No reweighs after steers leave the scales. Class winners will not be reweighed.
14. **CHAMPIONSHIP:** The 1<sup>st</sup> and 2<sup>nd</sup> place Market animal in each class will compete for Grand Champion and Reserve Grand Champion of the respective breeds.
15. **SUBSTITUTE SHOWMEN:** Animal must be shown by owner. Substitute showman will be allowed if an exhibitor has more than one animal in a class. The substitute showman must be a 4-H or FFA member and must be approved by the show superintendent. If an exhibitor is unable to show his/her animal due to a disability, a substitute showman will be allowed to show for that exhibitor. The exhibitor with the disability must be present at the show-ring when the substitute showman and animal enter the ring. The substitute in all cases must be a 4-H or FFA member and the substitute must be approved by the show superintendent at the time of animal check-in. No adults other than officials of the show will be allowed in the show-ring. No substitute showman will be allowed to show in showmanship.
16. **CONTROL:** All steers must be halter broken. Animals that are unruly can be dismissed from the show-ring at the discretion of the judge or the show superintendent. Any steer that breaks loose from the exhibitor three (3) times while in the show-ring will be disqualified.
17. **FORCE FILLING OF STEERS/MARKET HEIFERS:** Force filling of steers/market heifers with any substance, water included, is prohibited. This includes the use of pumps, tubes, hoses, etc. Drenches are acceptable when using products to help the animal (example - electrolytes, calming, and bloat guards). Drench applicators must be 150cc/ml or less. All steers/market heifers must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves. No graphite, hair, cotton twine, etc. may be applied.
18. **ALL STEERS MUST BE DEHORND:** Any regrowth of horns should be rasped and made presentable for the show.
19. **FALSE TAILHEADS:** False tailheads and false switches will not be permitted. All steers/market heifers must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves. NO GRAPHITE MAY BE APPLIED.
20. No hair, cotton twine, etc. may be applied to the animal.
21. No nose tongs can be used in exhibiting cattle.
22. **STALLING:** All counties must stall 4H/FFA together. Stalling will be the responsibility of the barn manager; changes may be made at their discretion.
23. **BEDDING:** Wood chip bedding will be provided for the first bedding. No straw, sand or other material will be allowed in the beef barn complex.
24. **TACK AREAS:** Will be assigned on an available basis depending on the number of animals *actually checked in*.
25. **NECK ROPES:** Must be used for tying steers and provided by the participant.
26. Exhibitors must keep the part of the building occupied by them neat and attractive in appearance. Ribbons won at this, and other shows may be used to decorate the area. Paint or any other substance that will mar or deface the stalls WILL NOT be tolerated.
27. **NO BLOCKING CHUTES** will be allowed in the arena area.
28. **NO BUTT FANS ALLOWED:** No fans allowed in alleyways. All fans must be attached to tie panel in stalling area and cannot be attached by extension to hang beyond 42 inches from the tie panel.
29. **TIE-OUTS:** Cattle may be tied out after 8:00 pm each evening in areas designated by management. Outside tie space is available on a "first come, first served" basis. Cattle are only allowed in tie-out areas. Exhibitors are permitted to use any type of bedding they so desire (natural products only) in the designated tie-out area. No equipment of any kind allowed, fans, generators, tents, etc. Pens may be set in the tie out area, but no electric fence is allowed in the tie out area. Panels are allowed to be set up as pens in tie outs for cattle. Maximum pen space is 12'x12'. Exhibitors are responsible for ensuring the pens/animals are secured. The GNF Show Management will monitor and remove panels if rules are not followed. Vehicles permitted for delivery of bedding and feed only. Vehicles must not be left unattended and are not allowed to park in the tie-out area.
30. Market animals cannot be reloaded and/or transported on the grounds until that animal has completed showing. Once the animal has completed showing, it can be loaded and removed from the facility.
31. **PASSES:** Complimentary passes must be picked up at the Livestock Credentials Office at the Livestock Gate of the Fairgrounds upon arrival.

## Classification Terms:

- **Ideal Characteristics:** Characteristics in combination that most accurately represent the breed.
- **Acceptable Breed Characteristics:** Characteristics that represent the breed.
- **Discriminatory Breed Characteristics:** Characteristics that are not reason for absolute disqualification but in combination with other discriminatory visual characteristics could lead to disqualification.
- **Absolute Disqualifications:** Unfavorable visual characteristics resulting in removal from a breed division.
- **Considerations:** The following will be considered at the discretion of the classification committee: birthmarks or scarring (due to hot iron branding, freeze branding, or injury-caused discoloration).

# Breed Characteristics

## British Breeds

### *Hereford*

#### **Ideal Breed Characteristics:**

- Must physically exhibit breed characteristics of a purebred Hereford
- Red body with white face, white underline, and white-marked legs
- Feather neck
- Horned Herefords must be dehorned

#### **Acceptable Breed Characteristics:** (but not necessarily desirable; in combination may be discriminating)

- Dark red color
- Red neck
- Solid red or solid white ear
- Excess white on legs
- Excess white above the underline
- Freckling on face and nose
- Eye pigment
- Black hair in tail, ear or on rear end of animal
- Black spotting/smut or freckling on the nose
- Line back
- White above switch in tail
- White across rump above the twist

#### **Absolute Disqualifications:**

- Diluter color pattern
- Brindles
- Double muscling
- Any color pattern other than red or white (birthmarks excluded)

### *Angus*

#### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a purebred Angus
- Solid Black
- Polled

#### **Discriminatory Breed Characteristics:**

- Continental breed type structure or head
- Bumps where horns would be on a horned animal
- Birthmarks or white hair on the switch should be reviewed for the skin color (black skin color is acceptable; white or pink skin is a disqualification)

#### **Absolute Disqualifications:**

- White skin resulting in white hair above the underline or in the front of the navel (white on the navel is acceptable)
- White skin resulting in white hair on the leg, foot, or tail
- Horns or scurs
- Brindle
- Diluter color pattern
- Dehorning scars
- Double muscling



## ***Red Angus***

### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a purebred Red Angus
- English/British characteristics
- Polled
- Black pigmentation (animals may have two of three areas of black pigmentation on the nose, around the eyes, and on the anus, but not all three)
- A blond, light red, or mixed switch
- Black hair on the tail, muzzle, face, neck, and shoulder

### **Discriminatory Breed Characteristics:**

- Course joints or head (big feet, big dewclaws)
- Bumps where horns would be on a horned animal
- Solid white switch

### **Absolute Disqualifications:**

- Horns or scurs
- White above the underline or in the front of the navel
- White on the leg
- Black pigmentation (having all three areas of black pigmentation: on the nose, around the eyes, and on the anus)
- Diluter color pattern
- Dehorning scars or evidence of dehorning
- Double muscling

## ***Shorthorn***

### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a purebred Shorthorn
- Solid red; solid white with red hair or red pigment on ear, muzzle, or tail; or any combination of red and white, with the red and white color pattern bleeding together

### **Discriminatory Breed Characteristics:**

- Motley or brockle face
- Orange or light red color
- Black nose pigment
- Straight-line white markings across leg
- Coarse head
- Double muscling

### **Absolute Disqualifications:**

- Diluter color pattern, such as yellow or yellow roan
- Blacks, blue roans, or grays
- Brindle

## **Continental Breeds**

### ***Charolais***

#### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a 50% purebred Charolais
- White, yellow, gray, or silver (moderate dappling allowed)
- Expression of diluter gene
- Painting or spotting less than 20%
- Skunk tail, line back, baldy

#### **Discriminatory Breed Characteristics:**

- Excessive painting or spotting (over 20%)
- Double muscling

- Brindles
- Frail bone work and frail general appearance
- Light red color
- Short stubby head
- Overly refined, narrow head
- Excessive dark pigmentation (eyes, nose, ears, and anus)
- Excessive dappling

#### **Absolute Disqualifications:**



- Black, red, dark smuts
- Showing no diluter gene, unless solid white
- **Excessive painting or spotting (over 25%)**

### ***Chi-Influence***

#### **Acceptable Breed Characteristics:**

- Must exhibit Chi Influence in head (ear, eye, and nose) and skeleton
- Any shade of black, red, gray, or yellow
- Brindles, baldies, blaze faces, and motleys

#### **Discriminatory Breed Characteristics:**

- Coarse joints and skeleton
- Excessive spotting above the underline

#### **Absolute Disqualifications:**

- Appears to be a purebred of any other breed

### ***Limousin***

#### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a 50% purebred Limousin
- Solid black, red, light red, charcoal black, yellow, blonde
- Bald face

#### **Discriminatory Breed Characteristics:**

- Coarse joints, skeleton, and head
- Brindle
- **Pointed Poll**
- **White Switch**



#### **Absolute Disqualifications:**

- **Roans**
- **Stocking Legs**
- **Spotting above the underline**



### ***Maine-Anjou***

#### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a 50% purebred Maine Anjou
- Spotted, solid black, or red
- White stocking legs, white underline, and spotting above the underline and on the face
- Heavy skeletal structure

#### **Discriminatory Breed Characteristics:**

- **None**

#### **Absolute Disqualifications:**

- Appears to be more than 50% any other breed
- **Brindle**
- **Diluted Color Pattern**
- **Roan**



## ***Simmental***

### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a 50% purebred Simmental
- Larger, longer head
- Larger ear, lower set
- Solid black, red, light red, gray, smut, red and white, yellow and white, black and white
- Painting or spotting above the underline
- Stocking legs
- Bald, blaze, or streak face
- Diluter color pattern

### **Discriminatory Breed Characteristics:**

- Roans
- Skunk tail
- Double muscling
- 40% or more white above the underline
- Diluter color pattern around the eyes and muzzle
- Monkey mouth

### **Absolute Disqualifications:**



- Brindle
- Roans
- Skunk Tail

## ***Gelbvieh Balancer***

### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of a 50% purebred Gelbvieh
- Solid black, grey, yellow to gold, red
- Light skin pigmentation around the eyes and nose
- Diluter color pattern

### **Discriminatory Breed Characteristics:**

- Roans
- Double Muscling
- Brindle
- White skin resulting in white hair above the underline or in front of the navel (white on the navel is acceptable)
- White skin resulting in white hair on the leg, foot, or tail

## ***Brahman Influence***

### **Acceptable Breed Characteristics:**

- Must physically exhibit breed characteristics of *Bos indicus* influence
- Any color or color pattern
- *Bos indicus* head, eye and ear of moderate length, slightly drooping and opens down and forward
- Crest or slick neck
- Sheath score of 2 or more

### **Absolute Disqualifications:**

- A combination of a *Bos taurus* head, eye and ear

# Glossary

**Baldface** – white covers a majority of the face

**Blaze or Streak Face** – a wide strip of white down the face to the muzzle

**Bos indicus** – (zebu) subspecies of cattle, originating in Asia; have a prominent hump in front of the shoulder

**Bos Taurus** – subspecies of cattle, originating in west Asia but usually called "European"

**Brindle** – a streaking of black or brown on the body (tiger stripe)

**British / English** – originating in the British Isles; Angus, Hereford and Shorthorn are most numerous in the U.S.

**Brockle or Motley Face** – white spotting on the face

**Composite Other Breeds** – any percentage registered breed with less than seven (7) head present at the show (Low Percentage Simmental, Chi-Influence, and Charolais Record).

**Continental** – breeds originating in Continental Europe; sometimes called "Exotic"

**Dappling** – mottled or spotted markings

**Diluter Gene** – cattle that carry both copies of the gene will appear white. Non-diluter cattle will appear black or dark-red, while those that carry a single diluter gene will appear grey or yellow.

**Discriminatory** – characteristics that are not reason for absolute disqualification, but in combination with other visual characteristics could lead to disqualifications

**Horned** – horns are solidly attached to the skull or there is evidence of dehorning

**Painting** – large white markings covering a major portion of the body

**Pigmentation** – dark skin coloring on the point of the animal (eyes, nose, ears, anus, tail)

**Polled** – naturally hornless

**Purebred** – animal of known ancestry eligible for registry in a breed association

**Scurs** – horny tissue of rudimentary horn attached to skin and not the skull

**Sheath Score** – scoring system from 1-5 based on the length of the sheath (1 = little sheath and 5 = excess sheath)

**Smut** – grey color pattern

**Spotting** – white spots on the animal

1. Junior Show exhibitors must abide by all General Rules and Regulations printed in the beginning of this book.

3. **ELIGIBILITY:** Exhibitors are eligible from the State of Georgia only. The Livestock show information can be found at [www.georgianationalfair.com](http://www.georgianationalfair.com) - Livestock - Livestock Competitions. *Please Note: Livestock Office hours are Monday through Friday, 7:00 am to 4:00 pm, and the office is closed on Saturday & Sunday. If the entry deadline of September 1, falls on the weekend or a Holiday there will be no one in the office to assist you. The deadline will not be extended.*

Registration certificate must be made out in the exhibitor's name only. Farm name or family name will not be acceptable. Tattoos will be checked. No copies or duplication of the original registration certificate will be accepted. **Heifers that are entered as registered heifers, but which do not have a registration certificate or do not meet minimum percentage requirements per these rules at check-in, will not be allowed to show and will not be moved to the Commercial Class. Registration number must be included on the entry form. Registration will be checked on each Breed Association page prior to arrival and checked at check in. No pending papers will be allowed.**
11. **AGE:** Commercial heifers and registered heifers must be born September 1, 2021, and after.
12. **IDENTIFICATION:** *Tattoo required on all Jr. Beef Cattle. The tattoo number in the animal's ear must match the tattoo number on the entry form when the animal is weighed in or checked in. (Ear tag numbers are not accepted for tattoo number on entry form.)*
13. **BREED SHOWS:** There must be seven (7) heifers actually showing per breed division to make for a championship drive. If less than seven (7) heifers check-in, then they will show in "Other Breeds". If a breed division does not make for 2





consecutive years, they will show in “Other Breeds”. The Composite Other Breeds division which will include any percentage registered breed with less than 7 (seven) head present at the show (Low Percentage Simmental, Chi-Influence, and Charolais Record).

- a. **Simmental** – Registered Fullblood (Fleckvieh) Simmentals will have a separate breed show if there are seven (7) or more checked-in for the show. If there are less than seven (7) Fullblood (Fleckvieh) Simmentals, they will show in Composite Other Breeds. Registered percentage Simmentals will have a separate breed show if there are seven (7) or more checked-in for the show. If there are less than seven (7) registered High Percentage Simmentals, they will be combined with the purebred Simmental. Percentage Simmental heifers must be at least ½ Simmental genetics to compete in the High Percentage Simmental Show. Any registered Percentage Heifer that is less than ½ Simmental genetics will show in the Low Percentage division IF there are seven (7) or more head entered in the show. If there are less than seven (7) Low Percentage heifers, they will show in the Composite Other Breeds Division.
- b. **Limousin and Lim-Flex** – Registered Limousin must be orange papered and 75% or higher to compete in the Limousin Show. All Lim-Flex heifers must be purple papered and 25% or higher to compete in the Limousin Show. Limousin and Lim-Flex females will show together in one show.
- c. **Registered Shorthorn Plus** (those with green papers) – Will be shown separately from purebred shorthorns (those with red papers) provided there are at least seven (7) head check in at the show. If there are less than seven (7) registered checked in, they will show with the purebreds.
- d. **Charolais** – Only purebred Charolais will be allowed to compete in the Charolais Show

All Maintainer heifers must be Green papered and 1/4 - 5/8 Maine-Anjou to show in the Maine show. Maine Angus cattle must be Blue papered and 3/8 Maine-Anjou to 5/8 Maine-Anjou blood and have between 3/8 registered Angus to 5/8 registered Angus and/or registered Red Angus blood to show in the Maine show. High % Maine, Maintainer and Maine Angus females will show together in one show.
- j. **Composite All Other Breeds “COB”** – Is designed for composite (percentage breeds) with less than seven heads of heifers. We will follow breed composite recommendations set in the rulebook under Heifer Rules.

1. Junior Show exhibitors must abide by all General Rules and Regulations printed in the beginning of this book.
2. **HEALTH CERTIFICATES:** Health Certificates meeting requirements set forth under Health Regulations printed in this Premium List and current Georgia Department of Agriculture regulations are required on all animals. All sheep may be inspected at the show premises for foot rot, scabies, contagious ecthyma (soremouth) and cutaneous fungal disease. Those with lesions must be removed from the show facility and must not be placed in barns. Failure to remove these animals from the show facility will be grounds to disqualify all entries of that exhibitor.
3. **ELIGIBILITY:** Exhibitors are eligible from the State of Georgia only. Classes open only to 4-H and FFA members through the 12th grade in school (plus pre-club age children in grades 1 to 4 *and at least 6 yrs. of age by Sep. 1*) No exhibitor who has graduated from high school is eligible to show in regular classes or in showmanship. \*\*\* **Lambs in the State 4-H & FFA Program are not automatically entered in this show\*\*\***
4. **SOCIAL SECURITY NUMBERS:** Will be required for premium checks.
5. **ENTRY DEADLINE:** All livestock entries will be **ONLINE ONLY**. Entry deadline remains **September 1st**. All entries will be paid for through the online process, using a credit/debit card. There is a processing fee of **\$1.50 per exhibitor**. The Livestock show information can be found at [www.georgianationalfair.com](http://www.georgianationalfair.com) - Livestock - Livestock Competitions. *Please Note: Livestock Office hours are Monday through Friday, 7:00 am to 4:00 pm, and the office is closed on Saturday & Sunday. If the entry deadline of September 1 falls on the weekend or a Holiday, there will be no one in the office to assist you. The deadline will not be extended.*
6. **REFUNDS:** There will be no refunds.
7. **SIGNATURES:** The online entry process has a place where you must agree to the rules, marking the check box will serve as required signature. There is an Advisors form that all 4H/FFA advisors are required to send in for their counties/clubs.
8. **NUMBER OF ENTRIES:** A maximum of four (4) ewes per exhibitor will be allowed.
9. **OWNERSHIP:** Breeding Ewe must be the sole property of the exhibitor no later than September 1, 2023. The exhibitor must maintain continuous full ownership, possession, and provide daily care of the ewe(s) from September 1, 2023, until show day.
10. **IDENTIFICATION:** Commercial Ewes must have a State ear tag number listed on the entry form. This ear tag is for identification purposes only and can be any number the exhibitor chooses. Ear tag in ewe's ear must match number on entry form when ewe is checked in. STATE ear tags need to be purchased through your Agriculture Education Teacher or County Agent; no other tags will be accepted. If an animal loses a tag, notify the GNFA Livestock office, no later than 7 days after the tag is lost.
11. **CLASSES:** The Georgia National Fair reserves the right to change, combine, or delete classes with insufficient entries. Classes within a breed may be split and heats run at the discretion of the show management.
12. **MOUTHING:** The Show Committee reserves the right to mouth all ewes for age and ewe lambs must have their milk teeth.
13. **SHOWMANSHIP:** Each participant in showmanship must own the ewe they show, and ewe must be entered and checked into the show in regular classes. Showmanship classes may be split, and heats run at the discretion of show management. Awards and prize monies available for classes 1-3 only. Breeding Ewes will show separately from Market Lambs in showmanship.
14. **SUBSTITUTE SHOWMEN:** Animal must be shown by owner. Substitute showman will be allowed if an exhibitor has more than one animal in a class. The substitute showman must be a 4-H or FFA member and must be approved by the show

superintendent. If an exhibitor is unable to show his/her animal due to a disability, a substitute showman will be allowed to show for that exhibitor. The exhibitor with the disability must be present at the show-ring when the substitute showman and animal enter the ring. The substitute in all cases must be a 4-H or FFA member and the substitute must be approved by the show superintendent at the time of animal check-in. No adults other than officials of the show will be allowed in the show-ring. No substitute showman will be allowed to show in showmanship.

15. **CONTROL:** All ewes entered in the individual classes must be broken to handle and under control at all times. Pre-club exhibitors (grades 1-4) will be allowed to use halters on their ewes in the show-ring.
16. **FILLING OF EWES:** With any substance is prohibited. All ewes must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the wool and trimming of the hooves.  
*Exhibitor's choice, Ewes may be shown fitted or slick sheared.*
17. **BEDDING:** Exhibitors wishing to use bedding other than the wood chips that are provided must bring their own.
18. **TACK AREAS:** Tack and trimming areas will be assigned on an as available basis depending on the number of animals *actually checked in.*
19. Exhibitors must keep the part of the building occupied by them neat and attractive in appearance. Ribbons won at this, and other shows may be used to decorate the area. Paint or any other substance that will mar or deface the stalls WILL NOT be tolerated.
20. **TRIMMING STANDS:** No trimming stands will be allowed in the show arena area.
21. **PASSES:** Complimentary passes must be picked up at the Livestock Credentials Office at the Livestock Gate of the Fairgrounds upon arrival.

1. Junior Show exhibitors must abide by all General Rules and Regulations printed in the beginning of this book.
2. **HEALTH CERTIFICATES:** Health Certificates meeting requirements set forth under Health Regulations printed in this Premium List and current Georgia Department of Agriculture regulations are required on all animals.
3. **ELIGIBILITY:** Exhibitors are eligible from the State of Georgia only. Classes open only to 4-H and FFA members 4th grade through 12<sup>th</sup> grade in school (and at least nine years old by entry deadline). No exhibitor who has graduated from high school is eligible to show in regular classes or in showmanship.
4. **SOCIAL SECURITY NUMBERS:** Will be required for premium checks.
5. **ENTRY DEADLINE:** All livestock entries will be **ONLINE ONLY**. Entry deadline remains **September 1st**. All entries will be paid for through the online process, using a credit/debit card. There is a processing fee of **\$1.50 per exhibitor**. The Livestock show information can be found at [www.georgianationalfair.com](http://www.georgianationalfair.com) - Livestock - Livestock Competitions. *Please Note: Livestock Office hours are Monday through Friday, 7:00 am to 4:00 pm, and the office is closed on Saturday & Sunday. If the entry deadline of September 1 falls on the weekend or a Holiday, there will be no one in the office to assist you. The deadline will not be extended.*
6. **REFUNDS:** There will be no refunds.
7. **SIGNATURES:** The online entry process has a place where you have to agree to the rules, marking the check box will serve as required signature. There is an Advisors form that all 4H/FFA advisors are required to send in for their counties/clubs.
8. **NUMBER OF ENTRIES:** No more than three (3) commercial dairy heifers can be entered by any one exhibitor.
9. **OWNERSHIP:** The exhibitor must maintain continuous possession and provide daily care for the heifer(s) from September 1, 2023, to show time.
10. **IDENTIFICATION:** All commercial dairy heifers must be photographed and have a **STATE** ear tag at the time of entry. Tattoos are required on solid-colored calves only; however, they are highly recommended on all calves. A tattoo number need not correspond to an ear tag number. Tattoo/Ear Tag numbers and photograph must be included with entries.
11. Heifers should meet the following requirements to be eligible:
  - a. Heifers must be born between March 1, 2022, and August 1, 2023.
  - b. Commercial dairy heifers are dairy cattle offspring of mixed dairy or purebred dairy cattle parents.

- c. Heifers weighing less than 100 pounds, and more than 1,250 pounds will be disqualified.
  - d. All heifers must be dehorned. Heifers not dehorned will be disqualified. Any regrowth must be rasped and made presentable and should NOT exceed one (1) inch in length.
12. Heifers showing in the Comm. Dairy Heifer Show are not eligible to be shown in the Purebred Show of the Georgia National Fair during the same year.
  13. **CLASSES:** Heifers will be classed and shown by weight.
  14. **WEIGH-IN:** Heifers must be weighed in on Sat., Oct. 7, between 10:00 am and 1:00 pm. **NO REWEIGHS** after Commercial Dairy Heifers leave the scales.
  15. **SUBSTITUTE SHOWMEN:** Animal must be shown by owner. Substitute showman will be allowed if an exhibitor has more than one animal in a class. The substitute showman must be a 4-H or FFA member and must be approved by the show superintendent. If an exhibitor is unable to show his/her animal due to a disability, a substitute showman will be allowed to show for that exhibitor. The exhibitor with the disability must be present at the show-ring when the substitute showman and animal enter the ring. The substitute in all cases must be a 4-H or FFA member and the substitute must be approved by the show superintendent at the time of animal check-in. No adults other than officials of the show will be allowed in the show-ring. No substitute showman will be allowed to show in showmanship.
  16. **SHOWMANSHIP:** Each participant in showmanship must own the calf they show, and the calf must be entered and qualified to show in weight class. Showmanship classes may be split, and heats run at the discretion of show management. Awards and prize monies are available for classes 1-8 only.
  17. **COUNTY GROUP OF FIVE:** Must have at least three county groups exhibiting to pay premiums. Each county group must have at least three different owners represented. Entries are limited to two groups per county, made up of 4-H and FFA exhibitors.
  18. **CONTROL:** All heifers must be halter broken. Animals that are unruly can be dismissed from the show-ring at the discretion of the judge or the show superintendent. Any heifer that breaks loose from the exhibitor three (3) times while in the show-ring will be disqualified.
  19. **FILLING OF COMMERCIAL DAIRY HEIFERS:** With any substance is prohibited. All heifers must be shown in their natural conformation and structure without alteration by modification except for grooming.
  20. **BEDDING:** A wood chip bedding will be provided for the first bedding. *No straw, sand, or other material will be allowed in the Beef Barn.*
  21. **TACK AREAS:** Will be assigned on a space available basis depending on the number of animals entering the show.
  22. Exhibitors must keep the part of the building occupied by them neat and attractive in appearance. Ribbons won at this, and other shows may be used to decorate the area. Paint or any other substance that will mar or deface the stalls WILL NOT be tolerated.
  23. **PASSES:** Complimentary passes must be picked up at the Livestock Credentials Office at the Livestock Gate of the Fairgrounds upon arrival.

#### **NOTICE TO EXHIBITORS**

24. State 4-H & FFA rules do not allow junior exhibitors and/or their advisors/teachers to spend the night inside the barns. GNF rules allow spending the night in the barns only to tend to lactating animals and Commercial Dairy Heifers do not fall into this category.

1. Junior Show exhibitors must abide by all General Rules and Regulations printed in the beginning of this book.
2. **HEALTH CERTIFICATES:** All animals being exhibited at the Georgia National Fair must have a current health certificate issued within 30 days of the opening date of the Fair. Animals that have been calfhood vaccinated for Brucellosis or are from a certified and accredited herd need not be tested but must be accompanied by an official health certificate stating that they are vaccinated or from a certified and accredited herd. However, all animals must originate in herds with no history of Tuberculosis. **HEALTH PAPERS ARE A MUST TO UNLOAD AND SHOW.**
3. **ELIGIBILITY:** Entries are open to the world. Exhibitors must be FFA or 4-H members at the time of entry and must be at least nine years old by Sept. 1, 2023. Entries will also be accepted from youth who are members of a bona fide dairy cattle breed association and who are *at least nine (9) years old* and have not reached their 21st birthday by the date of the Fair.
4. **SOCIAL SECURITY NUMBERS:** Will be required for premium checks.
5. **ENTRY DEADLINE:** All livestock entries will be **ONLINE ONLY**. Entry deadline remains **September 1st**. All entries will be paid for through the online process, using a credit/debit card. There is a processing fee of \$1.50 per exhibitor. The Livestock show information can be found at [www.georgianationalfair.com](http://www.georgianationalfair.com) - Livestock - Livestock Competitions. *Please Note: Livestock Office hours are Monday through Friday, 7:00 am to 4:00 pm, and the office is closed on Saturday & Sunday. If the entry deadline of September 1 falls on the weekend or a Holiday, there will be no one in the office to assist you. The deadline will not be extended.* **ENTRY FEE:** No entry fee for the Junior Dairy entries.
6. **REFUNDS:** There will be no refunds.
7. **SIGNATURES:** The online entry process has a place where you have to agree to the rules, marking the check box will serve as required signature. Nonstudent exhibitors must produce a current, paid-up Junior membership card or other proof of membership for a breed association.
8. **OPEN SHOW:** Open and Junior shows will be judged separately. All animals entered in the Junior show are eligible to show in the Open Show if applicable classes are available. If the Junior Exhibitor elects to enter the Open Show, he/she must abide by all the Open Show rules and must apply and pay entry fees for both shows by the entry deadline.

9. **NUMBER OF ENTRIES:** Each exhibitor is limited to showing two (2) entries in each class except for the following classes which are limited to one (1) entry per exhibitor: class 9, Best Jr Female, and class 21, Best Sr Female.
10. **OWNERSHIP:** Registration papers must show ownership by exhibitor of all animals at least thirty (30) days prior to the opening date of the Fair. The exhibitor must provide daily care for the dairy cattle from the time of entry to show time. Leased animals or project animals owned by a college or school may be shown provided they meet the requirements of their respective states and National Breed Association. A copy of the lease agreement or affidavit indicating individuals with animal project responsibility must be included at check-in.
11. **CERTIFICATE OF REGISTRATION:** Each animal shown in this department must be registered. Exhibitors must present to the Superintendent, prior to judging, an **Original** Certificate of Registration on each animal to be exhibited. Entries must be made in the name of the owner as it appears on the **Original** Certificate of Registration. All Animals must be certified by their respective breed association to be 87% or higher purebred to be eligible for entry in classes at the Georgia National Fair.
12. **TAG NUMBER:** Must be worn and visible in the show ring, harness preferred.
13. **BREED SHOW QUALIFICATIONS:** Breed shows will be held for those breeds listed with a minimum of five (5) exhibitors and a minimum of twenty-five (25) head showing. No-shows do not have an effect on these requirements. Breeds listed, but not meeting these minimum requirements, because of no-shows, will be allowed to display their cattle in the barn between their breed's designated arrival and release times. Exhibitors for breeds not meeting these minimum requirements, upon entry, will be notified shortly after entry deadline and entry fees refunded. Those breeds not meeting the requirements, because of no-shows, will not receive refunds. Breeds that do not meet these minimum requirements for two consecutive years will no longer be offered a breed show.
14. **CHECK-IN:** *All exhibitors must check their animals in by bringing registration papers and entry forms for substituted animals to the barn office by 8pm on Thursday. Animals not checked in by this time will be deleted from the show.*
15. **CONFORMATION:** All animals must be shown in their natural conformation and structure without alteration by modification except for the grooming and treatment of the hair and trimming of the hooves.
16. **SUBSTITUTIONS:** Substitutions are allowed in the same breed and class with the same owner or herd unit. In addition, one open substitution (out of class, but same owner) will be allowed per herd unit of the same breed. Once an animal is substituted in either the Junior or Open Shows, the original animal entered shall be eliminated from any further competition. *Exhibitor must submit a new entry form at check-in with all information completed on substitute animals. Extra entry forms will be available at barn office upon arrival.* No substitutions allowed after check-in.
17. **SUBSTITUTE SHOWMEN:** Exhibitor **must show their own animal** except for: (1) "where animals are registered in the names of different junior members of a family, residing on one farm and the herd is one unit, any junior family member may show the animal regardless of registered ownership"; (2) where an exhibitor has more than one animal in a class; or (3) where there is an *extreme emergency*. The substitute showman must be a 4-H or FFA member and must be approved by the show superintendent. If an exhibitor is unable to show his/her animal due to a disability, a substitute showman will be allowed to show for that exhibitor. The exhibitor with the disability must be present at the show-ring when the substitute showman and animal enter the ring. The substitute in all cases must be a 4-H or FFA member and the substitute must be approved by the show superintendent at the time of animal check-in. No adults other than officials of the show will be allowed in the show-ring. **No substitute showman will be allowed to show in showmanship.**
18. **SHOWMANSHIP:** Animals in showmanship classes must be owned by the exhibitor and actually shown by him/her in regular classes.
19. **SUPREME CHAMPION** will be chosen with Grand Champion from all breeds competing.
20. **PDCA REGULATIONS:** All PDCA regulations apply.
21. **TACK AREAS:** *will be assigned on a space available basis depending on the number of animals entering the show.*
22. **BEDDING:** A first bedding of wood chips will be provided. No sand will be allowed in the cattle barn complex.
23. **MILKING PARLOR** will be opened and available for use by exhibitors per the following schedule. Milking Parlor Schedule: Wednesday, Oct. 11, 6:00 – 11:00 pm; then Thursday through Sunday, Oct. 12-15, 5:00 am to 11:00 pm each day. Before using the parlor, an exhibitor must verify that he/she has valid health certificates on all animals using the parlor and that these animals meet all conditions of the Grade A PMO.
24. **PASSES:** Complimentary passes must be picked up at the Livestock Credentials Office at the Livestock Gate of the Fairgrounds upon arrival.

#### NOTICE TO EXHIBITORS

25. Exhibitors may spend the night inside the barns only to tend to lactating animals and must do so within their assigned stalling area or purchase additional stalling space, if available. No other camping is allowed in or around the barn areas.

26. In order to create a good public image and to add to the attractiveness of the livestock area, all beds, cots, bedding, etc., should be stored out of sight by 8 am each morning.
27. No cooking is allowed inside or around the outside of the barns to comply with local fire codes.

Exhibitors entering an animal in any other than the name of the bona fide owner or owners or showing an animal in a class for which it is not eligible, may, at the discretion of the Ag Expo Authority, be barred from further showing. - c. Collegiate Division: Open to all senior and junior colleges in the United States offering a degree or program in agriculture and/or animal science. Collegiate division is a “workout” only. Individual scores will be tabulated. No awards will be given for collegiate division.

## 2. Entry Fee:

- a. **Entries due September 20, 2023 to receive ground passes to enter the fairgrounds.**
- b. Contest entry fee is \$15.00 per competitor. Entries submitted on time will receive grounds passes to enter the Georgia National Fairgrounds.
- c. Late entries will be \$25.00 per competitor and will NOT include ground passes.

## 6. You will not be allowed to add contestants the day of the contest; however, you may substitute.

## 7. Junior/Senior 4-H/FFA Division:

- a. Max of 10 placing classes including market and breeding beef, swine, sheep and goats.
- b. Juniors will give a minimum of one set of reasons.
- c. Seniors will give a minimum of two sets of reasons.



8. Collegiate Division:
  - a. Max of 10 placing classes including market and breeding beef, swine, sheep and goats
  - b. Max of 6 sets of reasons may be included.
9. Performance data will be provided on selected breeding classes
10. Awards will include team and individual results for junior and senior divisions only.
