RULES AND REGULATIONS OF THE GLENN COUNTY FAIR PRINCESS PROGRAM

The Glenn County Fair Princess Program is open to all girls regardless of race, color, or creed who meet the age and other requirements as listed below and abide by the general rules as set forth above.

Completed applications are due in the Fair office by February 2, 2026. Eight (8) applicants will be selected for the princess program. All participants will be randomly selected by Lottery if more than 8 are received, after the application period has ended.

At the recognition ceremony prior to the Miss Glenn County Competition each princess will receive a tiara and a satin princess sash. The princesses will perform at the Miss Glenn County Pageant and Friday and Saturday of the Fair. Girls who enter the program should be as interested in the rehearsal and preparation experience as they are in performing at the Fair.

Each contestant is asked to obtain a \$125.00 sponsorship. Your sponsor can be family, friends, or local businesses. Each sponsor will have name recognition throughout the Fair.

The sponsor names and sponsorship fee must be submitted to the Fair office by February 9, 2026. Program Directors will NOT accept sponsorship payment.

A mandatory parent information meeting will be held on February 2, 2026, at 6:00PM in Flaherty Hall. Princesses do not need to attend this meeting. A practice schedule will be provided at this meeting. Princess contestants cannot miss more than two practices to participate.

ELIGIBILITY:

- Contestants must be between the ages of five and seven on or before January 1st.
- Attendance at all Princess Functions and rehearsals is expected. Prior arrangements can be approved by pageant directors.
- Only a Parent or Guardian of the contestants will be allowed to attend practices.
- Contestants will be accompanied by parent/guardian at all required fair appearances.
- Each contestant must agree to perform a certain number of hours at the Fair. The time will be determined by the Fair CEO and the Program Directors. When representing the fair, conservative and tasteful attire is expected.
- Applications will be stamped on time and date by the fair staff.
- Contestants must have the applications completed with the Rules and Regulations signed by their legal parent/guardian.
- Contestants may only participate one year in the program.
- **One parent/guardian of each contestant must attend the parents' meeting on February 2, 2026.**

The meeting will be at the Glenn County Fair Grounds, Flaherty Hall at 5:30 PM.

I hereby agree that my child will appear at the Glenn County Fair, May 14-17, 2026. I am aware that my child will be accompanied by ONE parent or guardian who will be given free entry into the Fair. All others must purchase fair admission. I hereby acknowledge that I have read the official rules and regulations printed on this sheet, and I am complying with them in every way. I am supplying the Fair Management and Pageant Director with my personal data that is accurate to the best of my knowledge.
