Application Instructions

- 1. This application is neither an offer nor guarantee of space. If application is approved, full payment is due April 15, 2021 or your application will be removed from our list and an alternate vendor chosen .**
2. If you are applying for more than one 20x20 spot, you must submit a separate application and additional vendor fee. You will be provided with 2- 8' folding tables as well as 2 chairs. If you need additional tables they can be provided at a cost of \$10.00 per table.
3. All questions on this application must be answered completely. Be sure the information you give is accurate, as it will be the sole representation of your business for the selection process.
4. All Applicants must submit a description of items to be sold or information to be given out and proposed prices. If selected, your list of items cannot be changed without approval from manager. This is to prevent a large amount of duplication and keep our vendors happy.
6. Submit a recent photo of your stand(s) with application. Photos will not be returned.
8. Your stand must fit within the 20x20 space assigned or you will need to pay for an extra space.
9. A copy of your North Dakota Tax Permit is necessary this year. You may obtain this license by calling the Office of the State Tax Commissioner at 701-328-8800.
10. Management will determine the location of your booth. Locations are subject to change from year to year. We will always try to accommodate the special needs of our vendors.
11. If you need electricity it can be provided for a rate of \$50 for the 5 day fair. .
- 12. The 2021 Outdoor Commercial Vendor fee will be \$200.00.**
13. If accepted and you cancel prior to April 30, 2021, your full vendor fee will be refunded. Any cancellations after April 30, 2021 will not be refunded.
14. All service vehicles and trailers must be parked behind the commercial exhibitors building.
15. All vendors must check in to the Fair Office prior to setting up.
