\*\*The Ardell Kitchen is leased by a private concessionaire. It is not available for use as part of the Ardell rental. The concessionaire may, or may not decide to open for your event. Please make arrangements with the concessionaire for your event if needed.

***\*Washington State Sales Taxes are included in these rental rates. Taxes will be applied to all other rates upon invoicing. Admission events will be given admissions tax registration and reporting forms.***
