PYGMY GOATS (OPEN CLASS)**

**Entries due by July 15th
Entry/Stall fees: \$3.00 per animal
Goats in barn by 11 am, Wednesday Aug. 10**

PREMIUM POINTS: All open class goats are for Exhibit only and will not be judged. A fixed premium of \$10 will be paid for Open Class Goats, with a maximum of 4 animals per Exhibitor being awarded premiums.

All entry fees must accompany entry forms. Pens will be assigned by the Superintendent and are on a first come first served basis, shavings will be provided.

- All animals must be health checked by the Superintendent or barn staff prior to unloading and the Superintendent has the right to refuse entry of any animal not in proper health for showing.
- 4-H and FFA exhibitors in county and out, may enter registered goats in the open show and must pay the appropriate entry fees. All 4-H and FFA boer goats being shown in open class will be stalled in the 4-H & FFA barn.
- All animals must be shown in individual classes to be included in group classes.
- Horned Animals are not allowed, except for Angora and Colored Angoras.
- Exhibitors are responsible for the care and appearance of their animals and display.
- All animals on exhibit must be shown in the appropriate class, no display animals.
- Classes will not be held for those arriving late to the show ring, have your animals ringside at the beginning of the show.
- All vehicles must be off the fairgrounds by 9:30 am.
- All stalls must be cleaned by 10:00am
- All ribbons and awards must be displayed.
- All goats must have official USDA national scrapie eradication assigned flock identification (your herd tattoo registered with the scrapie program is acceptable)
- All animals MUST be accompanied by registration papers!
- Refer to the official rules and general regulations for more on health requirements and general information.
- Base date of show for computing ages is August 5th.
- Only shavings will be provided. You must bring your own straw if you want straw.***

If not enough animals are entered to sanction each category the Superintendent reserves the right to combine classes to make sanction, by entering in our show you are agreeing to this possibility***

CLASS:

1. Doe under 2 months
2. Doe 2-4 months
3. Doe 4-6 months
4. Doe 6-8 months
5. Doe 8-10 months
6. Doe 10-12 months
7. Doe 12-24 months, never kidded
8. Doe, 1-2 years, kidded
9. Doe, 2-3 years, kidded

10. Doe, 3-5 years, kidded
11. Doe, 4-5 years, kidded
12. Doe, , over 5 years, kidded
13. Dam and Daughter, (dam and daughter any age)
14. Produce of Dam, (2 females from same Dam, any age)
15. Breeder's Trio (3 females any age, bred and owned by exhibitor)
16. Jr. Get of Sire (3 females of same sire, less than 2 years)
17. Sr. Get of Sire (3 females same sire, over 2 years.)
18. Exhibitor Herd (4 does, any age owned by one exhibitor) {limit one entry per exhibitor, one breed}

Entry/Stall Fee: \$3.00 per animal
Goats in barn by 8 pm Tuesday August 4th**

PREMIUM POINTS: All open class goats are for Exhibit Only and will not be judged. A fixed premium of \$10 will be paid for Open Class Goats, with a maximum of 4 animals per Exhibitor being awarded premiums.

- Pens will be assigned by the Superintendent and are on a first come first served basis, shavings will be provided.
- All animals must be health checked by the Superintendent or barn staff prior to unloading and the Superintendent has the right to refuse entry of any animal not in proper health for showing.
- 4-H and FFA exhibitors in county and out, may enter registered goats in the open show and must pay the appropriate entry fees. All 4-H and FFA goats being shown in open class will be stalled in the 4-H & FFA barn.
- Horned Animals are have to have horn covers on at all times.
- Exhibitors are responsible for the care and appearance of their animals and display.
- All vehicles must be off the fairgrounds by 9:30 am.
- All stalls must be cleaned by 10:00am
- All ribbons and awards must be displayed.
- All goats must have official USDA national scrapie eradication assigned flock identification (your herd tattoo registered with the scrapie program is acceptable)
- Refer to the official rules and general regulations for more on health requirements and general information.
- Base date of show for computing ages is August 5th.
- Only shavings will be provided. You must bring your own straw if you want straw.***

DIVISION:

1. Youth 12 & under
2. Teen 13-19

CLASS:

1. Obstacle with kid under 1 year – no pack
2. Obstacle with goat 1-2 years with soft pack
3. Obstacle with goat 2-3 years with pack & weight
4. Obstacle with goat over 4 years with pack and weight
