

Raffle Rules (also available at hotfair.com)

1. Limit of 1,000 tickets sold for \$100 each.
2. One ticket per \$100 donation.
3. Cash, personal checks, or credit cards are accepted for the purchase of a ticket. Firearms will not be awarded until the check clears the bank. Returned checks are subject to an additional fee and disqualification from the raffle.
4. By obtaining a ticket, you attest that you are a law-abiding citizen of good moral character, may legally possess the firearm (the winner has the intention of using the firearm only in a legal and safe manner), and will or have already obtained instruction on the safe use and operation of the firearm.
5. A specific firearm is assigned to each day of the drawing. The winner on a particular day will win the firearm assigned to that day.
6. Winning tickets will be re-entered into the raffle. The same ticket can win more than once.
7. There is no limit to the number of tickets purchased per person.
8. All firearms won are subject to availability and the South 40 Committee reserves the right to substitute a firearm of equal or greater value.
9. Winning ticket numbers will be announced on the South 40 Facebook page in order to protect the privacy of the winner. Winners will also be contacted by telephone.
10. Proceeds benefit the Heart O' Texas Fair & Rodeo Scholarship Fund.
11. You must be at least 21 years old and a legal resident of the United States of America to purchase a ticket. Winners must be at least 21 years old to take possession of a rifle or shotgun, and at least 21 years old to take possession of a handgun. Tickets should not be made out to children below the age of 21 as they will not be able to take possession of any firearms.
12. Winners will be contacted using the information provided by the purchaser on the ticket stub. Please print legibly. In the event that the winner cannot be contacted, it is the responsibility of the winner to contact the South 40 Committee to claim his/her prize. Prizes are non-transferable; the person designated on the ticket must claim the prize. **ALL PRIZES MUST BE CLAIMED AND TRANSFER COMPLETED WITHIN NINETY DAYS OF THE SCHEDULED DATE THE TICKET IS DRAWN.**
13. The raffle is void where prohibited.
14. All laws and regulations of the Federal Bureau of Alcohol, Tobacco, and Firearms (BATF) apply.
15. All firearm(s) transfers will be coordinated by the gun dealer and all Federal and State laws will apply, including the state laws for the legal residence of the winning ticket holder.
16. Winners may be required to verify that the ownership of the firearm is legal in their state, city or town, prior to taking possession of the firearm.
17. At no time will the South 40 Committee take possession of the firearm. All winners will receive their firearms directly from Ace Hardware.
18. South 40 Committee limits any and all liability to the purchase price of the ticket purchased.
