

## Little Miss Hardee County 2022 Information

### Date

February 25, 2022 at 7:00 pm

Please see calendar for all practice dates, due dates, etc. that is received when paperwork is turned in.

### Sponsor Fee

A sponsor fee of \$75.00 is required to enter the pageant. Please bring your sponsor fee along with sponsor information due no later than 12/17/2021 5-6 p.m. Committee will be at Main Street Heritage Park that day from 5-6 p.m. to collect any that have not been returned prior. All checks should be made out to the Hardee County Fair Association.

### Attendance

Attendance at practice is **EXTREMELY** important. We only have a short amount of time to practice! Dress rehearsal is **MANDATORY!** Please drop child off no earlier than 5 minutes prior to start of practice as we cannot guarantee supervision. Also please pick child up no later than 5 minutes after the end of scheduled practice as we cannot guarantee supervision.

### Opening Number

The theme this year is Superheroes- the girls attire will be black leggings, black tee shirt, cape. Contestants will pay \$15.00 due at time of sponsor fee and paperwork collection for the cape.

### Hardee Fun Fact

Each contestant will need to research a Hardee Fun Fact. The contestant will present her Hardee Fun Fact during the opening number portion of the pageant. The Fun Fact should be a short, fact or bit of information about Hardee County and its history. The Fun Fact should be one or two sentences. Each contestant will have a different fact. You must turn in three different facts in case your first fact has already been chosen.

### Sportswear

There is a sportswear category for this pageant. This is something you would wear out to play sports or an outside activity, i.e. running suit, jogging pants, athletic uniform, any attire/outfit worn for sports. Make sure to keep all tags on clothing. If the committee does not approve it, you will have to choose something else. Remember clothing must be tasteful.

### Dress

The dress should be a Holiday Style or Party dress. The dress should have a full tank bodice and be tea length. **NO FULL LENGTH, BACKLESS, STRAPLESS, OR HALTER DRESSES WILL BE ALLOWED. NO SPAGHETTI STRAPS. NO SHEER OR SEE-THROUGH FABRICS WILL BE ALLOWED UNLESS FABRIC UNDERNEATH SHEER FABRIC MEETS REQUIREMENTS.** Dresses must be altered and ready for the stage on the appointed due date.

### Fair Book

If your family would like to put a "Good Luck" ad in the fair program book, you will receive a form as you turn in paperwork.

### Photogenic Pictures

Photogenic pictures are TBA but are during the first week students return to school after the holidays. The girls should wear an outfit of their choice with no writing on the shirt/blouse and shirt cannot be crop topped or low cut below the natural neck line.
