WHY SHOULD YOU RAISE MONEY FOR YOUR ORGANIZATION WITH HARTMAN ARENA

Hartman Arena is a 6,500 seat, multi-purpose facility with 15 acres of on-site parking and is uniquely configured so that there is literally not a bad seat in the house.

The arena has hosted a range of concerts from Alan Jackson and Slipknot, to New Kids on the Block, Earth Wind & Fire/Chicago, Jake Owen, Little Big Town, Dancing with the Stars, Alice Cooper, and many more have been part of Hartman's event list. Our arena also a variety of other kinds of events such as the Chisolm Trail Gun Show, Vintage Market Days, State High School Wrestling, Region VI Basketball Championships and much more. In 2019 over 140,000 people visited Hartman Arena

HOW IT WORKS

We have two different roles that volunteer groups can fill during events.

Concession Stand Staff

Your group can run one of our four concession stands to raise money. If you have enough people to completely run a stand on your own (At least 7 people) you will earn 10% of the concession stands net sales or \$10 per hour per person. Whichever amount is higher. If you don't have enough people to run an entire concession stand your organization will earn \$10 per hour per person. During the average event you tend to work 5 to 5 $\frac{1}{2}$ hours. There are also opportunities for working in bars as well.

Wrist Banding Guests for Alcohol

Alcohol compliance is a very important part of a great guest experience. For almost all of our concerts we have staff in the front of the arena wrist banding guests as they enter. This is to ensure proper ID procedures are being followed and to speed up service at our bars. Wrist banders are paid \$35 per person. Wrist banders tend to work about 2 $\frac{1}{2}$ hours during an event.

WHAT WE NEED

We need a current W9

In order to work as a non-profit organization for Hartman Arena, your group must maintain the appropriate insurance. That insurance requirement is as follows; Comprehensive or Commercial General Bodily Injury and Property Damage Liability Insurance with a combined single limit of not less than One Million Dollars (\$1,000,000.00) per occurrence, and Two Million Dollars (\$2,000,000.00) in the aggregate, (which coverage shall include risk of false arrest, false imprisonment, malicious prosecution, defamation of character, libel or slander, and other errors and omissions); and Worker's Compensation Insurance per Kansas statutory limits; and Employer's Liability Insurance in the minimum amount of One Hundred Thousand Dollars (\$100,000.00) per accident, Five Hundred Thousand Dollars (\$500,000.00) for disease, and One Hundred Thousand Dollars (\$100,000.00) per employee.
