**Booth spaces** will be assigned to each Exhibitor and WILL NOT necessarily be the same space as in the past. We ask that vendors keep areas clean and comply with all health standards. **NO SMOKING IN OR NEAR BOOTHS.** 

We ask that you keep any music or sound equipment at a low volume so you are not disturbing your neighbor.

**FOOD VENDORS MUST** have a **Current Food Permit** posted on their booth to serve food on our property.

**ALL VENDORS MUST** come to the office by Tuesday, July 26<sup>th</sup>, no later than 5:00 pm to receive their photo ID badge that they are required to have when entering the fair grounds during fair. **NO EXCEPTIONS.** 

**A \$500 REFUNDABLE DEPOSIT** will be required by all vendors. **No refunds** will be made on booths after July 1<sup>st</sup>. All food/retail vendors **MUST** be open and ready to serve/sell food and retail by **NOON** all the das of the fair. **NO EXCEPTIONS.** 

**BRING** your own extension cords, tables, chairs, or anything that you will need to keep your booth operational. We will not provide those items for you. **All outside electric cords must be weatherproof.**

## **General Rules:**

**No RV's or personal vehicles on the Midway**. Only exception is handicap necessity with prior approval of management.

RV Parking is available for vendors from out of town with electric & water and access to a dump station at a cost of \$20 per night.

The Hood River County Fair Board reserves the right to remove any items considered objectional by a large number of complaints by fairgoers, as well as removing any displays causing disruption in the overall display.

No sale of knives, guns (including cap guns), alcohol, cigarette items, marijuana, or tobacco products. Any items deemed inappropriate by the Manager or Board can be pulled by the Manager or Board. No smoking in the booth spaces, smoking is allowed only in designated spaces, clean up after yourself.

NO pets on fairgrounds.

**ALL VENDORS MUST** remain in place on the fairgrounds from Wednesday, July 27<sup>th</sup> at noon until Saturday, July 30<sup>th</sup> at 10 pm. It is then your option to tear down after 10 pm on July 30<sup>th</sup> or the following day. **The fairgrounds must be vacated by noon on Sunday, July 31<sup>st</sup>. NO EXCEPTIONS.** 

All vendors must have proof of their own Liability Insurance. The Hood River County Fair Board will not be held responsible for any actions taken against any Vendor.

All unloading of supplies must be completed before 11:30 am each day and all vehicles removed from the midway area at that time. No vendor vehicles are allowed on the midway grounds after 11:30 am all days of the fair. NO EXCEPTIONS.

**Vendors** may remain open until the carnival closes at 11:30 pm or later if they wish.
