General Information for All Vendors

Space Footage

Standard booth spaces are 10'x10' outside, 10'x12' inside, and 10'x20' outside. Food vendor sites are approximately 20'x15'.

Electricity

Electricity hookups are limited and will be provided on a first-come basis. Please specify number of outlets needed. Most of the festival area electrical hookups are on light poles with individual circuits. You must provide your own extension cord. Use only the heavy-duty cords. 25-50ft cords are recommended depending on placement. NO HARDWIRING DIRECTLY TO ELECTRICAL PANEL.

Photos of electrical plugs are required for ALL food vendors.

Insurance

General Liability Insurance valid through the event is required for all food vendors and may be required for certain other vendors.

Sales Tax

Sales tax permit must be displayed in booth on the day of the event. If the type of good you are selling does not match the good listed on your vendor application you will not be allowed to sell that item.

Food Vendors

MANDATORY FOR FOOD VENDORS TO SEND A FULL MENU AND PICTURE OF THEIR PRESENTED SIDES OF THE TRAILER THEY WILL BE SELLING OUT OF. THE MENU WILL BE APPROVED BASED ON THEIR APPLICATION OF THE FOODS SOLD.

Health Permits

Vehicles will not be allowed to stay with trailers. Vendor parking will be available for one vehicle. This is a rain-or-shine event.

Schedule

Saturday – Sunday	noon-Midnight
Monday – Friday	5p-12a

Vendors are expected to be open and present at booth during fair hours. Set up for vendors starts Thursday, April 21st @ 8am. Tear down is not permitted until after the participants have left the fairgrounds Sunday night.

Inventory

All dealers must submit a list of inventory for approval for each piece of equipment along with quantities they plan to bring to display at the fair by March 1, 2022. Approval for each dealer list will be given by April 1, 2022.

All vendors must submit a product list for approval.

Security

Festival security will be provided for vendor and public safety. Vendors should take precautions and arrangements for their wares against theft and weather. Security will be provided for vendor protection throughout the night.
