Information for Youth Groups

What is a Youth Organization?

The Jefferson County Fair welcomes community members to exhibit their animal and static projects. Youth aged 8-19 who are part of an organized group such as **4-H, FFA, Scouting America Troops, church groups, afterschool programs, school clubs, or other organizations** with adult leadership and an educational program are eligible to show in the Junior Department. The educational program should be appropriate to that organization, and feature education that aligns with at least one of the Jefferson County Fair Departments. Leaders of all youth organizations must complete the Youth Organization Application form annually and submit it to the Fair by **March 1st** of the current Fair year to allow their members to exhibit.

Sprout Exhibitors

Youth in your organization who are **ages 5–7** as of January 1st of the current Fair year can exhibit in the Sprouts Department. Sprouts exhibitors showing animals can communicate with their adult leader to find a junior exhibitor to guide them during their showing experience in the ring. Static project exhibitors (e.g., baking, crafts, photography) will have their projects judged by an experienced 4-H member, helping them improve as they continue to exhibit in future years.

Junior Exhibitors

Youth ages 8–19 as of January 1st of the current Fair year are eligible to exhibit in the Junior Department, provided they are in good standing with their designated youth organization, as determined by its leadership.

What do I need to know about Competitive Exhibits at the Fair?

Departments

The Jefferson County Fair is divided into animal and static departments.

- Animal departments: Department #1 (Dairy) to Department #11 (Cats).
- Static departments: Department #12 (Animal & Veterinary Sciences) to Department #29 (Health, Political, and Social Sciences).

Each department is further divided into divisions and classes. Exhibitors sign up to exhibit within their desired class.

Superintendents

Each department is overseen by a Superintendent, a highly qualified individual specializing in that department's subject area. Superintendents serve as an advocate for the exhibitors to help with rules and regulations, check-in procedures, and check-out processes.

Judging

Projects are judged using different methods:

- Animal projects: Judged face-to-face, requiring the exhibitor to be present during judging.
- Static projects: Judged through Conference Judging, where exhibitors present their project to a judge, explain details, and answer questions. The static exhibit will be placed on display, along with the placing and the ribbon before the end of Fair. The exhibitor will be able to gather their ribbon and project when they are released at the end of the Fair.
- Event projects: Judged face-to-face, these are events where the exhibitors showcase their project. These are things such as Speeches and Demonstrations, Archery, Music & Drama, etc.

All judges are qualified through DATCP and selected by Jefferson County Fair staff.

Awards, Ribbons, and Premiums

Each department, division, and class offer ribbons with corresponding monetary awards (premiums). Some divisions award ribbons without premiums. Additional special awards, such as "Judge's Favorite," "Grand Champion," "Reserve Grand Champion," and others may also be available. Details on premiums can be found in the Premium Book.

How to Enter

The Fair uses the FairEntry software for managing entries. Exhibitors may begin submitting entries in November of the current fair year, with a **final deadline to be communicated in the Premium Book and on our website**. Late entries will not be accepted. Premium Book

The Premium Book contains all rules and regulations for the Fair, including information about the Sprouts, Junior, Open, and Senior Departments, as well as auction details, entry fees, judging schedules, ethics policy, and more. It is an essential resource for entering exhibits and understanding each department. The Premium Book is available on our website under [Premium Book](#).

Exhibitor Fees

Entry fees vary by department and division. Every entry in Sprouts is \$0.25, while it changes from class to class in the Junior Department. The fee will be listed under the rules in each department in the Premium Book.

Admission

Exhibitors may purchase one wristband for \$15.00 through FairEntry, granting daily access to the Fair. These wristbands can be purchased for exhibitors in Sprouts, Junior, Open, and Senior departments.

Steps to Exhibit

Youth Organization Approval

All Youth organizations including 4-H, FFA, school clubs, Scouting America, church groups, afterschool programs, etc, must submit the **Youth Organization Application** annually. This form can be found at the end of this packet or on our website under [Youth Organizations](#).

- It is recommended to complete the application early to ensure exhibitors can register under the correct organization.
- The adult leader of the organization must complete and submit the form.

Project Entry Process

Youth exhibitors (Ages 5-7: Sprouts; Ages 8-19 Junior) must be entered into the **FairEntry** software by a parent/guardian or themselves. Entries open in **November**, and close on a **final deadline to be communicated in the Premium Book and on our website**.

Entry Review

After entries close on the closing date, the Fair staff will review the list of exhibitors registered under each approved youth organization.

- Staff will send this list to the organization's adult leader, who must confirm which exhibitors are in good standing.
- Exhibitors who are not confirmed in good standing by the adult leader will risk losing their ability to exhibit in Junior Departments in the current Fair year.

Project Check-in & Judging

Exhibitors must bring their projects to the Jefferson County Fair on the designated check-in and judging day.

Judging

Projects will be judged according to the judging schedule on **found within the Premium Book**.

- **Static exhibits:**
 - Exhibits are dropped off, tagged, and judged on the same day.
 - After conference-style judging, exhibits will be left with the Superintendent and displayed until pick-up on Sunday.
 - Ribbons and awards will be displayed with the projects.
- **Animal exhibits:**
 - Judging schedules vary and may include additional events such as **Master Showperson** and the **Animal Auction**.
 - Details for animal exhibit schedules are in the Premium Book under each department.

Project Pick-up/Release

Static exhibits must be picked up on the final day of the Fair (Sunday); times can be found in the Premium Book



Approved Youth Organization Application Form

The purpose of the Jefferson County Junior Departments is to showcase the educational programs of youth organizations through exhibits youth complete as a member of their organization. The Jefferson County Fair experience helps reinforce youth's education and provides opportunity for reflection through interaction with judges, peers, and the public.
