GENERAL RULES FOR NON-LIVESTOCK EXHIBITS

1. All articles entered must be the work of the Exhibitor and have not been previously exhibited in a prior year at the Josephine County Fair.
2. Online entries must be submitted by the date stated and published within each Department's Rules. Information must be accurate and complete.
3. Entries must be delivered and removed only during the published scheduled times. Removal of an exhibit before the designated time forfeits all awards for that exhibit. Items not picked up within 10 days after the close of Fair are forfeited by the Exhibitor.
4. Entries will receive a claim check upon delivery of their item(s) and must present the claim check in order to pick up items at the scheduled pick-up time after Fair.
5. Superintendent or Judge may disqualify or transfer any exhibit to a more suitable Class which, in their opinion, is not a true representation of the Class in which it is entered or if published rules are not followed.
6. Departments are closed to the Public while exhibits are being judged. Ribbons and/or prizes will be as warranted. All Judge's results are final.
7. Exhibitors found in violation of rules, or to be in practices unethical or adverse to Josephine County Fair, shall be penalized by forfeiture of awards and/or privileges and removed from the exhibit.
8. The Josephine County Fair Board will take reasonable precautions to ensure the safety of exhibits while at the Fairgrounds, but will not be responsible for loss, damage, theft or injury of any kind to exhibits or Exhibitors. Exhibitors shall indemnify and hold harmless Josephine County which shall include all authorities, boards, bureaus, commissions, divisions, departments, districts and offices of Josephine County and the individual members, employees and agents thereof in their official capacities.
9. Media Disclaimer: Josephine County Fair reserves the right to use any photo or video taken at any event without the expressed written permission of those included within the photo or video. Josephine County Fair may use the photo or video in publications or other media. To ensure the privacy of an individual, images will not be identified using names or personal identifying information without written approval from the photographed Subject, Parent or Legal Guardian. Any person not affiliated with Josephine County Fair may not use, copy, alter or modify official Josephine County Fair photos, graphics, videography or other similar reproductions or recordings without the advance written consent of an authorized designee from Josephine County Fair.

1. All General rules and regulations apply.
2. All Artwork/Entries must be registered online at <https://josephine.fairwire.com/> prior to drop-off/submittal.
3. Entry Deadline is August 3rd, 2022, by midnight.
4. Artwork/Entries must be Submitted/Dropped off Friday and Saturday Before the Fair between 9am-5pm.
5. Artwork/Entries will be released Monday after the Fair from 9am -5pm.
6. Artwork/Entries left more than 10 days will become property of the Fairgrounds.
7. Any Artwork/Entry previously shown at the Josephine County Fair may not Compete.
8. Multiple Artwork/Entries brought in by one Exhibitor must be brought in at the same time.
9. Exhibitor is limited to three (3) Artwork/Entries but cannot enter more than one (1) Artwork/Entry per Class.
10. No wet or unframed paintings will be accepted.
11. Artwork/Entries must be matted or framed except for Painted Wrapped Canvas. All Artwork/Entries must have sturdy screw eyes and wire hangers only. NO "Alligator" style hangers or Glass clip frames. Entries not properly done will not be Displayed.
12. Watercolors, dry pigment, charcoal, pastels, etc. may be framed under glass or Plexiglass (preferred).
13. Dimensions are NOT to exceed 24" x 36" or 36" x 24" or weigh more than 5lbs. for hanging art.
14. Copy Work is defined by "the reproduction of another artists work." This Class Protects you, the Artist, from liability of plagiarism and Copyright infringement laws.
15. Copy Work: A copy of the original along with credit to the original Artist (if available), not to exceed 8.5" x 11", must be included with your submission for judging.
16. Classwork is Defined as, "Work created in a class or workshop environment where instruction is provided in new techniques, methods, and mediums and/or work produced by all students is of a common subject.
17. The Superintendent reserves the right to reclassify pictures or combine classifications as needed, according to the total number of Entries.
18. The Superintendent may refuse to accept any Entry at their discretion.
19. Ribbons - All Classes in each Division will receive 1st Place, 2nd Place, 3rd Place and Honorable Mention.
20. Special Ribbons Awarded by Division- One ribbon awarded Best of Show, Most Creative, and People's Choice and a Special Ribbon to Best Depiction: "Grants Pass It's The Climate!". A Special Ribbon for "Best Fair Theme, On with The Show!" A Special Ribbon for "Best Depiction of a Local Shelter Animal."
21. Professional Classes, Copy Work, and Class Work are NOT eligible for Best in Show or People's Choice Ribbons. Only 1st, 2nd, 3rd, Honorable Mention and Best of Class ribbons will be awarded in these Divisions.
22. Best Depiction of a Local Shelter Animal Class - All entries must include a photograph (not to Exceed 8.5"x11") of the animal being depicted, as well as, which Shelter it was in and the animal's name. The

Animal must either be in a local shelter or adopted in 2022. Participating Shelters are Rogue Valley Humane Society and Josephine County Shelter.

23. All winners are eligible for State Fair “Best of the Best”, for year 2023. Contact Oregon State Fair for more information.

24. **Division Descriptions:**

- **Beginner:** One who is learning artistic skills, not teaching, or selling any art in any specific medium.
- **Intermediate:** One who has had two or more years of experience and art sales that do not exceed the cost of materials used, and does not have other revenue from art.
- **Semiprofessional:** One who engages in the arts as a Hobby and whose return from sales exceed the cost of Materials Used.
- **Professional:** One who makes revenue from the sale of their art.
- **Special Needs:** Artists who needs assistance composing art.

25. While the Superintendents, Judges and Fair staff appreciate that art is subjective we do ask artists to take into consideration the family friendly nature of the event when creating their Artwork/Entries and refrain from overtly Sexual, Graphic or Political Subject matter. If subject matter is deemed inappropriate it may not be displayed. Let’s keep this a fun family event for all.
26. **Display space is limited.** Depending on the number of Entries some Artwork may not be displayed. Staff will do it’s Best to accommodate all Artwork.
