August 27	<b>Entry Deadline</b> – On-line entries by midnight. No charge for entry.

August 31	Judging following Receiving
Sept 15	Entries are released as of 6:00 pm – 8:00 pm <b>**No early releases</b>
Sept. 16	Entries picked up between 9:00 am – 1:00 pm
After Sept 20	Must contact KSF Admin Office to make arrangements (620) 669- 3621 or (620) 669-3600. <u>All items should be picked up within 1 week from the closing of the Fair (by Sept. 24<sup>th</sup>).</u> After that date, limited days and times will be available.
<b>October 1</b>	<b>All remaining Exhibits will be destroyed.</b>

All teacher-entered school artwork will be displayed in the Oz Gallery.

Due to limited display space, **each student will only be allowed one entry** in their division.

Student Art has no fee to enter.

If the student wishes to enter additional artwork, they may do so individually in the Fine Arts Department. Entry fee for Open Class is \$1.00 per item and \$1.00 per Exhibitor.

**All exhibits/artwork must have a label on the back of the sheet with the student's full name, school name, teacher name, and grade level. NO EXCEPTIONS - Artwork will not be accepted without this information.**

## Division 1 – School Art - 2nd Grade and Under

- All artwork is to be on **9" x 12"** paper. Should item exceed the size imitation, it will not be accepted.
- No mounting is necessary.
- No frames.
- If an entry is accepted by oversight, it may later be disqualified and/or not judge or displayed.
- Drawing/paintings only. Do not glue objects to paper.
- Disability students may use a preprinted coloring page.
- Must have student's full name, school name, teacher name, and grade level. No exceptions – Artwork will not be accepted without this information.

***“My favorite part of the Fair”***

- Drawing/paintings only. Do not glue objects to paper.
- Disability students may use a preprinted coloring page.

- Drawing/paintings only. Do not glue objects to paper.
- Disability students may use a preprinted coloring page.
- Must have student's full name, school name, teacher name, and grade level. No exceptions – Artwork will not be accepted without this information.

***“My favorite part of the Fair”***

## Division 4 – School Art - 9th - 12th Grade

- Stretched Canvas may be used. Edges must be finished – no raw edges.
- Canvas Boards may be framed. **ONLY LIGHT-WEIGHT FRAMES.**
- **Not to exceed 30"**
- **Must have wire or eyes for hanging. Do not use nailed-on hangers or masking tape.**
- Entries may be matted within a frame.

Awards for Division 1-4 are ribbons only – 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and Merit.

### **ALL JUDGING CRITERIA:**

**WORKMANSHIP - DESIGN - GENERAL APPEARANCE - MATERIALS USED**

### **ADDITIONAL RULES/INFORMATION - READ CAREFULLY**

1. **Any item that does not meet the requirements will not be accepted. If an item is accepted as an oversight, it may later be disqualified and/or not judged or displayed.**
2. **All items must have the student's name, grade level, school, and teacher on the back of the exhibit.**
3. Subject matter must be original and not copies (Except for disability students). Entries must be the work of the exhibitor with work being done since the 2023 State Fair.
4. Artwork in frames, on stretchers, or canvas must have wire or eyes for hanging. Do not use nail-on hangers or masking tape - Classes in Division 4 only.
5. Our primary audience consists of family and youth. We reserve the right to reject any entry/exhibit which may be considered objectionable by that audience.
6. All exhibits will receive the best care and protection in their surroundings. At all times exhibits are subject to owner's risk and in no event will the Fair be responsible for any damage which may occur. All exhibits will be displayed at the discretion of the Department staff.
