Lucas- The Committee looked over the Finances on tab 2. This Finance Report is only through September 30, it does not account for the full fair since . There are still some checks outstanding and expenses to record. Butler Amusement payments will not show up until the November financials. The fair seemed to be successful with the discussion with Mike. Cash positions are strong. In the month of September, we are in green \$100,000 compared to last year we were \$250,000. We made more Revenue last year but our expenses were less last year. We hired a lot more people for this fair. We also worked all 12 days, whereas last year we took off Mondays and Tuesdays. Looking forward to getting the full report of fair time. Overall, our YTD Revenue as of September 30 is \$4,200,000, whereas last year it was \$3,500,000.

# Livestock Committee - Jared Britschgi, Chairperson

Jared- With every year somethings went well, and somethings we need to work on. I have had some people reach out to me and my suggestion is to come to the Livestock meeting to voice concerns and ideas on how to improve. Moving the Auction to the Swine got a lot of positive feedback. We had 4900 entries this year. The Auction this year did \$1,280,000 on 518 lots compared to last year at \$1,270,000. Add-ons were \$633,000 as oppose to \$617,000 last year. \$240,000 was actually paid online, so that online process actually seems to be working pretty well. First round of checks is set to go out this week. Being 15 days out we only have an unpaid balance of \$460,000, where in other years we have had more. We had 2500 registered buyers of those only 1195 in some form or another participated in the auction. We had 311 true buyers that actually bought animals. Kids need to get better at getting buyers. We need to look into the hours and not doing the auction so early. We also need to get together on how to make it better.

# Facilities Committee - Cesar Chavez, Chairperson

#### New Business

a. Review and Discussion to extend the fair dates to include the Friday, Saturday and Sunday before our normal fair dates. The annual fair would extend to 15 days with each Monday closed.

Mike-The staff and I recommend mot extending the dates for the following reasons: Overlap of other fairs, expense versus actual revenue, lack of food concessionaires that would be able to attend, moving all start dates and load in dates up, Livestock exhibitors are out of school long enough, lack of commercial vendors for buildings, routing for grounds acts, biggest obstacle is the lack of Fairtime staffing. We recommend waiting to see if Fresno Fair is successful extending their dates in 2023 and

revisit this late next year. We also feel that we are just trading dollars and the community is tapped out especially with talk of a recession happening next year. We propose that we look into a spring 4 day festival with carnival, food vendors, commercial vendors and local entertainment.

Lilia-At Ventura county Fair we were really successful in adding a spring fair. The Carnival providers are typically slow at that time and have routing.

Ned Dunphy-I like that idea. It would be great to offer something new like this.

Lucas-When were you thinking would be a good time?

Mike-We thought possibly tying it in with the Pacific Coast Livestock Show or another date in March or April.

Lilia- We had the spring festival Easter weekend, but we could have it the weekend before when the kids are all out of school.

David Torres-I like this idea. We should look into it.

Lucas- Would we do it for 2023?

Lilia and Mike-I think it would be too soon because events like this take time to organize and market, but we could possibly rearrange things for 2024.

# **CEO Reports**

Mike- We have many expenses and revenues still coming in. We think the fair will be as good or better than the 2021 fair. We are waiting for payment from Vallarta, Grimmway, and alcohol concessionaires. It was a very difficult fair than 2021. There was more turn over with staffing and a shortage of personnel that led to overtime. On tab 11 the expense report from building #4 that Lucas had ask me to report. The total cost to upgrade building #4 was \$260,000. The payroll amount was in line even though they had a lot of overtime to get it ready for fair. Like most projects you run in to unforeseen problems and cost overruns. We are looking next at Harvest Hall to upgrade that building. I discussed with Councilman Andre Gonzalez the need for streetlights along Ming Avenue from Union Avenue to Chester. He would have the city look into the feasibility of adding the lights because people cross the streets and almost get hit. I also talked to him about the center divider lights on Union Avenue were out during Fair and he will look into who to contact with the Highway. We are planting trees, grass and keeping up the facility. The new equipment is wonderful, thank you. The maintenance staff love the new equipment. We just got our bobcat front loader and it can get into tight spots and pick up dirt and trash in the livestock area. Thank you, Kristine Hudson, and Downs Equipment company, for the equipment we used to grade the parking lots. One of the challenges we faced during fair was our sewer system which was collapsing in certain spots. The clay sewers were installed in 1952 and at some point, we will need to replace them. I met with Michael Flores and Mike Francesconi from CDFA when he was here. He asked, "What our biggest issue that needs to be fixed" I told him paving. We need to try to get all our roads, parking lots, under grandstands asphalted to mitigate trip and falls. He is working on many things to get it fixed and they acknowledged that this is a problem throughout the whole network of fairs. Alcohol wrist banding was a challenge also. Lilia, will you comment on the wrist banding? Lilia- We had to have ABC understand we are not just one thing we are many things in one and we need our co-partners to hand out wristbands and check ID's as well. This allowed us to check ID's and wristband more people without the outrageously long lines. This seemed to make our customers happy. We have to still work out some kinks to improve the process, but overall, it turned out good. We have many events coming up; Bakersfield Fall Home Show, Crossroads of the West Gun Show, a family reunion, Monster Truck Thunder, Dia De Los Muertos, Christmas Town, Toy Run, NaTesha Johnsons and the Bakersfield Police Departments food drive through.
