Finance Committee - Lucas Espericueta, Chairperson

Lucas- The cash position is stable at the current time with a cash balance of \$5,237,780.81, cash balance of July 2020 was \$495,668.82. All cash has been reconciled as of September 30, 2021. Accounts Receivable amount \$23,928.68 balances to the A/R Aged Invoice Analysis enclosed. The Association has \$18,309.68 in doubtful accounts (awaiting approval to write off from the State of California) which is a net Accounts Receivable of \$5,619.00. No Change from June 2021. The Deferred Charges are \$1,045,103.53 of Deferred Outflow of Resources Pension which is part of he GASB 68. Depreciation Expense for the month was \$14,894.04. Accounts Payable has a balance of \$192,813.73 which are our current liabilities. The Consolidated Financial Statement Revenue for September was \$2,213,236.66 Expenses \$1,712,015.17 for an operating profit of \$501,221.49 Depreciation was \$14,894.01, SVOG Grant \$2,090,000.00 for a profit of \$2,576,327.45 for the month of September. YTD profit \$2,167,847.32 ties to the balance sheet. September 30,2021 the fair was in full operation. These financial statements show the "snapshot in time" on that date. KC Marketplace is bringing in revenue and doing great. SVOG may be used for payroll costs, rent payments, utility payments, payments to independent contractors, maintenance costs, administrative costs, state and local taxes and fees, insurance payments, advertising, and other ordinary and necessary business expenses. The funds cannot be used to buy real state, make payments on loans originating on February 15, 2020, make investments or loans, make contributions payments to or on behalf or any political parties, committees or candidates for election or anything else prohibited by Administrator. We are required to maintain documentation showing our compliance with the eligibility and other requirements of the SVOG program. They must retain employment records for four years following the receipt of a grant and retain other records for three years.
