Mike- Strategic planning meeting will be at the fairgrounds on December 10<sup>th</sup>. The SVOG Budget was approved, and we are working to close out the grant. We are going to start the

audit phase of the grant which is required if you spend over \$750,000 in any one year, which we did. The closeout and the audit will be close to \$30,000 cost which is part of the expense of the grant funds. Our Annual Financial Audit for 2021 will start in late January and will be a cost of about \$35,000. We are trying to get caught up on audits, but we cannot because of SB84 & SB64 which we wait for the State Controller's Office. They are about two years behind in getting us the numbers to insert into the audit. We are working on the 2023 budget. We are working on entertainment for Bud Pavilion Stage. We are remodeling the Carnival Lot bathroom for Christmas Town right now since it was a disaster. Upcoming events are Harvest Moon and Comic-Com this weekend, Christmas Town starts on the 25th of November, and Holiday Classic, ToyRun, Upside Toy Drive, Shot Clinic from County of Kern are all in December.
