Director Espericueta- The summary on tab 3 reported a strong 2023 financial position for 2023. Year to date Revenue is our all-time high at \$9,400,000. We had Expenses of \$9,300,000, which gave us a profit of \$109,000. That does not include the AB1499 money we received for \$215,000, so in total we have a profit of \$324,000. This year we had expenses of \$9,300,000 and last year \$8,000,000 and 2019 we were at \$8,200,000. The increased expenses were due to payroll costs and project costs. Tab 15 has the budget that was approved last month. We have budgeted expenses for \$9,600,000 and Revenue of \$9,957,850. January is a slow month and there is not much to report financially. Overall, the financials look great.

Mike- Does everyone understand the relationship between WFA and California Fairs Alliance?

d. California Fairs Alliance is our advocacy group and WFA actually is an organization that supports 9 to 10 States and provides a Yearly Convention They

are tied together. Most states have their own associations, so California Fairs Alliance is trying to move away from WFA and still be under their 501 non-profit statuses. This process is very time consuming, and we are all members of it. Several fairs have asked for multiple years for us to go after other money not just fair related money. We advocate that our fairs are more than just fairs, we are venues, events, resiliencies centers for emergencies. We are being used more and more emergencies and we need funding from a different source. We can get more funding for the infrastructure to be upgraded and ready for any emergency that arises. There is a new organization with six original board members of which I am one of the six representing the Kern County Fair. The Office of Emergency Services are interested in partnering more closely with fairgrounds to have facilities that are ready when the Governor needs the temporary use of the properties for emergencies. We have hired a lobbyist to advocate on our behalf to secure funding for venues and fairgrounds. The new organization is called CA EMERGENCY RESPONSE AND RESILIENCY VENUES AND FAIRGROUNDS (CERRVF) and it is a 501 c 5 corporation. We hired a top lobbyist called Platinum Advisors and the owner is Darius Anderson. He is putting together our website and lists of legislation that would benefit us. The actual cost for this year is \$25,000.00 for dues and this amount is part of the approved 2024 budget.
