#### 4H NEEDLEWORK RULES

1. The exhibitor must be enrolled in the project in which they enter.
2. Each exhibit must have a 3"x 5" card attached stating: Fiber content of thread or yarn and care label.
3. You may have more than one entry in each class but each entry must be different in design, different stitch.

#### DIVISION 70-A ..... ANY ARTICLE MADE IN BASIC KNITTING

##### CLASS 01 – SIMPLE ITEMS

Slippers, bags, hats, scarves, potholders, etc.

##### PREMIUM POINTS

Blue ..... 20

Red ..... 16

White ..... 12

##### CLASS 02 – DIFFICULT ITEMS

Sweater, afghans, slippers, large quilts, etc.

##### PREMIUM POINTS

Blue ..... 45

Red ..... 35

White ..... 25

##### CLASS 03 – NOTEBOOK

Notebook with samples of stitches: garter, stockinet, ribbing, increase, decrease

##### PREMIUM POINTS

Blue ..... 15

Red ..... 11

White ..... 8

##### CLASS 04 – NOTEBOOK

Notebook with samples of stitches: buttonhole, seed, cable, yarn over, seam joining, decrease, increase

##### PREMIUM POINTS

Blue ..... 15

Red ..... 11

White ..... 8

#### DIVISION 70-B ..... ANY ARTICLE MADE IN BASIC CROCHET

##### CLASS 01 – SIMPLE ITEMS

Bags, scarves, potholders, hats, etc.

##### PREMIUM POINTS

Blue ..... 20

Red ..... 16

White ..... 12

##### CLASS 02 – DIFFICULT ITEMS

Sweaters, afghans, slippers, large quilt, etc.

##### PREMIUM POINTS

Blue ..... 45

Red ..... 35

White ..... 25
