## RULES, DRESS CODE, RESULTS & GRIEVANCES

- **RELEASE OF LIABILITY FORM REQUIRED**
- All team members must be listed for each team and full entry fee submitted with entry form. Failure to list all team members or to pay full entry fee will result in the team ineligible to compete.
- Team Penning & Branding event is open to KLICKITAT COUNTY RESIDENTS only. Participants must have been county residents at least 90 days prior to fair. If participants are college students whose parents are Klickitat County residents, they may participate as county residents the same year following their college graduation. A current local driver's license is used to determine residency. A signed release form is required.
- There are no substitutions of team members with the exception of injury, illness or natural disaster. In cases that qualify for substitution, they are at the discretion of the grievance committee and need approval prior to competing.
- In all roping events, physically challenged and participants 50 years and older may tie hard and fast.
- Cattle for finals at all events are chosen on basis of best cattle. The choosing of these cattle is the decision of the chairperson and committee.
- Order of the go for the finals shall be the reverse of the placing in the go-rounds by the qualifying teams (longest time will go first). The number of teams that advance to the finals are two (2) more teams than would qualify for the payoff. Twenty teams and under: four teams advance to the finals. Twenty-one teams and over: 20% of the teams advance to the finals.
- Payoff is based on the last team placing will receive their entry fee amount according to a standard payoff.
- Payouts are not split and will be available at fair office following the rodeo performance on Sunday.
- Sanctioned events are governed by rules/bylaws of Klickitat County Fair and Jack Davenport Memorial Penning & Branding Committees with Chairman present.
- **DRESS CODE:** All contestants must wear a western hat, ASTM/SEI helmet or no hat, and a long-sleeved shirt with cuffs down and buttoned. In the event a contestant has a mishap during the event or a button or snap is torn off or broken, this is not to be considered an infraction. Failure to wear western attire will result in disqualification. For safety reasons, western boots must be worn at all events.
- **AWARDS:** There must be three (3) entries for award qualification. Type of award is determined by the award committee.
- **ENTRIES, RESULTS AND CONTEST INFORMATION:** Entries, results or additional contest information will be posted online as they become available. The Program is posted at the fair office and/or near starting gate. Results are posted the day following competition by 1pm online and at the fair office.
- **GRIEVANCES:** You may not approach the judge(s) at any time with a grievance; to do so will result in disqualification of the contestant and/or the team(s). A cowbell is hung on the fence for the team to ring. When someone is flagged out, the Judge will communicate with the Announcer to determine why the team was flagged out. The Announcer will inform the Team and the spectators. If you do not agree with the call, ring the bell to assemble the Grievance Committee. A fee of \$20 must be paid before the Committee will assemble. All grievances must be filed before leaving the pen.

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the terms and conditions for participation as determined by Klickitat County Fair & Rodeo. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the County immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Klickitat County Fair & Rodeo, their officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releases"), FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
