# **Hearing of Delegates**

- Commissioner Brooks thanked the Fair Board and staff for sticking in there and putting together a great community event. Commissioner Duncan said she was looking forward to opening the fair on August 20<sup>th</sup>. No other report.
- Dave Paul spoke on behalf of the rodeo committee Junior Rodeo was excellent, and ground was the best it has been. Fair staff and rodeo committee spend hours grading and picking rocks after the last motorsport event held in July. Jumbotran is being built and chutes are being painted and stickered. Dave also reported that the Gem State Stampede is the first rodeo to offer equal pay to the breakaway ropers. Cowboy Channel will be onsite, and all rodeo performances will be aired.

## New Business

- Safety Policy Exemption Request McAlister Arenacross August 13-14, 2021 Chaun McAlister requested an
  exemption to the Safety Policy for the August 13/14 arenacross event stating he has 2 medical doctors onsite
  superior to KCEMS and his insurance does not require a standby unit. Fair Board discussion was that moving
  forward all high impact events will have standby service as the Safety Policy requires. Board consensus was to
  allow the exemption for the August 13/14 arenacross pending confirmation from Chaun's insurance stating
  standby is not required and license's of the medical staff working the event. Beyond the August 13/14 event he
  and all other promoters would be expected to follow the Safety Policy. Chaun agreed to connect with insurance
  and send in medical staff information in the next couple days.
- CDA Police Department expressed interest in being at the fair on busy nights with their DUI awareness program. They will offer people to uber tickets along with their program. Board consensus is to allow them to offer the program during the fair, another great way to keep people safe.
