# FAIR

- 2022 Fair Attendance was an all-time high with 168,567 up 9% from 2021
  - Food Up 10%
  - Carnival Up 10% (Presale up 44%)
  - Over 22,000 walked through the Petting Zoo in Building 10
  - Merchandise was up 119%
  - Livestock Sale was up waiting on final numbers
  - $\circ$  Security walked an average of 7 10 miles a day and logged 200 miles on their UTV
  - Collected 127 lbs. of canned goods on our Feed the Need Day.
  - Of 11 Arena Shows, 8 were sold out in advance.
- We are working on awards submissions to all fair associations we belong to.
- 2023 Fair Theme First Draft of the Theme Logo is ready
  - We will start working on Entertainment and arena line up
  - We are holding wrap up meetings over the next couple weeks with different groups, collecting thoughts and looking forward to some great new things and positive changes for 2023.
