#### **Old Business**

- RV Park Update (discussion item) Discussion of a possible rate increase took place. The goal of this would be
  to offset sewer/water costs. Additional discussion to be had within the finance committee before a decision is
  made.
  - The restroom/shower facility may be delayed because of the 6-month lead time needed to construct the prefab structure and obtain from supplier.
  - May need to seek sponsorship to assist in creating a community fire pit rather than have individual camp site pits (less liability and maintenance)

#### **New Business**

• 2020 Proposed Budget – The board reviewed an updated draft of the proposed 2020 budget but will not take action to adopt it until the January 2020 meeting.

## **Committee Reports**

- Finance & Budget Discussed with the 2020 proposed budget. Looking into grant possibilities to increase seating at the Findlay Arena as well as some cosmetic and functionality upgrades in the Clubhouse. Booking software for Fairgrounds events is a necessity.
- Development and Planning Dave Fair is working on framework for a strategic plan involving a master plan rendering done by professionals with fairground specific experience. He is planning to have a draft available at the January meeting.
- Facilities & Rodeo Zach and some rodeo committee members attended the PRCA convention recently and confirmed talent for the 2020 & 2021 rodeo production. They are also working on promotion and planning of the 2020 Bareback & Saddle Bronc clinic, which will be held at the Pendleton Pavilion. Discussion and interest shown in upgrading the arena scoreboard for video production through the same service provider.
- Equipment It was the consensus of the board to order a snow pusher. Ken will gather quotes for the pusher and chains. He also donated a cutting torch to the fairgrounds.
- Livestock & 4-H Fundraiser for Casey Amy, long time "Ringman" for 4-H, coming up in January. Fair staff to put together a basket to support him and his family.
