Awards Notes: All entered events including team roping (heading and heeling) count for all around points. Contestant may enter both ends of team roping (only once per end), but partner must be named on entry form or you will be placed in the draw pool. 10 points applied for each event, 1<sup>st</sup> – 10<sup>th</sup> place for each event and each age group. No stock draw, all stock will be chute run by day-sheet order; Open catch pen; Ground Rules posted Friday night prior to rodeo. Turnouts prior to 8/1 will be refunded 50%; Turnouts after 8/1 will not be refunded except a refund of 50% will be granted with a written vet/med out. Management reserves the right to make changes and limit or refuse entries. Entries will be taken on a first come, first serve basis. \*Contestants may enter up in breakaway (Peewee boys/girls) or tie-down (Junior boys) roping for go-around awards only; points will NOT count for all-around. Only events listed and entered in each division will count towards all around. No horses on grass camping areas. \*\*Stalls available at \$15/stall/night+\$30 refundable cleaning deposit; Campers may tie horses to trailer or setup personal horse pens in approved areas. \*\*\*Overnight RV camping available contact Fairgrounds.208-765-4969
