



**COVID-19 HEALTH ACKNOWLEDGEMENT & LIABILITY WAIVER**

I, \_\_\_\_\_, and my parent/guardian (if applicable) are aware of the potential spread of COVID-19 that could result in severe illness and potential death. My presence at the 2020 American Quarter Horse Association Youth World Championship Show held in Oklahoma City, Oklahoma (“Event”) proves I voluntarily accept this risk by attending the Event and accept sole responsibility for any injury to myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, including, but not limited to, illness, damage, loss, claim, liability, or expense of any kind, that may be experienced or incurred in connection with my attendance at the Event.

I understand that the risk of being exposed to or infected by COVID-19 at the Event may result from the actions, omissions, or negligence of myself, and others, including, but not limited to, American Quarter Horse Association, and/or its employees, officers, directors, representatives, agents, show staff, volunteers, Event participants/attendees and their families. I hereby release, covenant not to sue, discharge and hold harmless AQHA, and/or its directors, officers, employees, representatives and agents from any claim associated with allegedly being exposed to or infected by COVID-19 as a result of participating in Event activities and/or being on Event show grounds.

**HEALTH PROTOCOLS:**

- I have read, understand and agree to comply with the attached Health Protocols and understand and agree that I may be disqualified from participating in the Event and required to leave the Event show grounds should I fail to do so.
- I will, to the best of my ability, practice proper social distancing as recommended by health department directives, as well as practice good hygiene (hand washing, use of hand sanitizer, wearing of a mask if and when required, etc.) and follow other health directives ordered or suggested.

**HEALTH REPORTING:**

- I have not experienced new or worsening symptoms of possible COVID-19 in the last 14 days, including cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, loss of taste or smell, diarrhea, feeling feverish or a temperature greater than 100°.
- I have not had close contact with a person symptomatic or confirmed to have COVID-19 in the last 14 days.
- I have not been diagnosed with COVID-19 within the last 14 days. If I have been infected by COVID-19 at any time, I have been medically released to return to normal activities.
- If I develop a fever and symptoms, such as a cough or difficulty breathing while at the Event, or if I am diagnosed with COVID-19 while at the Event, I will self-quarantine and immediately report this information to AQHA show management.

## **Health Protocols**

*Updated July 18, 2020*

The following guidelines have been put in place in accordance with OKC Fairgrounds requirements and the recommendations of the CDC and WHO regarding social distancing and public health. Attendees should review the current [CDC](#) and [WHO](#) guidelines prior to the event and refrain from attending the show if they have been in contact with anyone exhibiting COVID-19 symptoms within the last 14 days, have a fever or other symptoms, or are immune compromised.

The Built Ford Tough AQHYA World Championship Show will be closed to the general public. Participants, family, vendors and staff may attend in accordance with the health protocols contained herein and any applicable local, state or federal mandates.

Please be aware, in addition to the Ford Youth World face protection protocols outlined below, the City Council of Oklahoma City voted to require face coverings in indoor public places in Oklahoma City, which will be applicable to the OKC Fairgrounds. *An inherent risk of exposure to COVID-19 exists in any setting where people are present.*

**If you test positive for COVID-19 during the Ford Youth World, please contact show management immediately at 614-207-3152.**

**If you contract COVID-19 while attending the Ford Youth World and test positive within 14 days of the event, please contact [worldshow@aqha.org](mailto:worldshow@aqha.org).**

If you have a professional service provider (i.e. banders, braiders, farriers, veterinarians etc.) attending to your horses, ask them to review and adhere to these protocols, as well.

### **Exhibitors, Attendees and Arenas**

- Exhibitors and attendees should not congregate in groups of larger than 10 people and must follow social-distancing guidelines.
- Put 6-feet between yourself and people who are not from your same household or household contact. Remember that some people without symptoms may be able to spread the virus.
- Exhibitors and attendees will be held responsible for providing and utilizing their own personal protective equipment, including but not limited to face protection, personal hand sanitizer, gloves, etc.
- AQHA will provide each exhibitor with one complimentary face covering per exhibitor packet. Additional face coverings will be available for purchase, while supplies last. Profits from the sale of the face coverings will be donated to the Youth Scholarship Fund.
- Exhibitors and attendees are required to wear face protection/face coverings in common areas, including but not limited to the stands, show office, trade show and bathrooms. Face protection astride and at halter is optional. *(Per the CDC, children under age 2, or anyone who has trouble breathing, is unconscious, incapacitated or otherwise unable to remove the mask without assistance are not required to wear face protection.)*
- Social distancing in the barns or outside is required, when not wearing face protection.

- Daily temperature screenings are the responsibility of each individual at the show. Additional screenings with no-touch thermometers may be required for entry. Based on guidance from health authorities, anyone with a temperature of 100F or above should not attend.
- Follow [CDC guidance](#) if symptoms develop.
- Riders/handlers and individuals on foot must keep at least 6-feet of space between each other at all times.
- Arena entrances/exits will be arranged so that riders/handlers are not coming in close contact entering and exiting the arenas. Loitering is not permitted around the gate or steward stand areas.
- Riders/handlers shall maintain social distancing guidelines at all times including but not limited to the warm-up and show arenas.
- Outside spectators will not be permitted. Exhibitors are encouraged to limit the number of people in their group (i.e. parents, spouse, a single family member and coach).
- Only exhibitors and trainers in the class currently working may be in the adjacent warm-up arena.
- No foot traffic (including trainers, family, etc.) will be allowed at the in-gates. Foot traffic must go to the stands to watch the class.
- Indoor, warm-up rings will be limited to 2 people/horses per 1,000 sq. ft. (i.e. the Performance Arena is 30,000 sq. ft. and would permit up to 60 people and/or horses at one time warming up. Barn 8 Arena is approximately the same size. Super Barn arena is 22,000 sq. ft. and would permit up to 44 people/horses).
- All individuals on the ground or assisting riders will be asked to maintain a 6-foot social-distancing standard and wear personal protective equipment when safe distancing is not possible. This will be a challenge as you approach the competition ring, but you will be asked to follow the protocol.
- Those seated in the stands will be asked to leave two (2) vacant seats between each person from a separate household or household contact.
- Every other aisleway in the seating area will be blocked off by the facility for safe physical distancing.
- Exhibitors and attendees must deliver a signed COVID-19 Health Acknowledgement & Liability Waiver to the Show Office. The completed waiver is required to attend and participate at the event. The waiver is available at [www.aqha.com/youthworld](http://www.aqha.com/youthworld). Please print [this waiver](#) and bring it with you to the show.

### **Show Office**

- Pre-entry and show related documents are only available online.
- Show Office capacity will be limited to one person and one parent/guardian per actively staffed front desk computer, plus one person and one parent/guardian in the waiting area for the next in line.
- Show Office will require at least 6-foot distancing for check-in areas and in locations where lines form.
- Show Office personnel will have a protective barrier separating them from exhibitors.
- Show Office will provide sanitizing wipes and/or sanitize entry and exit points of office regularly. When possible, doors will be left open during check-in or periods of high traffic for air flow.
- Separate entrance/exit doors will be marked to minimize crossing of people.
- To minimize contact, communications will be made through announcements, text alerts, Horse Show Tracker use and other contactless options.
- Stall and VIP RV reservations will be coordinated by AQHA prior to the event. All other RV needs will be handled directly by the facility at 405-948-6713.

### **No-Contact Options**

With these no-contact options, you can further limit your interaction with the Show Office.

## **Staff and Other Areas**

- AQHA personnel and OKC Fairgrounds staff are required to adhere to social-distancing protocols, daily temperature screenings and to wear face coverings to safeguard themselves and exhibitors to help mitigate the risk of spreading the virus.
- The announcer stands, microphones, judge tables, paddock stands and other show equipment will be sanitized with a disinfectant solution.
- Only AQHA personnel are allowed to access the announcer stands, paddock stands and judge areas.
- Signage will be placed around seating areas and throughout the facility to encourage safe distancing.

## **Enforcement**

- Exhibitors and attendees must abide by these social-distancing and health protocols; failure to follow protocols could result in removal from the OKC Fairgrounds and the forfeiture of fees. *Exhibitors and attendees will receive a warning for the first offense, mandatory discussion with show management for the second offense and potential removal from the facility for the third offense.*
