



## Plein Air Competition

**Saturday, April 6, 2024**

The Lake County Fair Plein Air Competition beckons skilled artists who relish the opportunity to immerse themselves in capturing the lively happenings of our fair through their artwork. The resulting pieces vividly encapsulate the essence of the moment experienced in the great outdoors. Few mediums rival the ability of a painting to truly convey the spirit of a location or occasion!

### **Registration Deadline:**

Friday, March 29, 2024 by 5:00pm

\*Entry Agreement must be signed and submitted for registration to be accepted\*

**Entry Fee: \$25.00**

### **Awards:**

Spirit of the Fair (1<sup>st</sup> Place)- \$300 and Award  
(The painting that most exemplifies the traditions and spirit of the Lake County Fair)

2<sup>nd</sup> Place-\$225 and Award

3<sup>rd</sup> Place-\$175 and Award

### **Eligibility:**

1. Competitors must reside in Lake County and be aged 18 years or older on day of competition.
2. Competition is open to professional, semi-professional, and amateur artists.
3. Contest will be limited to 20 entries on a first come first serve basis.

### **Competition Rules:**

1. All paintings must be created during at the Lake County Fair during the competition time.
2. Paintings must be completed on a 16x20 inch wrapped canvas or smaller.
3. Artists must check-in at The Art Barn on the day of competition prior to initiating any painting. At Time of Check-In a stamp will be placed on the back of your canvas. This stamp **MUST** be visible when submitting for final judging.
4. Competitors may check-in up to 4 canvases (stamped), but will only be permitted to submit One (1) Painting for Final Judging.
5. Types of media permitted include oils, acrylics, water media, pastels, and graphite.
6. Paintings of offensive, controversial, or objectionable nature or subject matter will not be accepted. The Lake County Fair decision in this matter will be FINAL.
7. Photographs and Tablets will not be permitted to create paintings, however they may be used to reference lighting of the scene.
8. Paintings must be submitted by 7:00pm on the day of competition for final judging. Paintings will not be accepted after 7:00pm and will be disqualified.
9. All submitted Paintings **MUST** be for sale after judging and will remain in the Art Barn for the entirety of the Fair.
10. Both Sold and Un-Sold artwork removal date is Monday, April 15<sup>th</sup> from 11am-6pm.
11. Any artwork left after removal time will be recycled. Special arrangements can be made with Creative Living Superintendent if you are unable to remove.
12. Artist will set the price of their painting and must do so at time of submittal. Artists are NOT Permitted to change pricing after submission is received.
13. The Lake County Fair will retain a 20% Commission.
14. Village Framer and Art Gallery has graciously offered framing for entries. Artists will be able to choose from available colors for framing upon submittal. Only entries sized 14x11 will be framed. Smaller or larger canvases up to maximum size stated in rule 2 may be submitted but will NOT be framed.

### **How to Enter:**

- All Contestants must register and complete their entry online using The Lake County Fair ShoWorks system.
- Visit [www.lakecofair.com](http://www.lakecofair.com)-Under competitions tab, scroll down to Creative Living, and Click on Plein Air Competition.

When registering, please verify that all information entered is correct. Pay close attention to capitalization, names of cities and counties (No abbreviations will be accepted).

**\*Please note mail-in registrations and payments will NOT be accepted.\***

### **Frequently asked questions:**

**Q:** Do I have to be a professional artist to participate?

**A:** No, all levels and experience are welcome!

**Q:** Do I have to get model releases?

**A:** No the Lake County Fair does NOT require model releases.
