

OPEN MEETINGS PROCEDURES

WHEREAS, Section 10-15-1(B) of the Open Meetings Act (NMSA 1978) states that, except as may be otherwise provided in the Constitution or the provisions of the Open Meetings Act, all meetings of a quorum of members of any board, council, commission or other policy making body of any state or local public agency held for the purpose of formulating public policy, discussing public business or for the purpose of taking any action within the authority of or the delegated authority of such body, are declared to be public meetings open to the public at all times; and

WHEREAS, any meetings subject to the Open Meetings and held for the purpose of formulating public policy, discussing public business or for the purpose of taking any action within the authority of or the delegated authority of the Board of County Commissioners of Lea County (hereinafter "County Commission") shall be held only after reasonable notice to the public; and

WHEREAS, the Open Meetings Act, NMSA 1978, Section 10-15-1(D), requires the County Commission to determine annually what constitutes reasonable notice of its public meetings; and

WHEREAS, NMSA 1978, Section 4-38-12, allows the County Commission to establish rules and regulations to govern the transaction of county business in these meetings.

NOW, THEREFORE, BE IT RESOLVED that:

- 1. All meetings of the County Commission will be held at the Commission Meeting Room at the Lea County Courthouse, 100.N. Main, Lovington, New Mexico 88260, at 9:00 a.m. or as otherwise indicated in the meeting notice.
- 2. Notice of regular meetings will be given at least seven days in advance. The agenda will be available at least seventy-two (72) hours in advance of regular Commission Meetings from the office of the County Manager located on the fourth floor of the Lea County Courthouse, Lovington, New Mexico 88260 and posted on the Lea County website (www.leacounty.net). In addition, a meeting agenda will be sent to all broadcast stations licensed by the Federal Communications Commission and newspapers of general circulation that have provided a written request for such notice. The agenda will indicate the time, date, place and specific items to be discussed during the County Commission meeting. The County Commission shall take action only on items appearing on the agenda.
- 3. In addition to the Board's regular meetings, work sessions and special meetings may be called at the discretion of the Chairperson or upon the request of two Commissioners upon seventy-two (72) hours notice, in accordance with paragraph 5. The final agenda for work sessions and special meetings shall be available at least seventy-two (72) hours in advance of the work session or special meeting.

- 4. Emergency meetings will be called only under unforeseen circumstances that, if not addressed immediately by the County Commission, will likely result in injury or damage to persons or property or substantial financial loss to Lea County. The County Commission will avoid emergency meetings whenever possible. Emergency meetings may be called by the Chairperson or any two Commissioners upon twenty-four hours (24) notice, unless a threat of personal injury, property damage or substantial financial loss requires less notice. The notice for all emergency meetings shall include an agenda for the meeting or information on how the public may obtain a copy of the agenda. Within ten days of taking action on an emergency matter, the County Commission shall report to the Attorney General's office the action taken and the circumstances creating the emergency; provided that the requirement to report to the Attorney General is waived upon the declaration of a state or national emergency.
- 5. For the purposes of regular meetings described in paragraph two of this resolution, as well as special meetings and work sessions described in paragraph three of this resolution, notice requirements are met if notice of the date, time, place and agenda or information on how the public may obtain a copy of such an agenda is posted on the Lea County website and provided to all broadcast stations licensed by the Federal Communications Commission and newspapers of general circulation that have provided a written request for such notice.
- 6. For the purposes of emergency meetings described in paragraph four of this resolution, notice requirements shall be met if notice of the date, time, place and agenda is posted on the outermost doors of the Courthouse and in the offices of the County Manager, who shall also provide telephonic notice to those broadcast stations licensed by the Federal Communications Commission and newspapers of general circulation that have made a written request for notice of public meetings.
- 7. In addition to the information specified above, all notices shall include the following language:

If you are an individual with a disability who is in need of a reader, amplifier, qualified sign language interpreter, or any other form of auxiliary aid or service to attend or participate in the hearing or meeting, please contact the Lea County Manager's office located in the Lea County Courthouse in Lovington, New Mexico at least one week prior to the meeting or as soon as possible. Public documents, including the agenda and minutes, can be provided in various accessible formats. Please contact the Lea County Manager's Office at the Lea County Courthouse if a summary or other type of accessible format is needed.

- 8. The County Commission may close a meeting to the public only if the subject matter of such discussion or action is exempted from the open meeting requirements under the Open Meetings Act, Section 10-15-1(H) NMSA 1978 Comp.
 - A. If any meeting is closed during an open meeting, such closure shall be approved by a majority vote of a quorum of the County Commission taken during the open meeting. The authority for the closure and the subjects to be discussed shall be stated in the motion for closure and the vote on closure of each individual member shall be recorded in the minutes. Only those subjects specified in the motion may be discussed in a closed meeting.

- B. If a closed meeting is conducted when the County Commission is not in an open meeting, the closed meeting shall not be held until public notice, appropriate under the circumstances, stating the specific provision of law authorizing the closed meeting and the subjects to be discussed with reasonable specificity, is given to the members and to the general public.
- C. Following completion of any closed meeting, the minutes of the open meeting that was closed, or the minutes of the next open meeting if the closed meeting was separately scheduled, shall state whether the matters discussed in the closed meeting were limited only to those specified in the motion or notice for closure.
- D. Except as provided in Section 10-15-1(H) of the Open Meetings Act, any action taken as a result of discussions in a closed meeting shall be made by vote of the County Commission in an open public meeting.
- 9. The notice requirements set forth above in paragraphs two, three, and four shall apply to all Boards and Committees appointed by the County Commission.
- 10. The public may address the County Commission on county matters not listed on a meeting's agenda during the portion of the meeting identified as Public Input. All persons, agencies or organizations who desire to discuss public business or matters with the County Commission at a County Commission meeting, must make their request to the County Manager prior to the commencement of the County Commission meeting.
 - A. The request may be oral or written and must include the name of the person making the request and the subject on which they wish to address the County Commission. Such persons addressing the County Commission will be limited to three (3) minutes.
 - B. All persons, agencies or organizations that require additional time to discuss public business or matters with the County Commission, must make their request, in writing, at least seven (7) days prior to the County Commission meeting. Such persons addressing the County Commission will be allowed up to fifteen (15) minutes in the discretion of the Chairperson.
- 11. On matters involving agenda items, the Chairperson will ask for public comments before any vote or other action is taken by the County Commission. Such comments will be limited to three (3) minutes.
- 12. The County Commission may, by Resolution, adopt additional rules and regulations regarding the conduct of the meetings of the County Commission and any of its subordinate Boards or Committees.

Section 504 of the Rehabilitation Act of 1973 (Public Law 93-112)], which prohibits discrimination on the basis of handicap; the Age Discrimination in Employment Act of 1967 (Public Law 90-202), as amended; the Americans with Disabilities Act of 1990 (Public Law 101-336); and all amendments to each, and all requirements imposed by the regulations issued pursuant to these acts, especially 45 CFR Part 80 (relating to race, color, and national origin), 45 CFR Part 84 (relating to handicap), 45 CFR Part 86 (relating to sex), and 45 CFR Part 91 (relating to age).

ARTICLE 10 - CONFIDENTIAL INFORMATION: Any confidential information, not subject to disclosure under the Inspection of Public Records Act, given to or developed by the Contractor, its officers, directors, employees, agents, or sub-consultants in the performance of this Contract will be kept confidential and will not be made available to any individual, organization, or other entity by the Contractor without prior written approval of the County.

ARTICLE 11 - CONFLICT OF INTEREST: The Contractor warrants that it presently has no interest and shall not acquire any interest during the term of this Contract which would have the potential to conflict with the performance of the services required under this Contract. In the event such a conflict arises, it shall immediately be brought to the attention of the County and appropriate action acceptable to the County shall be taken. The Contractor's failure to inform the County of the existence of a potential conflict of interest constitutes default and shall be grounds for immediate termination of Contract by the County.

ARTICLE 12 - CONFLICTS OF LAW: If any provision of this contract conflicts with governing federal or state law or County ordinances, then that law or ordinance shall supersede the conflicting provision of this contract.

ARTICLE 13 - HIPAA COMPLIANCE: As applicable, the parties agree to comply with the provision of the Health Insurance Portability and Accountability Act of 1996, and related regulations, as amended ("HIPAA") in the event the Contractor receives patient records or information (Protected Health Information as defined by HIPAA).

ARTICLE 14 - INDEMNIFICATION AND HOLD HARMLESS AGREEMENT:

<u>Non-Governmental Entity</u> The Contractor shall hold harmless, indemnify and defend the County and its "public employees" as defined in the New Mexico Tort Claims Act, Sections 41-4-1 to 41-4-29, NMSA 1978, as amended, against and from any and all claims, losses, demands, judgments, damages, liabilities, lawsuits, expenses, attorneys fees, costs or actions of any kind resulting from or related to the Contractor's intentional acts, errors or omissions in the Contractor's performance under this contract. The Contractor's agreement to hold harmless, indemnify and defend shall not be affected or terminated by the cancellation, expiration of the term or any renewal or any other modification of the Contract for any reason and shall survive the cancellation, expiration of the term or any renewal or any other modification of this contract, acts, errors or omissions to act occurring during the term of this contract.

<u>Governmental Entity</u>: Neither party shall be responsible for liability incurred as a result of the other party's acts or omissions in connection with this Contract. Any liability incurred in connection with this Contract is subject to the immunities and limitations of the New Mexico Tort Claims Act, NMSA, 1978 § 41-4-1 et. seq. and its amendments, where applicable.

ARTICLE 15 - INDEPENDENT CONTRACTOR: Nothing in this Contract is intended or should be construed in any way to create or establish a partnership relationship between the Parties or to establish the Contractor as an agent, representative, or employee of the County for any purpose or any manner whatsoever. Contractor and its employees shall not accrue leave, retirement, insurance, or any other benefits afforded to employees of the County. Contractor is an independent contractor of the County. The Contractor, its officers, directors, employees, servants, agents, or representatives are not and shall not be deemed employees of the County and shall not bind the County in any respect.

ARTICLE 16 - INSURANCE: For the duration of the contract and until all work specified in the contract is completed, the Contractor shall maintain in effect current Certificates of all insurance as required below and comply with all limits, terms and conditions stipulated therein. The County shall be named as an additional insured as stipulated. Contractor's who are required to provide Certificate(s) of Insurance, must provide a new current Certificate(s) no less than annually. As applicable, work under this contract shall not commence until evidence of all required insurance is provided to the respective County Department for inclusion with this Contract. All insurance shall be written to conform to the requirements stipulated. Evidence of such insurance shall consist of a completed certificate of insurance, signed by the insurance agent for the Contractor and returned to the County attesting that all required insurance is in effect. If for any reason any material change occurs in the coverage during the course of the contract such change will not become effective until 30 days after the County has received written notice of such change.

Required Insurance: As specified in the RFP, BID documents or Attachment A.

ARTICLE 17 - KEY PERSONNEL: The Contractor shall identify all key personnel assigned to the performance of this Contract in Section II, Attachment H of this Contract. Key personnel may not be changed without prior written approval of the County Manager and inclusion of that written approval in the official Contract File in the County Purchasing Department.

ARTICLE 18 - MEDIATION: In the event that a dispute arises with respect to any of the provisions contained in this Contract or any other matter affecting this contractual relationship between the County and the Contractor, the Parties agree that prior to filing any court action to enforce the Contract or rights under the Contract, they will use the services of a mediator. The mediator shall either be certified as a mediator or shall have experience as a mediator. The parties shall mutually agree upon the choice of mediator. In the event the Parties have not agreed to a mediator within three days of written notice to the other regarding the dispute, then a list of seven potential mediators will be obtained from the Court or other professional association, and the Parties shall use a striking process until a mediator is agreed upon. Each party shall be responsible for their respective mediation costs.

ARTICLE 19 - MERGER OF PRIOR CONTRACTS: This Contract incorporates all the conditions, contracts, agreements, and understandings of the Parties concerning the subject matter of this Contract. All such conditions, understandings, and agreements have been merged into this written Contract. No prior condition, contract, agreement, or understanding, verbal or

otherwise, shall be valid or enforceable unless embodied in this Contract, either explicitly or by reference.

ARTICLE 20 - NON-APPROPRIATION: The County's obligation to make payment under the terms of this Contract is contingent upon its appropriation of sufficient funds to make those payments and the NM Department of Finance's (DFA) final approval of the County's budget. If the County does not appropriate sufficient funds or DFA does not approve the County's final budget, this Contract will terminate upon written notice of that effect to the Contractor. The County Board's determination that sufficient funds have not been appropriated, through Board of County Commissioners or DFA action, is firm, binding, and not subject to review.

ARTICLE 21 - NOTICE TO PROCEED OR COMMENCEMENT OF WORK: It is expressly understood that this Contract is not binding upon the County until approved and signed by the County and, further, that the Contractor shall not proceed with its obligations until the Contract has been signed by all Parties.

ARTICLE 22 - PARAGRAPH HEADINGS: Paragraph headings are for convenience and reference and are not intended to limit the scope of any provision of this Contract.

ARTICLE 23 - PERSONAL LIABILITY: No elected or appointed official, employee, servant, agent, or law enforcement officer of the County shall be held personally liable under this Contract or any extension or renewal thereof because of its enforcement or attempted enforcement, provided they are acting within the course and scope of their employment or governmental duty and responsibility.

ARTICLE 24 - PROCUREMENT CODE: The Procurement Code, § 13-1-25 through § 13-1-199, NMSA 1978 as amended, imposes civil and criminal penalties for its violation. In addition, New Mexico Criminal Statutes impose felony penalties for illegal bribes, gratuities and kickbacks. Pursuant to the above, it is unlawful for any Contractor to engage in bribery, offering gratuities with the intent to solicit business, or offering or accepting kickbacks of any kind. All other similar act(s) of bribes, gratuities, and/or kickbacks are likewise prohibited.

ARTICLE 25 - PROPRIETARY INFORMATION: All documents, writings, electronic formats, drawings, designs, specifications, notes, project manuals, or related documents and other work developed in the performance of this Contract by the Contractor shall become the sole property of the County whether the activity for which they are developed is implemented or not. The Contractor shall provide the County with a complete set of all such proprietary information as requested by the County, but no later than the effective termination date of the contract. Contractor is strictly prohibited from reproducing, duplicating or printing any such proprietary information in any format for personal or monetary recognition, use or gain without the advance written permission of the County.

ARTICLE 26 - RECORD KEEPING AND AUDITS: The Contractor shall compile, maintain, and make available for inspection all records relating to the services to be provided under this Contract. These records shall be subject to inspection by the County or designated auditor. The County shall have the right to audit billings both before and after payment; payment under this Contract shall not foreclose the right of the County to be reimbursed any excessive or illegal payment amounts made to the Contractor during the term of this Contract. Pursuant to State of New Mexico General Records Retention requirements, Contractor will retain all original, source and supporting documents and records related to this contract for a minimum of six (6) years after the ending date of this contract.

ARTICLE 27 - RELEASE: The Contractor, upon final payment of amounts due under this

Contract for work completed and accepted by the County, releases the County, its officers and employees from all liabilities, claims, and obligations whatsoever arising from or under this Contract. The Contractor agrees not to bind the County to any obligation not assumed in this Contract by the County, unless the Contractor has express written authority from the County Manager to do so, and then only within the limits of the expressed written authority.

ARTICLE 28 - SEVERABILITY: If any clause or provision of the Contract is held to be illegal, invalid, or unenforceable by a court of competent jurisdiction, then it is the intention of the parties hereto that the remainder of the Contract shall remain in full force and effect. However, in the event that either Party can no longer reasonably perform pursuant to the remaining Contract terms, or if the purpose of the Contract can no longer be carried out by either Party, the Contract may be voided and no damages shall accrue to either party.

ARTICLE 29 - SOVEREIGN IMMUNITY:

<u>Non-Governmental Entity</u>: By entering into this Contract, the County and its "public employees" as defined in the New Mexico Tort Claims Act, NMSA 1978, Sections 41-4-1 through 41-4-29, as amended, do not waive sovereign immunity, do not waive any defense, and do not waive any limitations of liability pursuant to law. No provision in this Contract modifies or waives any provision of the New Mexico Tort Claims Act, *supra*.

<u>Governmental Entity</u>: By entering into this Contract, the County and the Governmental Entity Contractor do not waive sovereign immunity, do not waive any defense and do not waive any limitations of liability pursuant to law. No provision in this Contract modifies or waives any provision of the New Mexico Tort Claims Act, supra.

ARTICLE 30 - SUBCONTRACTING: This Contract is based on the personal skills and reliability of the Contractor as known by the County at the time of execution of this Contract. The Contractor shall not subcontract out any portion of the services to be performed under this Contract without the prior written approval of the County Manager and inclusion of that written approval in the official Contract File in the County Purchasing Department. The written approval shall minimally include disclosure of the name of the individual(s) to be contracted, a statement of the individual(s) qualifications and a justification of the request to subcontract.

ARTICLE 31 - TERMINATION: The County may terminate this contract for convenience, in whole or in part, by providing written notice to the Contractor thirty (30) days prior to termination. In the event of contract termination, the Contractor shall be paid for work completed to the date of termination. In no event shall the dollar amount to be paid upon termination exceed a total of the maximum contracted amount and any additional amount provided for by amendment(s).

- a. Where a Party to this Contract has committed a major breach that is capable of remedy, the Party who is not in breach may serve a written notice, with a fixed period in which to remedy the breach. The period given shall be determined at the sole discretion of the Party serving the notice but subject to a minimum period of two weeks.
- b. The County and Contractor shall have the right, such right being exercised at their absolute discretion, to terminate this Contract, in writing, if a major breach has been committed that can not be remedied. Further, the Parties may terminate this contract, in writing, if a breach has not been remedied to the reasonable satisfaction of the Party serving the notice of breach within the period specified in any such notice.

ARTICLE 32 - THIRD PARTY BENEFICIARY: It is agreed between the Parties executing this Contract that it is not intended by any of the provisions of this Contract to create on behalf of the public or any member thereof the status of third party beneficiary nor to authorize anyone not

a party to the agreement to maintain a suit based upon this Contract.

ARTICLE 33 - WAIVER: Any waiver by the County of any breach of any covenant, term, condition, or agreement in this Contract to be kept and performed by Contractor shall not be deemed or considered as a continuing waiver and shall not operate to bar or prevent County from declaring a default for any succeeding breach either of the same covenant, term, condition, or agreement or another. All remedies afforded in this Contract shall be taken and construed as cumulative, that is, in addition to every other remedy provided herein or by law.

ARTICLE 34 - DUPLICATE ORIGINALS: This document shall be executed in no less than two (2) counterparts, each of which shall be deemed an original.





The 2016 Four States Fair saw a slight increase in attendance; hosting about 85,000 guests over the ten days. Admission was \$7 for adults, \$5 for children 6-12, and kids 5 and under were free. This year, the fair also offered an admission "Fun Pass" for \$65; those who purchased the pass were able to come to the fair every day. In addition to regular admission prices, the Four States Fair offered admission specials on Senior Citizens Day and Salute To Our Heroes Day. Senior Citizens Day was on Sunday; seniors got in for free and the fair provided shuttles to the front gate.

Additionally, the fair partnered with a local hospice facility to provide senior citizens with free blood pressure tests, free food, and free blood screening. Senior Cilizens Day was very well attended according to Lisa Barr, COO of the Four States Fair. Salute To



Our Heroes Day took place on September 11th; all first responders were admitted into the fair for free in order to thank them for their service to the community.

The Four States Fair partnered with Wrights Amusements this year. Barr found Wrights Amusements at the Texas Fair and Expo Show. According to Barr; the decision to make Wrights their midway provider was an easy one; "I fell in love with them on the spot. Wrights Amusements are good people and a good carnival company. We look forward to continuing our

relationship with them." Wrights Amusements offered customers \$30 armbands each day of the fair; the pay one price ride option every day was very popular with fairgoers. In partnership with the Four States Fair, Wrights Amusements offered a \$2 Tuesday ride special for the 2016 fair.

The Four States Fair provided fairgoers tons of family-oriented entertainment. On their outdoor stage, they hosted local entertainment: radio stations and popular bands.

Football is huge in Texarkana so the fair hosted post-football game dence-offs at the fair to encourage high school aged students and people from the community to integrate the fair into their normal football routine. All the local entertainment is included with the price of admission. Wednesday through Saturday, the fair held PRCA extreme bull riding and rodeo; "The show was very well received and had big crowds," said Barr. Additionally, on the first Saturday of the fair, they had a demolition derby which also had a great crowd.

Barr felt that these thrilling acts attracted audiences of all ages. The fair also had Bob Burnham's Family Entertainment Show, which hosts mock game shows for families to enjoy, as well as The Banana Derby, a dog racing show with monkey jockeys!

The Four States Fair also uses their Agricultural Learning Center as a family attraction throughout the fair. The Ag learning center is usually used as a field trip area throughout the year but is a main attraction during the fair. The staff in the Ag Learning Center gave away free ice cream, answered questions about the educational displays, let children milk a fake cow, and monitored the petting zoo complete with facts and general information about the different animals.

Food plays an important role at the Four States Fair and is often people's sole motivation to come out each year. According to Barr, "A lot of people come out just for the fair food."

One of the most popular items is the peanut patty, they're generally only sold at the fair so people wait all year to get them. The fair also boasts an impressive amount of fried foods including the cajun corn dog (new this year), and fried cookies and candles. One of the fair's year-round vendors tried a new item at Barr's urging: the funnel cake hamburger. Barr loves working with the vendors and pushing them to try new and creative menu items each year; "I am very fortunate. I have a great group of vendors who put up with my ideas."

4-H and FFA have a big presence at the Four States Fair. They host the largest livestock show in Arkansas for junior breeding beast cattle; this year's show included over 600 head of cattle. In addition to livestock shows, 4-H and FFA members participate in goat shows, dairy shows, and swine shows throughout the fair. Every year, they hold a couple of volunteer kid's days at the fair for kids in pre-k all the way up to 3rd grade. On the volunteer kids days, the participants get to enjoy the agricultural learning center, and see a min-rodeo created just for them.

The Four States Fair has lots of domestic exhibits so that members of the community can participate in the fair. They have one building strictly for fine arts and photography displays. The Home Arts section of the domestic exhibits includes canning, baking, sewing, clothing, woodworking and needle-working as well as many other displays. All judging is done prior to the fair and then entries are displayed for fairgoers to enjoy. Anyone can enter their home or fine arts goods into the competition so it is a great way for many members of the community to get involved with the fair.

Advertising the Four States Fair is a unique challenge as the fair staff aims to get their message out to residents of four different states: Arkansas, Texas, Louisiana, and Oklahoma. They do a \$40,000 cash buy for media advertising as well as some additional trade.

The Four States Fair advertises on television, radio, print, and social media. Barr mentioned that they have pulled back a bit on their print budget but still make sure they advertise in all the local social magazines. This year, the fair staff decided to increase their social media budget from \$100 to \$1,000. Barr says that this has made a huge difference for the fair and they've noticed a lot more participation on their social media sites. Barr does Facebook posts and contests where customers like and share statuses and post their favorite fair photo in order to win a fair fun package. The Four States Fair makes sure that their message is consistent in all markeling efforts; "We want our customers to feel like a kid; leave all stress and worries behind when they're at the fair," says Barr.

The Four States Fair is a 501-C(3) nonprofit organization. The fair receives some grants for advertising. The fair operates the rest of the year on year-round events, they try to make sure their facilities are constantly booked in order to fund fair activities. Barr says that they operate on a \$1M budget.





- 1. Failure to comply with all of the Instructions and Conditions may subject the proposal to rejection. The Terms and Conditions, and the Specifications and Contractual Terms will form part of the contract between the County and the successful offeror.
- All proposal copies will be enclosed together and sealed in one envelope/package, addressed and delivered to: The Finance Department, 100 N. Main, Suite 11, Lovington, New Mexico 88260-4030 by 3:00 p.m. local time NOVEMBER 1, 2017. It is the offeror's responsibility to see that the proposal arrives on time. Late proposals will be returned unopened. Faxes or telephone proposals will not be accepted.
- 3. All firms submitting proposals will be notified by letter of the Board's award which will be conditioned upon entering into a formal written contract acceptable to the County. Any form of contract which an offeror would expect the County to execute if it were awarded the project must be attached. It may not conflict with any provision contained in the Request for Proposals package.
- 4. The proposal specifications indicate the minimum standard of quality, performance or other pertinent characteristics required. All variations and exceptions from minimum specifications must be listed on or attached to the proposal.
- 5. Contents of any proposal will not be disclosed upon opening so as to be available to competing offerors during the negotiation process.
- 6. Proposals will be evaluated according to factors set forth on the attached sheet. Each factor will be given the weight indicated.
- 7. The County reserves the right to waive technical irregularities in the form of the proposal which do not alter the quality or quantity of the services, and the County may reject any or all proposals when it is the best interest of the County to do so.

The offeror agrees to comply with state laws and rules applicable to workers' compensation benefits for its employees. If the offeror fails to comply with the Workers' Compensation Act and applicable rules when required to do so, this agreement may be terminated by the contracting agency.

13. The City of Eunice is requesting the following from Lea County in order to make the convenience/recycling center a reality in our community.


- Transfer of ownership of the parcel of land located near the intersection of Fourth Street and Avenue G to the City of Eunice.







STATE OF NEW MEXICO COUNTY OF LEA ORDINANCE NO. 89

AN ORDINANCE REPEALING ORDINANCE NUMBER 49 AND ESTABLISHING A MERIT SYSTEM FOR HIRING, PROMOTION, DISCHARGE, AND GENERAL REGULATION OF COUNTY EMPLOYEES, VOLUNTEERS, AND COUNTY AGENTS

WHEREAS, the Board of County Commissioners of Lea County, pursuant to Sections 3-13-4 and 4-37-1 NMSA 1978, has the authority to establish a merit system for all employees of Lea County; and

WHEREAS, the Board of County Commissioners of Lea County previously adopted Ordinance Number 49, establishing Lea County personnel policies, on February 8, 2002; and

WHEREAS, the Board of County Commissioners of Lea County has determined that the personnel policies need to be updated.

NOW THEREFORE, the Board of County Commissioners does hereby repeal Ordinance Number 49 and adopt the following Ordinance.

1. Short Title. This Ordinance shall be cited as the "Lea County Personnel Ordinance."

2. **Purpose.** The purpose of this Ordinance is to establish a merit system for hiring, promotion, discharge and general regulation of County employees, volunteers, and other County agents.

3. **Binding Effect.** It is the express intent of the Board of County Commissioners that the provisions outlined herein and in the Human Resource Policies to be adopted pursuant to the authority granted herein will be binding on the operations of the Human Resources Department and other County departments relating to hiring, promotion, discharge, and general human resources management.

4. Equal opportunity employer; discrimination and harassment prohibited.

A. The County is an equal opportunity employer. Discrimination by any employee is expressly prohibited. If such discriminatory acts occur, the person committing those acts is subject to appropriate discipline, including dismissal, from County employment.

B. It is declared unlawful:

(1) For any employee to give preference to, or to discriminate against, any person, because of political affiliation, race, religion, age, national origin, color, sex, disability, or any other legally protected status, unless based upon a bona fide occupational qualification.

(2) For any employee or applicant to be appointed, promoted, removed, or in any way favored or discriminated against because of race, sex, color, national origin, disability, age, political or religious affiliations, or any other legally protected status.

(3) For any employee to harass any employee, especially when such conduct has the effect of interfering with an individual's work performance or has the effect of creating a hostile or offensive work environment. No employee shall make such conduct a condition of employment or use refusal to participate in such conduct a basis for employment decisions.

5. Administration of human resources system.

A. The County Manager, with the assistance of the Human Resources Director, will administer the Lea County Personnel System set forth in this Ordinance, consistent with the Human Resources Policies and Procedures to be adopted in accordance herewith, and in accordance with all future approved directives and administrative instructions.

B. The County Manager, with the assistance of the Human Resources Director, will ensure that employment decisions, including but not limited to, recruitment, selection, promotion, reassignment, corrective action, compensation and other conditions or privileges of employment, are based on the individual's ability to perform the essential functions of the job.

C. The County Manager, with the assistance of the Human Resources Director, will continue to establish programs to develop, implement, and maintain procedures for the conditions of employment, evaluation of work performance, employee conduct, leave usage, and other aspects of human resources management for County employees, in compliance with applicable laws and policies.

D. The County Manager, with the assistance of the Human Resources Director, will continue to establish programs to develop, implement, and maintain the County's compensation plan, including a salary schedule reflecting the pay ranges for each job classification and other pay policies.

6. Classification of employees

A. All paid positions in the County service are divided into classified and unclassified categories, except those held by elected officials, volunteers, including members of boards, commissions, committees, etc., appointed by County Commissioners or County staff, which are not included in either category.

B. Classified positions.

(1) A classified position is a regular, approved positon. Employees in classified positions are covered by the Human Resources Policies and Procedures and can be separated from the County only through the processes outlined in the Human Resources Policies and Procedures after the employee has completed their initial probationary period.

(2) The classified service is comprised of all County employees, except those who are specifically placed in the unclassified category by the terms of this Ordinance.

C. Unclassified positions.

- (1) Unclassified positions are comprised of the following:
 - (a) The County Manager.
 - (b) Chief deputies of elected officials.
 - (c) The Undersheriff and Executive Secretary to the Sheriff.
 - (d) The Chief Appraiser and Bureau of Elections Administrator.
 - (e) Department directors hired by the County Manager.
 - (f) Probationary and temporary employees.

(2) Employees in unclassified positions are in an "at-will" status and serve at the pleasure of the County. These employees are not covered by the employment, discipline, and grievance provisions of the Human Resources Policies. Such employees are, however, governed by the other provisions of the Human Resources Policies.

7. Human Resources Policies

A. The County Manager, with the approval of the Board of County Commissioners by resolution, shall establish, maintain, and publish Human Resources Policies and Procedures to facilitate the implementation and maintenance of, and compliance with, the policies expressed within this Ordinance. These Human Resources Policies and Procedures will be reviewed periodically and may be modified by resolution of the Board of County Commissioners. Neither this Ordinance nor the policies resulting from this Ordinance shall constitute a contract of employment.

B. The Human Resources Policies and Procedures will include, but are not limited to, classification of all County positions based on duties, authority and responsibilities; reclassification assignment, transfer, and layoff; disciplinary procedures; hours of work and attendance; and benefits.

8. County Manager authority.

A. The County Manager is the Chief Executive Officer of County government and is authorized to run County operations pursuant to policy established by the Board of County Commissioners.

B. The County Manager is charged with:

(1) The exclusive authority, except for those persons identified in paragraphs 6. C. (1) (b), (c), (d) and as indicated in paragraph 8. B. (2), to employ and discharge all County employees pursuant to this Ordinance and the Human Resources Policies and Procedures adopted by the Board of County Commissioners pursuant to this Ordinance.

(2) The hiring of and contracting with the Directors and County Attorney to run the County's departments subject to approval by the Board of County Commissioners.

(3) Recommending the organizational structure and salary plan for the work force.

(4) Appointing a designee or designees to act on the County Manager's behalf in carrying out these responsibilities.

(5) Formulating and implementing personnel rules to carry out the intent of this Ordinance, as long as such rules do not conflict with this Ordinance or the Human Resources Policies and Procedures adopted pursuant to this Ordinance.

(6) Exercising discretion to transfer or reassign any employee within the organization to permit the best use of skills, experience, and education for the benefit of the organization.

9. Violations.

Any employee who violates or attempts to violate this Ordinance or the Human Resources Policies and Procedures shall be subject to disciplinary action, up to and including dismissal.

10. Conflict of interest.

No employee shall engage in any business or transaction or accept private employment or other public employment that is functionally or physically incompatible with the proper discharge of the employee's County job responsibilities. All employees, volunteers, and other County agents shall comply with applicable state law governing conflicts and disclosures.

11. **Preservation of confidentiality.**

Lea County employees, elected officials, volunteers, and other County agents may have access to confidential information in the course of their duties. This information may include personnel matters, internal investigations, restricted computerized data, attorney work papers or other legally privileged information, and/or contract or financial information. Unauthorized disclosure of confidential information could be very detrimental to the individuals involved and/or Lea County. Unless required by County work, at no time should an employee, elected official, volunteer, or other County agent disclose confidential information or remove it from the County's premises. The negligent or intentional disclosure of confidential information is grounds for discipline, up to and including dismissal.

12. Headings.

The paragraph headings of this Ordinance are inserted only for reference and in no way define, limit, or describe the scope or intent of the section.
