

Public Comments

- Danny Fletcher, Holtec International: Gave an update concerning the progress of Eddy/Lea Energy alliance. Twin bills both in House and Senate. Lobbying team defeated both Bills. Tabled at Senate Judiciary Committee. Received a lot of support from Lea and Eddy County. Senators Martin Henrich and Ted Cruz proposed Federal Bills banning Federal Funding to store spent fuel. Less than 15% of Holtec is federal funding. We should hear by early summer about the Nuclear Regulatory licensing approval. Will update as available. Thank you for support.
 - Sena Expressed his appreciation to Legislators. He reiterated his support of diversifying our economy, citing the uncertainty of decisions our Governor and President may make concerning the oil and gas industry.
 - State Representative Larry Scott, District 62 (First Comment): Presented House Memorial #39 which was cosponsored by 25 members of the House of Representatives and passed unanimously during the most recent Legislative

- Session. This Proclamation Recognizes February 4, 2022 as Law Enforcement Appreciation Day. Representative Scott read the Memorial Proclamation and presented it to LCSO Chief Deputy Chan Kim.
- State Representative Larry Scott, District 62 (Second Comment): Mentioned that a Successful challenge to the redistricting efforts is a long shot. He commended the Redistricting Committee for doing a great job at the Legislative Session. Representative Scott explained what he felt the effects of the Congressional Redistricting were, including diluting the southern voice of the voters with more conservative values and supporters of the petroleum industry. He stated that he believes the best chance at change is not in the Courthouse but in the Ballot Box.
