

Consideration of Lea County Resolution No. 22-SEP-204R Authorizing an Agreement for Land Exchange

between Lea County and Hobbs Country Club

In January of 2020, Lea County requested that the Hobbs Country Club (HCC) and Lea County Regional Airport enter into a land exchange agreement for properties near the west property lines of the HCC.


Lea County has the need to acquire approximately 0.98 acres of property shown in red and move the 8' tall game fence to the new property line. In exchange, Lea County will transfer ownership of the approximately 1.94 acres of land currently being utilized by the HCC.

Lea County Regional Airport has a number of on-going projects that will bring it into compliance with this mandate including a relocation of an ILS localizer antennae, removing the high game fence and perimeter inspection roads from the Runway Safety Area and Runway Obstacle free zone of Runway 21.

Lea County has hired environmental, surveying, and appraisal consultants to complete all the necessary studies and documents for compliance with the FAA.

In February 2022, Lea County received a determination letter from the FAA authorizing the land swap of 1.94 acres of Lea County property for 1.94 acres of Hobbs County Club property.

By authorizing this land swap, it will enable Lea County to complete the RW 21 RSA project as well as improvements associated with the RW 3 extension.

WHEREAS, Lea County has the need for an additional 1.96 acres on the northeast corner of the airport to meet Federal Aviation Administration (FAA) compliance on multiple issues; and

WHEREAS, Lea County borders the Hobbs Country Club and wishes to trade equal land areas to acquire the necessary land; and

WHEREAS, Lea County has performed all necessary land valuation, environmental and surveying tasks to meet FAA approval.

**NOW**, **THEREFORE**, **BE IT HEREBY RESOLVED** by the Board of County Commissioners of Lea County that a land exchange between Lea County and Hobbs County Club is hereby approved.

**BE IT FURTHER RESOLVED** that the Commission Chair and/or County Manager may finalize and sign any agreements consistent with the terms of this resolution.



This letter is in reference to your correspondence dated September 3, 2020 regarding the exchange of land with an adjacent property owner as described in the Lea County Regional Airport (HOB) Summary Subdivision plat attached to this document. The Airport property depicted in magenta will exchange with a Hobbs Country Club (HCC) property depicted in light blue. We have received all records in regards of the land exchange in between a HOB property and the HCC property such as property deeds, an airport property map, a land exchange request letter to the FAA, and an exhibit 1A with a proposed action of the land exchange. The 1.94 acres of land that will be traded to the adjacent property owner is currently unused by Lea County, is on the east side of a drainage ditch and outside of the Lea County Regional Airport fencing. It is not near any current or proposed runway, taxiway or navigational aid.

Based on the aforementioned documentation, this letter of determination from the Louisiana/New Mexico Airports Districts office concurs and acknowledges your land exchange, therefore releasing the Lea County of their federal financial obligations to proceed with the land swap for the benefit of the public. Additionally, Grant Assurance 29 still requires the airport to update and maintain a current ALP. Please send an updated ALP and Exhibit A property map that depicts the exchange of the property if the project is completed.

As part of the release of obligations related to the airport land being swapped, the following restrictions should be added to the land deed Instrument of Transfer:

- 1) That the City of Hobbs reserves unto itself, its successors and assigns, for the use and benefit of the public a right of flight for the passage of aircraft in the airspace above the surface of the real property herein described, together with the right to cause in said airspace such noise as may be inherent in the operation of aircraft, now known or hereafter used, for navigation of or flight in the said airspace, and for use of said airspace for landing on, taking off from or operating on the Lea County Regional Airport.
- 2) That the Grantee (HCC) expressly agrees for itself, its successors and assigns to restrict the height of structures, objects of natural growth and other obstructions on the herein described real property,
- 3) That the Grantee (HCC) expressly agrees for itself, its successors and assigns to prevent any use of the hereinafter described real property which would interfere with landing or taking off of aircraft at the Lea County Regional Airport, or otherwise constitute an airport hazard,
