PROGRAM RULES

You are currently under the supervision of the Lea County Misdemeanor Compliance Program and are ordered to follow the requirements listed below. You will be under supervision until you are officially discharged.

You will receive ONE REMINDER by your preferred method of contact in reference to your orientation appointment. If you fail to attend your scheduled orientation without proper notice, a Probation Violation will be forwarded to your sentencing court.

____ 1. I will not illegally possess or use a controlled substance. I will not frequent places where controlled substances are illegally sold, used, distributed or administered. Cannabis use and/or possession without a valid Medical Cannabis Program Patient Identification Card is prohibited.

____ 2. I will refrain from the use of alcohol and will not possess, use or consume alcoholic beverages. I will not enter an establishment in which alcohol is sold and/or served.

____ 3. I will submit to scheduled and/or random drug/alcohol testing while under supervised probation as directed by the Court Compliance Officer. Evidence of alcohol or drug usage, any conduct to deceive, attempt to tamper with, adulterate, substitute and/or dilute or the possession or wearing of a prosthetic device for the purpose of adulterating or substituting urine specimen will be grounds for referral back to court. Testing will be at my expense.

____ 4. You shall immediately report to your Court Compliance Officer any change in address, telephone number, employment status, marital status, living arrangements and income.

____ 5. If you are planning on leaving Lea County for a period 24 hours or more **OR** less than 24 hours but including an overnight stay, you must submit a travel permit request to your Compliance Officer within the time period designated on the Travel Permit Request Form. If travel is approved by your Compliance Officer, you will be given a travel permit prior to your leave date.

____ 6. NO PERSONAL ITEMS ALLOWED past Security. Personal items will include backpacks, bags, purses, cell phones, keys, iPads/tablets, watches of any type. You may utilize provided lockers for items at your own risk. Lea County is NOT responsible for items left and/or unsecured in lockers.

____ 7. You are not allowed to carry any type of weapon and/or firearm on the Lea County premises.

____ 8. Clothing which portrays profanity, nude images, illegal activity, or drug/alcohol images are not allowed at any check-in, class, community service, or counseling session.
