Effect of Signature: By signing this application and submitting it, the contestant represents and agrees that (1) all facts and representations contained in this application and contract and its attachments are true and accurate; (2) the contestant agrees to abide by all rules and regulations of the Lea County Fair Board described in this application and its attachments in the period before and during the year of service; (3) the contestant meets each requirement for eligibility set forth in the regulations; (4) any unsatisfactory behavior will be cause for dismissal of contestant and relinquishment of title and any awards.

Conduct of the Competition: I understand and agree that the Lea County Fair Board shall determine the manner and method of conducting the competition is its sole discretion. I further understand and agree that the Lea County Fair Board shall also determine the time, method, and manner of judging the competition in its sole discretion.
