Enclosed are two different Vendor Agreements. One for food and beverage vendors, and one for all non-food and beverage vendors. Please complete the applicable Agreement in its entirety including providing your measurements and whether you will be utilizing a tent or trailer. Also enclosed is our pricing for the 2022 Lincoln County Fair.

We will send out assigned locations and a corresponding map prior to the event. We will also mark your location clearly with your business name. **Your assigned area is where you will remain for the duration of the fair.**

Parking permits will be provided for each Vendor (number is location dependent). Parking will be limited to your assigned area. Unfortunately, we are unable to accommodate hookups for camp trailers, RVs, or other recreational vehicles at this time. There are dry camping spaces available. Please indicate your interest in a dry camping location on your application.
