

**MANATEE COUNTY FAIR**  
**RELEASE, GENERAL LIABILITY WAIVER,**  
**AND HOLD HARMLESS AGREEMENT**

I represent that I am a custodial parent authorized to execute this instrument for myself and on behalf of my child or children named below. I represent and warrant that I am signing this document for myself and my child or children as to any property or facilities owned, leased, operated, or occupied by Manatee River Fair Association, Inc. d/b/a Manatee County Fair (herein, the "Association"), including, but not limited to, the Manatee County Fairgrounds, which incorporates, without limitation, all property owned, leased, operated, or occupied by the Association, including without limitation the Mosaic Arena, Veterans' Hall, and all other buildings and improvements situated therein (all collectively the "Fairgrounds").

I am fully aware of the risks and dangers attendant to my child or children entering on the Fairgrounds. I understand the risk to myself and my child or children, and that the Association is not responsible in any manner for my or my children's usage or any personal injury or property damage to me or my children as a result of the entry upon or presence in the Fairgrounds. I further understand that I am solely responsible for any personal injury or property damage caused by me or my children as a result of the usage of the Fairgrounds. I acknowledge that, in the middle of a global pandemic, there is a serious risk that, by entering the Fairgrounds I or my child or children could contract a dangerous virus or other health condition, and that I accept this risk and nonetheless voluntarily choose to allow my child or children to enter the Fairgrounds.

The undersigned grant full permission to the Association to use my picture or likeness, or my child's or children's picture or likeness on any media, including, without limitation, the Manatee County Fair website, social media, forms, brochure, and any other record of participation in activities in connection with the Manatee County Fair for any publicity and/or promotional purpose(s) without obligation to the Association or its successors, assigns, et al., or liability by the publisher or promoter. The images may be used in print publications, online publications, presentations, websites, and social media. No royalty, fee or other compensation shall become payable by reason of such use.

In consideration of my child or children being allowed to enter and remain on the Fairgrounds for the purposes of exhibiting livestock, exhibiting arts and crafts, exhibiting photography, or any other authorized activity incidental to the events taking place during the Manatee County Fair and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, on behalf of myself, my child or children, and all others who may claim by, under, or through myself, I do hereby agree to irrevocably indemnify and hold harmless and do hereby release, acquit, and forever discharge the Association and all of its members, officers, directors, employees, volunteers, attorneys, agents and assigns, and all other persons or companies from any and all claims, actions, or causes of action which I or my child or children now have, or which may hereafter accrue, whether for personal injury or property damage, whether known or unknown, arising out of or in any way resulting from our usage of any Association property or facility or participating in Association activities.

**NOTICE TO THE MINOR CHILD'S

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF THE MANATEE RIVER FAIR ASSOCIATION, INC. D/B/A MANATEE COUNTY FAIR USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM THE MANATEE RIVER FAIR ASSOCIATION, INC. D/B/A MANATEE COUNTY FAIR IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND THE MANATEE RIVER FAIR ASSOCIATION, INC. D/B/A MANATEE COUNTY FAIR HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.
