BIOSECURITY MEASURES FOR POULTRY EXHIBITORS

CRITICAL ADVICE FOR POULTRY EXHIBITORS

- Only take healthy animals to shows or fairs.
- Quarantine new or returning birds from home flock for 30 days and monitor for signs of illness.
- Perform home flock chores first. Use separate equipment, footwear, and clothing for quarantined birds.
- Provide disinfectant footbaths and disposable boot covers for anyone having contact with your flock.
- Wash hands before and after coming into contact with poultry.
- Isolate sick birds and contact a veterinarian about them.
- Clean and disinfect equipment regularly.
- Vaccinate for relevant diseases.
- Minimize stress for birds at home or away.
- Provide excellent nutrition and clean water at all times.
- Emphasize sanitation and keep premises clean.
- Monitor all flocks for increased mortality or clinical signs consistent with Highly Pathogenic Avian Influenza (HPAI) and report any concerns immediately.

Additional Biosecurity Recommendations

• Checklist after a Fair

- Take fair clothing and footwear home in a plastic bag; launder and disinfect promptly.
- Keep show birds separate from their home flock for 30 days after returning from a fair.
- O Do home flock chores first or designate one person to do the chores for returning birds and another person for the home flock.
- Use separate footwear, clothing, and equipment for the home flock and returning birds. Wash hands between both groups.
- o Do not allow exhibitors to handle another exhibitor's birds without permission and without washing hands or changing gloves before and after.
- o Do not allow exhibitors to share equipment.
- Watch returning birds closely for signs of illness; call a veterinarian to discuss any concerns that arise.

• General Biosecurity

- o Thoroughly clean and disinfect equipment often.
- o Do not visit other poultry farms.
- o Do not wear farm clothing or footwear off the farm.

Cleaning and Disinfection

- o Thorough cleaning and disinfecting are important aspects of biosecurity. A veterinarian or Florida Department of Agriculture and Consumer Services representative can recommend the most appropriate disinfectant to use. Follow these steps for effective disinfection:
 - Thoroughly clean and disinfect cages, feed and water bowls, and any other equipment used during the fair.
 - Cleaning means removing all visible debris (manure, bedding, dirt, feathers, feed, etc.).
 - Thoroughly clean all surfaces with soap and water.
 - Rinse well and let dry.
 - Apply an appropriate disinfectant at the proper concentration for the recommended contact time.
 - Rinse and let dry before using equipment or restocking premises with birds.
 - Store equipment where it cannot become contaminated with bird or rodent feces
