Payment and application must be turned into Horseshoe Pavilion Business Office by 5pm on Wed. March 30<sup>th</sup> to register. Office, open from 8am - 5pm M-F, closed 12-1pm daily.

There are 30 maximum riders per night. **The first 12 riders per night (and paid) are guaranteed a spot during intermission Friday or Saturday night!** The additional 13-30 will compete before the rodeo, beginning at 6:30pm. All riders must be checked in by 6pm each night. If you do not check in, by 6pm, your spot may be given to another paid rider.

**Books Open, to walk-up entries** at 6:00pm, Fri. April 1 and Sat. April 2, open to riders who have not signed up during the pre-entry time frame. Helmets and Gear will be provided by Cadillac Rodeo Company. Back numbers will be provided by the PBSSPR.

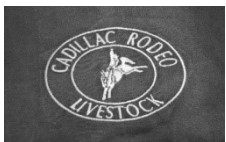
