Kids Q Competition

Rules and Regulations

1. You must be between the ages of 6-17 years of age to participate. There is only one category. Junior Division: Ages 6-11, Senior Division: Ages 12-17.
2. The entry fee is \$25.00 and can be paid online but must be paid by or at the Chief Cook's Meeting on Monday, July 20, 2026.
3. The Kids Q Competition will be held at the Cook-off Pavilion. The committee will provide 1 grill and heat source, such as charcoal or wood for each entrant. You will only be allowed to use the grill and heat source which is provided to you by the committee.
4. A parent or guardian must be present during the entire Kids Q Competition.
5. Protein will be provided by Cook-off Committee at the Kids Q Competition Cooks meeting on Friday, July 24, 2026. You will also receive your turn-in container at that time. You must use the meat provided. No exceptions.
6. Judging will be based on Appearance, tenderness, texture and taste. Scoring will be determined by CBA. All decisions are final.
7. All cooking and prep must be performed at the Cook-off pavilion by the Kid Cook. The parent/guardian may only assist in lighting the fire and slicing the protein. The parent/guardian should not help season, cook, present or box protein.
8. Each Kids Q Cook may bring one box of supplies of items they will need. For example- cutting boards, knife, seasonings, gloves, hot pads and cleaning supplies.
9. No electronic devices (i.e. cell phones, laptops, etc.) will be allowed in the cooking area. Parents may take photos only with their phones.
10. The Cookoff Chairman reserves the right to make additional rules as the situation warrants. The decisions of the Cookoff committee and judges are final.
